**Approval of the Previous Meeting Summary** – The March 2023 meeting summary was approved by the GAB CPAC members.

**Presentation(s): Detective April Cobb, JSO and Detective Harold Chapman, JSO** informed the CPAC about identity theft and various types of scams.

The detectives reviewed the most common scams occurring locally. The scams include skimmers at gas pumps or ATM machines, online romance scams, fake calls regarding family emergencies (usual fake grandchildren), fake calls from local utilities and phishing through emails. All of these types of scams should be reported to the police.

Detective Cobb provided a brief overview of how and who to report fraud to and how to start repairing the damage created from an identity theft and/or scam. Materials from the Federal Trade Commission were provided to serve as a guideline to recover from identity theft and scams. This information can also be obtained online at www.ldentityTheft.gov. This information covers personal account recovery, child identity theft, tax identity theft, and medical identity theft.

## Municipal Code Compliance Division (MCCD) – Robert Bautochka shared the following updates:

- In the past 30 days, 1617 inspections were completed, and 344 snipe signs were removed.
- The next systematic inspection will be conducted in the Atlantic Beach Estates community.
- The Jacksonville Assistance and Relief or JAR program was discussed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be unable to achieve it due to disability or economic disadvantages. The program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

**Chairs Report** – Chair Keeley opened the discussion regarding the GAB CPAC Capital Improvement Project (CIP) recommendations and reviewed the criteria for Capital Improvement Project (CIP) recommendations. After some discussion, the CPAC decided to re-submit three of the unfunded CIP recommendations from prior years. The recommendations include:

- 1. Build an "over the road walkway" over San Pablo Road in between Alimacani Elementary School (2051 San Pablo Road) and River City Science Academy (2002 San Pablo Road S.)
- 2. Ed Austin Regional Park: as a safety measure, conduct an engineering study to determine the number of additional lights needed to properly illuminate the parking lot(s) adjacent to the PAL Building and the Jim Fortuna Senior Citizen Center both located within Ed Austin Regional Park.
- 3. Build a multi-use path/trail system using JEA right-away land. The start of the trail would begin at the St. Johns River (RE#160266-0120 to RE#161135-0000) and continuing east across McCormick Road.
