

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5918-24C</u> was filed on <u>May 8, 2024</u>, as <u>Ordinance 2024-351</u>.

The subject site is approximately <u>10.91 acres</u> and is located with an address of <u>0, 3019, and 3025 Leon Road,</u> between Beach Boulevard and Leahy Road.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Business</u> Park (BP). Plan category descriptions can be found on the Planning and Development Department website.
