Monday March 4, 2019 Meeting, Disabled Services Conference

The Chair called the meeting to order at 10:20 a.m.

Natalie Alden asked that conferences, including Connecting the Dots and the Tools Conference submit applications for funding as the division works to build its new budget.

Kevin McDaniel stated that he was working on a kite fishing event for the community.

The committee reviewed Brooks Rehabilitation request for adaptive fishing. Request was approved, committee asked for clarification on date.

The committee reviewed Brooks Rehabilitation request for adaptive kayaking. Request was approved, committee asked that the division keep track of number of kayak clinics hosted per year.

The committee reviewed Brooks Rehabilitation request for adaptive horseback riding. Request was approved.

The committee reviewed Brooks Rehabilitation request for adaptive skydiving. Request was partially approved for 24 participants. The committee requests that final report include feedback from the community as well as break down of costs per person.

The committee reviewed Brooks Rehabilitation request for Gate River Run and Challenge Mile. Request was partially approved for \$1,250.

The committee reviewed a support letter for a grant application for adaptive kayaking to be submitted to the council on 3/5/2019.

The committee discussed disability parking downtown. Kevin McDaniel stated that he intended present a request to the full council to establish a work group to discuss.
