Meeting Convened: 2:00 PM

Dr. Moreland opened the meeting and introduced the Committee Members. He advised that James Croft, prior Committee Vice Chair, is no longer employed at COJ, and welcomed Sarah Schmidt, as a new Committee member. Recognized Dr. Georgette Dumont as UNF representative for today's meeting.

Election of Vice Committee Chair:

Motion made by Dr. Moreland to elect Kristen Reed as new Vice Chair. Joshua Gideon 2nd the motion and was approved by the Committee.

Meeting Minutes for the July 13, 2021, Committee Meeting:

Approved by the Committee July 15, 2021.

Review of Ordinance/Executive Order:

Dr. Moreland reviewed extensively with the Committee.

Dr. Georgette Dumont, UNF (incoming Director), MPA Program:

Dr. Dumont discussed the MPA program at UNF, and potential options for notifying UNF students of the Lex Hester Scholarship. There are approximately 100-150 students currently enrolled in the MPA Program. She will provide detailed recommendations.

Joshua Gideon:

Discussion regarding Executive Order 2018-03 potentially broadening the current parameters to include surrounding (5) counties.

Dr. Moreland:

Recommended a push through UNF for more applicants prior to considering any changes to Executive Order 2018-03.

Tracey Hester Flynn:

Discussed potentially adding alternate family member in the event she is unable to attend a committee meeting and who would be a voting member in her absence.

Advertising process:

Dr. Moreland reviewed the advertising process and the timing required of same.

Advertising for the Fall 2022 Term will commence in March 2022.

Advertising options were discussed. Dr. Dumont will provide her recommendations for advertising options with UNF. Dr. Moreland discussed the high cost of advertising in the UNF Spinnaker publication.

Kristen Reed suggested that the MPA Professor's could advise the students of this scholarship program. Dr. Dumont agreed that they could push out the information that way and that she will send a plan of approach to the Committee.

Sarah Schmidt:

Asked Dr. Moreland if there was any type of recognition ceremony, i.e., Certificate and photo opportunity with the Committee Chair, representing the Mayor's Office.

Dr. Moreland:

This is included in the Executive Order, under Section III; Annual Timeline, and has not been considered as a result of COVID-19 and has hampered our ability to have a recognition ceremony.

Application Open/Closing for Fall 2022 Round:

The posted timeline for Fall 2022 round was reviewed and agreed to proceed as noted.

Advertise March 1, 2022 – March 31, 2022.

Application closes April 1, 2022.

Review and score applications May 2022.

Notify winner(s) June 2022.

Award scholarship July 2022.

Next Committee Meeting:

The Committee agreed to meet in July 2022, at the convenience of Tracey Hester Flynn, for the Spring 2023 round.

The Committee agreed to meet in-person May 2022, if there is more than one applicant for the Fall 2022 round. If only one applicant, the Committee will score the application and essay via email communication through the Committee Staff, Tina Thompson.
