Health and Public Safety:

E. Pantoja reported:

- M. Decunto met with Times Union Editorial Board to discuss increasing awareness of Mental Health. Provided discussion on effects of PTSD, Depression, in our student population. Informed board of Duval County Public School Superintendent Nikoli Vitti's need for increased funding in mental health due to recent increase in behavioral concerns, depression, and suicidal ideation in the high school population.

During this interview, the community was introduced to the importance of access to health care, Florida Kidcare, and the services the center provides to families in need of health coverage. Class is available to educate families on healthy sleep habits at Player's Center for child health at Wolfson's Children's Hospital. Class is held 1xmonth.
- 3. Health Literacy and Safety Presentation at the Center for Language and Culture January 26th Contact Hind Chahed

Met to discuss Housing Workshops by MHAAB Board Member Jose Cuetos to include a

recurring program offered at the FSCJ Downtown Campus and South Campus for those

individuals that live closer to the beach area. The workshop would be included in part of the ESOL program as a way for the students to converse in English and Spanish, ask questions and learn about their house options.

Students are not required to attend but the intention is to promote social interaction, economic understanding and learning potential. Creating the first Legislative Internship Program to offer students hands-on training in offices of elected officials. Once the curriculum committee approves the course description and outline, the scholarship committee will assign a monetary amount for students that want to study in Washington, DC for one semester. Students will also continue their studies with the ability to take 2 online courses at the same time. The full credited program is expected to launch in Fall 2017.

Signed up to begin the TESOL/TESL/TEFL certificate course through Oxford Seminars, usually given at UNF. The course will begin January 21 st 9 a.m. -6 p.m. for three consecutive weekends plus 40 hours of online courses and a teaching practicum that occurs during class time. This will allow me the opportunity
