# Revenue

## **Transportation Program**

- As of June 30, 2007, transportation program net revenues total \$46,917,964, \$2.8 million above model.
- However, sales tax revenues are performing below model for the same period, there was a \$2.2 million negative variance.
- Program is able to withstand such variances in sales tax revenues due to the other revenue streams associated with the program (i.e., constitutional gas tax), which have been overperforming.
- Life-to-date program performance is \$20.6 million above model, with a total of \$402,707,526 net revenue.
- Expect to issue bonds totaling roughly \$95 million by the end of August.

### **Infrastructure Program**

- Sales tax performance is a bit better than in the infrastructure program, due to a difference in the basis of collection transportation program is countywide, infrastructure is shared w/Beaches and Baldwin.
- Sales tax revenues are performing slightly above model as of June 30 \$119,189 positive variance against model.
- We will issue debt before calendar year end, though it has not been sized. The size will be driven by performance over the next couple of months, then go to market late this year.
- Life-to-date infrastructure program sales tax performance is \$9.1 million below model.

Over the next few months, the Finance Office plans to work with the BJP Finance Administration Committee to review the models and financial elements associated with BJP. Currently the BJP tax is still anticipated to end several years before the December 31, 2030 deadline.

### PROGRAM & DESIGN STATUS

- Auchter / Perry-McCall (APM) completed a master plan of the courts facilities to meet the judicial needs of the county through 2035. Its recommendation was a unified courthouse that would require additional funding and Council approval.
- APM's contract was terminated for convenience on May 3, 2007
- On July 19, CSPEC authorized the start of negotiations with Turner Construction, in conjunction with KJB Architects, which was the second-ranked team on the RFP.
- Design will commence following approval of the award to Turner and negotiation of contract. Design will be for the entire 780,000 SF as defined in the Dan Wiley 2005 Program and must be approved by the Courthouse Architectural Review Committee.
- Groundbreaking expected early 2008, with construction expected to last three years

### **CONSTRUCTION STATUS**

- Old Federal Courthouse
  - > Re-roofing project was completed in February.
  - > Exterior cleaning contract has been bid and awarded. Work is ahead of schedule and should be complete by the end of August.
- Bay Street Courthouse
  - > Two new courtrooms and offices for four judges completed in December 2006.
- City Hall Annex
  - ➢ Plans underway for minor renovations to all floors to accommodate State Attorney. Work is complete on Floors 5, 8, 9 & 12 and the State Attorney's Office has moved in. Work continues on the 1<sup>st</sup>, 2<sup>nd</sup>, 13<sup>th</sup> and 14 Floors and will be complete in August.

• Approximately 1,775 miles of neighborhood streets have been resurfaced.

 As of September 30, all BJP resurfacing funds will be exhausted. There will remain approximately 60 miles of the original list left unfinished by the program, 11 of which are on hold for drainage improvement projects. The remaining roads, and all future resurfacing projects, will be funded by the city's capital resurfacing funds as well as the county road program.

# **Septic Tank Phase Out Program**

- ♦ The Better Jacksonville Plan will phase out septic tanks in six areas of the community that have been declared a sanitary nuisance by the Duval County Health Department.
- ♦ All of these areas have been shown to have leaking septic tanks, which are polluting the St. Johns River or tributaries leading to the river.
- ♦ JEA will install sewer lines in these areas at a total cost of \$87.4 million (\$75mil+\$2.4mil+\$10mil).
- ♦ JEA will incorporate an additional \$20 million of city drainage improvements in the Projects.

# **Northwest Economic Development Trust Fund**

# **PROGRAM SCOPE** The overall vision of the Northwest Economic Development Trust

Fund (NWEDTF) is to be a catalyst for economic development within the target area, by working with business owners and entrepreneurs to attract new businesses and expand existing businesses, thereby, creating employment opportunities and providing area residents with much-needed commercial, retail and

entertainment services. \$25 million

### **PROGRAM STATUS:**

The Northwest Economic Development Trust Fund (NWEDTF) has public funds used to provide capital for project development. The prospective applicant must be a business located within the Northwest Jacksonville area or a business that is expanding its operations into this targeted area.

The NWEDTF will use standard eligibility and credit factors in the loan/grant decision process. Credit decisions will be based on an analysis of program eligibility, management experience and ability, character and credit histories, repayment capacity, financial strength and collateral adequacy. The loan/grant will be subject to ongoing monitoring to ensure compliance of the contract stipulations.

In March 2007, the NWEDTF Advisory Board published the project evaluation criteria, available online at http://www.coj.net/Departments/Housing+and+Neighborhoods/NWEDTF/default.htm.

All projects considered for NWEDTF must meet the following general guidelines:

- Business must be located within NWJEDF area boundary.
- Completed personal financial statement if a business is not a corporation.
- Initial businesses, for infrastructure only.
- Existing business (defined as 2+ years in business) shall submit at least two years of most recent financial statements or tax returns.
- New commercial development shall submit a complete business plan with pro forma for three to five years projections and demonstrate relevant experience.
- Provide evidence of proper zoning.
- Provide cost estimate for proposed acquisition and/or improvements (to include machinery & equipment purchases and/or proposed leasehold improvements).
