

Call to Order

Vice Chair DeVall called the meeting to order at 5:30 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan St., established that a quorum was present and welcomed everyone. Chair Parrish extends her apology for not being at the meeting. She had a family emergency.

Approval of the Minutes

Member Arnold made a Motion to accept the minutes from the January 7, 2013 meeting. A second was made by Member Swain. The Vote: All in favor; none opposed. The Motion carries.

Vice Chair DeVall introduced guest speaker Director of Public Works Jim Robinson.

Guest Speaker

City of Jacksonville Director of Public Works Jim Robinson gave a PowerPoint presentation on the Public Works Department. He stated there were 530 employees operating in 5 Divisions.

- Right-of-Way & Grounds Maintenance
 - o They maintain over 3,600 miles of roadways & 180 bridges, patch 4,000 Potholes per year, manage the resurfacing of 100 miles of roadways per year, have 1,100 traffic signals and mow 3,900 acres of roadside. They manage the stormwater and drainage with the following: 44,000 catch basins/inlets, 7,500 manholes, 1,000 miles of stormwater pipes, 134 ponds, 2,000 miles of major outfalls (ditches), 4,000 miles of roadside ditches and 8 pump stations
- Solid Waste
 - Collects garbage from 265,000 residential property owners, COJ handles 57K and manages the other 208K thru private haulers, manages the small business downtown collections (124 businesses) and manages the Trail Ridge Landfill
- Real Estate Engineering
 - They manage 118 City leases (tenant or landlord), acquire real estate needs for Capital Improvement Projects (CIP), manage the real estate surplus and closure services
- Public Buildings
 - They maintain 636 Buildings/Structures (9 million SF 2 million SF of this is managed by SMG)
- Engineering
 - Management of Capital Improvement Projects (CIP) & drainage projects, roadway projects, park projects, public buildings projects, public safety projects and "Other" projects
 - Support development engineering design reviews
- Officer of the Public Works Director
 - Support event/debris management

- Support EOC during storm events to ensure Drainage System continues to function & roads remain open
- Post storm event provide all services to collect and dispose of storm debris
- Ensure FEMA coordination for reimbursement
- C-H-A-N-G-E
 - o C Customer Service, H Help one another, A "All in", G Goal directed action, E Exciting
- CARE System

Members had questions/concerns on the following:

- Member Vanderlaan has used the CARE system many times and it is a good system but when it comes to potholes it is a problem. They have trouble determining if it is a cave-in or a pothole. Then where should it be sent: to the City or JEA. Citizens don't know the difference between a cave-in or a pothole. Therefore; they have trouble getting them fixed. At 1809 North Liberty there is a hole that has been reported and nothing has been done. Director Robison explained that this is a difficult issue that they are working on. They do have to first determine if it is a pothole or a cave-in. Is the surface base stable or is the road depressed? Can it be fixed by his in-house team or does it have to be sent to a contractor? The contractor has large equipment to work with larger diameter pipes and deeper trenches. He stated that next time he comes back he hopes to have made improvements with this process. He is convinced he can address this issue.
- On the corner of Walnut and Phelps and Ionia Streets there is a pond built in the early 1990s when the Habitat homes were built. A resident has been mowing this and can no longer manage this. The city right-of-way and the pond has not been maintained by the city. Someone needs to take on this responsibility. Director Robinson stated that they have just finished the bidding for right-of-way mowing and the new contract that goes into effect on March 1, 2013. Due to the competitive process they will mow 6 times per year instead of the budgeted 4 times.
- Member Swain asked why some neighborhoods have garbage cans and others do not. The City of Jacksonville has three private contractors and the City has an area that they pick up garbage. Southland Waste went to a new automated system and have a can for garbage and one can for recycling that are picked up with a claw on the truck. There has been an increase in recycling. They have doubled the amount of tonnage. This is going to the recycling center and not the landfill. Each ton that is collected the city gets \$41. If you need a blue bin you can get them at Superior Street. Each Council District received 300 blue bins and some Council Members had a convenient location to pick one up. Check with your Council Member to see if they have a location.
- Has the rule changed on the time that garbage can be put to the curb? There is trash all over the neighborhood. It was called in and the litter patrol came out. The time has not been changed. There is also illegally dumped garbage that can be checked with members of the Solid Waste Division investigating this.
- Ms. Harris asked about getting curbs and gutters in the community and how often do you check on trees or other issues in the drains and ditches? Given the current manpower we are in a reactive mode and a proactive mode in the storm season. We do depend on the citizens to report issues to the CARE system. Roads are designed either with road side ditches or with a curb and sewer pipes underneath. It is a monumental effort to convert from a ditch system to a pipe and curb system. It has to do with the actual slope of the road. If there is a situation that it is physically feasible they could possibly look at it with the understanding that it may fall under a neighborhood assessment. Neighborhoods would have to have 2/3 of the residents agree to an assessment to raise the money. The city can help come up with an agreement and front the money knowing that the citizens will be paying for it. Ms. Harris sees a lot of cracks in the roadway. This may be an indication that a pothole or cave-in may be coming soon. Don't hesitate to report that. We go through the city streets and rate the roads. The type of crack may indicate what is happening with the road. This year because of the funding level they will be addressing the roads that have been rated 60 or below (in a 100 scale) they can afford to fix. If the number is higher than 60 you may still see cracks. They are looking at additional techniques to see if they can extend the life of the roads. If you are just seeing cracks starting it may not be addressed for years away.
- Can you please update us about the cave-in at Liberty Street near the Riverwalk? There was a painting/weather stripping contractor that Berkman Plaza hired. There was a weight restriction on the road due to the pilings underneath the road surface. The area near the old courthouse and the Hyatt was historically water and it is now on a bridge. The contractor took his crane that was four times the weight limit and the cave-in happened. The City of Jacksonville felt it was the contractor's fault and they should fix it. There was a contest with his insurance company and the city. The insurance company wanted the City to investigate the problem then work out the claim issue. The city hired a demolition company to remove the debris which was a step to take before FDOT divers can determine the extent of the repairs on the bridge below the surface. Then they can get back with the insurance company. With a collapses of this nature they have to determine the extent of the repairs. It was not logical on how the steps that were taken but they were what the attorneys and insurance company decided on. They are still not sure when it will be repaired. Parks & Recreation – Bobby Quaintence was in attendance for the excused District Park Manager Mark Hartley. He sent an e-mail on the on the following:

- 1. We have identified 8 locations on the north bank and we will be installing no fishing signs at those locations this week. (JSO will now be able to enforce the No Fishing Ordinance).
- 2. The repairs to the restrooms at Confederate Park will resume in a couple of weeks. A change order had to be made due to the plumbing issue that was found once the demo started.
- 3. JSO has removed the homeless camp from under the bridge at Confederate Park which was a question from last month's meeting.
- The new Confederate Park will have an opening on Feb. 13th and members stated that it is a marvelous Park and being used a lot already.
- Another project for Parks is a place downtown for people to fish legally. The suggestion is the deck by the St. Johns Boat Ramp near the River City Brewing Company. It would have to be approved by the Fish Management System but then there is also the potential if the USS Adams comes as a floating museum it would need to move. Another suggestion would be at the Shipyards Property with the beautiful grassy area. Ordinance 28.701 for Downtown would have to be changed to include an area for fishing. It is obvious that people want to fish downtown and we need to find them a location to do so legally.

Members had questions on the following:

- What time do the lights go out at the parks? The Kennedy Center lights go out at midnight and there are no lights lite at A. Philip Randolph Park.
- At the Raymond Davis Park on 21st Street and Spires the sawdust and mulch needs to be replaced. In particular under the swings. There is a drainage issue and the rain washes it away.

Municipal Code Compliance – Supervisor Nelson Beard reported that there are 1410 active cases in the Urban Core. Members had the following questions:

- They wanted to know where the active cases were: 29th and Chase, Brooklyn, Downtown, East Jacksonville, Fairfield, Hogan's Creek, LaVilla, Midwest Side, Moncrief, Phoenix, Springfield and Tallyrand neighborhoods.
- Members wanted to know how long it took to resolve problems. It varies from issue to issue. For example, nuisance
 issues depend on the time of year i.e. the growing season and how fast a contractor can get out. With board ups
 vagrants break in more in the winter months. There is no set answer.
- It was mentioned that on East 4th Street in the 700 block it has become a dumping site. Solid Waste handles garbage.
- Member Swain reported 2719 Fairfax (4-plex) for garbage all over. They do not place the garbage in cans and the dogs spread the garbage throughout the neighborhood. Code Enforcement no longer cites for early set-out of trash. It went back to Solid Waste. Supervisor Beard will send out an officer to check the area.

Subcommittee Reports

Preservation – Chair DeVall would like to have a meeting at 4:30 p.m. before the next regular meeting on Monday, March 4, 2013 in Training Room 110. Members discussed that this committee could expand the scope to include vacant lots and buildings i.e. the Laura Street Trio, the old Bank of America Building, Annie Lytle School and the Armory. Members suggested using the Armory for the Supervisor of Elections Office. They would like to meet first to discuss goals and objectives on what direction to go. Then at the following subcommittee meeting they will invite people to discuss the issue/building and bring back information to the CPAC members.

Unfinished Business

Members wanted to know how parking fees for events are decided i.e. the circus was \$10. They also wanted to
know if the Ordinance on parking that was talked about at the October 2012 meeting was passed. Yes, it was
enacted, Ordinance 2012-674. This was the information that was presented at the October 2012 CPAC meeting
from Parking's Jack Shad.

New Business – Council Member Boyer sent info on a Draft Revision for a PUD. Members had the following comments but no action was taken. They went over the revisions. There are going to be two types of a PUD – General and Large and Small and one is Conceptual. The conceptual will tell you what you want to build. It is very specific. They will be asking for a lot of information on what is to be done. They may want to recommend that they don't need that much information on the General PUD. They would like more information on this. The small scale is the existing PUD. The letters and numbers are not correct. Once the new bill is modified that may be the time to get more information and take a position. Or the CPAC can wait until it will be ready to go before Council. Members stated they did not want to make it harder for development or businesses to get up and running. Also they wanted to know what the purpose of the revision was. Members would like to have Council Member Boyer or her ECA come and help answer these questions or they will wait until it goes to committee with the revisions to make a decision on how to proceed. There was no action taken.

Public Comments/Announcements

- Council Member Clark wants to reinstate the Mobility Fee Moratorium for 3 more years. Residential units would be exempt. The CPAC took action previously with a letter from the October 5, 2012 meeting. After reviewing the new Ordinance 2013-0094 the CPAC may want to resend the letter or oppose it. It will be introduced at the next City Council meeting. The CPAC may want to have the Chair or a representative at the City Council meeting to state the Urban Core CPACs position. Members would also like to get a copy of the bill to review it and or look at opposing Council Member Clark's Ordinance 2013-0094.
- The Bostwick Building has been deferred until at least the 20th, per Councilwoman Boyer's office.

Adjournment

Member Radlinski made a Motion to adjourn and was seconded. The Vote: All were in favor; none opposed. The meeting was adjourned at 7:01 p.m.
