Call to Order

Chair Parrish called the meeting to order at 5:34 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan St., established that a quorum was present and welcomed everyone. She reminded visitors that candidates are welcome to introduce themselves and state the office they seek during the public comment portion of the meeting but there cannot provide additional information or distribute literature anywhere inside of the building.

Approval of the Minutes

Member Arnold made a Motion to accept the minutes from the June 4, 2012 meeting. A second was made by Member Merrick. The Vote: All in favor; none opposed.

Staff Reports:

JSO – Zone 1 – Sgt. Perkins had no official report. Members asked for information on the temporary downtown enhancement program and learned that during the last two weeks, for the downtown area from the river to Duval Street between Liberty Street and Broad Street there was 1 robbery, 1 residential burglary (at Newnan Street) and 3 car burglaries.

Municipal Code Compliance – Supervisor Nelson Beard reported 1940 active cases in Zone 1 with no new systematic inspections. Members asked for an update on the squatter previously reported on 20th Street, and Mr. Beard advised that the property was checked a few times and the house remains secure. They have not caught a squatter. If the house becomes open they will ask for a complete board up due to the complaints at this address. Beard noted that he is down 4 officers due to the proposed budget and does not believe the vacancies will be filled.

Recreation and Parks – Pam Roman reported:

 begin Monday, Aug. 13, 2012.
- Summer Night Lights will end next weekend. Additional funding has been provided for 2013.
- Members had the following questions and comments:
- The sign prohibiting feeding birds requested for Confederate Park is not there.
 Ms. Roman stated that Parks is working on the appropriate wording for the signage.
 This has gone to the Preservation Chief. A member asked why would it go to the Preservation Chief; Ms. Roman advised that wildlife issues are handled by Preservation.
- A member asked for an update on the Confederate Park Playground. Ms. Roman advised that she would obtain that
 information. Ms Roman followed up with an email advising that construction would begin on August 10th with
 completion mid September.

Guest Speakers

Chair Parrish introduced Public Defender Matt Shirk, after advising that CPAC tried to contact Chuck Fletcher, Mr. Shirk's opponent in the upcoming election, to invite him to attend tonight's meeting.

Mr. Shirk provided an overview of his education and work history, provided information about the Public Defender's Office and discussed several programs of the PD:

- The Office has 75 attorneys and 70 support personnel and a \$12 million dollar budget. They work in Duval, Nassau and Clay County in the 4th Judicial Circuit and handled a large volume of cases.
- For the past few years the PD has partnered with the Children's Commission and PAL to provide a summer camp for youth called Vision for Excellence. This year the camp was at the Eastside PAL Center on Franklin Street and 40 children participated, with a waiting list of 50 children.
- The PD recently started a Veterans Court Program which is similar to Drug Court, a very successful initiative with only a 10% recidivism rate. Approximately 1300 veterans are arrested each year, and many were not getting the services they needed from the Veterans Administration. This program matches these veterans with mentors and so far participants have had a **zero** recidivism rate.
- Members expressed concern about losing the JSO Matrix House Program, an intensive four month substance abuse treatment program with a maximum of 135 inmates, due to proposed budget cuts. Mr. Shirk agreed that this program should continue.

Chair Parrish thanked Mr. Shirk for his presentation and introduced the second speaker, JTA.

Chair's Report

- 2013 Nominating Committee: The committee will present a slate of officers at the October 2012 meeting and the
 election would be during the November 2012 meeting. Members Gloria DeVall, Dorothy Merrick and Doug
 Vanderlaan volunteered to serve. They will meet at 5 p.m. before the next regular meeting on September 10, 2012.
 If any members would like to be considered please let Neighborhood Coordinator Marilyn Fenton-Harmer or a
 committee member know.
- Chair Parrish discussed with members what speakers they would like at future meetings. She would like to invite the IBM Smarter Cities Challenge Team to speak, and Member Merrick advised that she was invited to the kick-off on Tuesday, Aug. 7 at 10 a.m. at the Main Library. Members stated they would like their voice to be heard about downtown. A request to speak about the Duval Food Policy was discussed and declined.

Elected Officials Reports - none

Subcommittee Reports

- Parks Chair Radlinski reported that the subcommittee recently reviewed conditions at Robert F. Kennedy Park, Simonds Johnson Park, Russell "Bill" Cook Park, Grunthal Park and Florida C. Dwight Park. Members found Kennedy Park to be most well-appointed and well maintained. Other parks needed mowing and minor maintenance. Ms. Roman explained that mowing frequency has been reduced due to budget constraints; however, Parks is willing to negotiate with community groups to sponsor parks, which includes maintenance. Deficiencies such as broken or missing equipment, lights without bulbs and litter will be reported to Public Works through the CARE System. At its next meeting (9/10) the committee will review James Small Park, Liberty Park, Wigmore Park, Longbranch Park, J.S. Johnson Park and Emmett Reed Park. More than half (16 of 30) of the parks within the Urban Core CPAC jurisdiction will have been visited and reviewed. Member Merrick attended a recent meeting about Hemming Plaza and suggested that we send our past Motion on Hemming Plaza, stating Urban Core CPAC recommendations for that park, to Council Member Lee and other committee members.
- <u>Environmental</u> Chair Vanderlaan no report
- Preservation Chair DeVall advised that the Urban Core CPAC will now receive the Historic Commission Design Review Book on Friday or Monday of the week before each Historic Preservation Commission meeting. The meeting is on the last Wednesday of the month and the Urban Core CPAC will not have an opportunity to discuss issues at its regular meeting because the HPC agenda is not then available. Chair DeVall asked that the Urban Core CPAC consider reviewing issues related to historic landmarks located in the Urban Core but not in a recognized historic district. A list of these landmarks was requested from historic planning. The Preservation Subcommittee will strive to meet on the Tuesday before each HPC meeting to discuss the agenda.
- <u>TRUE Commission</u> CPAC Representative Radlinski reported that the TRUE Commission is focusing on the City's pension problem.

Unfinished Business – none

New Business

Member Vanderlaan presented the following Motion:
 "A close partnership between Urban Core neighborhoods and JSO has resulted in a very positive trend toward reduced crime rates and safer streets. The Urban Core CPAC is concerned that proposed budget cuts will lead to the layoff of hundreds of JSO officers, and will set back efforts to further improve public safety. In order to continue the improvements in public safety in the Urban Core we urge the Mayor and City Council to work together to provide

adequate funding to avoid these layoffs. We are confident that the budgetary tools, including millage rollback, are available to protect our quality of life."

A second was made by Member Radlinski. Discussion ensued.

Chair Parrish recommended amending the Motion to provide:

"A close partnership between Urban Core neighborhoods and JSO has resulted in a very positive trend toward reduced crime rates and safer streets. The Urban Core CPAC is concerned that proposed budget cuts will lead to the layoff of hundreds of JSO officers, and will set back efforts to further improve public safety. In order to continue the improvements in public safety in the Urban Core we urge the Sheriff, Mayor and City Council to work together to avoid these layoffs. We are confident that appropriate budgetary tools are available to protect our quality of life."

A second was made by Member Merrick. Discussion; The Vote: All in Favor; none opposed.

• Member DeVall stated that North Shore Elementary School has made many changes this past year with new administrators and teachers. Students have attended school an hour more each day than other schools. The school grade improved from a D to a B, an achievement that is particularly significant when the socio-economic status of the students is considered: 93% of North Shore students receive free or reduced lunch.

Member DeVall made a Motion to commend the school, administration and district for hard work resulting in improved grades. Member Merrick made the second. Discussion ensued with questions about changes in this year's educational standards. The Vote: All in favor; none opposed.

Public Comments/Announcements

- Michelle Kalil introduced herself as a Candidate for Judge.
- Cassandra Barlow introduced herself stating that her husband Al Barlow was running for Judge.
- Shakera Baily reminded members that early voting started on August 4 and goes to August 11 and the Primary Election is on Tuesday, August 14, 2012.

Member Vanderlaan made a Motion to adjourn and was seconded. The Vote: All were in favor; none opposed. The meeting was adjourned at 7:15 p.m.

The City of Jacksonville's Urban Core Citizens Planning Advisory Committee has established a Subcommittee to review parks and recreation in the Urban Core. That Subcommittee has engaged in extensive dialogue regarding the future of Hemming Plaza and presented its findings to the full CPAC during a meeting earlier this year. The Subcommittee made the following recommendations regarding Hemming Plaza:

- The Park should be "softened" and made more attractive with additional landscaping, including grass and flowers.
- 2. Benches and other seating should remain in the Park.
- 3. JSO should provide officers on foot to patrol the Park during open hours.
- An area for children and families, including a small playground, should be provided in the Park in close to the Main Library and MOCA.
- The City should focus on providing regular (at least weekly) programmed events in the Park.
- 6. Bicycle racks should be installed to encourage cyclists to visit the Park.
- The City should consider allowing concessions in the Park (including food trucks) for the sale of food and beverages.

The entire CPAC voted unanimously in support of the recommendations of the Parks Subcommittee. We hope that you will strongly consider these suggestions as you move forward with compiling your own recommendations for the improvement of Hemming Plaza. We are Urban Core residents and business owners and will be among those most directly and significantly impacted by any changes made to the Park.


