

### Call to Order

### **Speakers**

### Ron Barton, Executive Director, JEDC

Provided an update on the Downtown Master Plan to reflect current conditions. Stated that JEDC has replaced DDA for downtown development. A downtown committee will focus on retail and entertainment. The proposed project would run \$60 million. Citizen involvement will be implemented through task forces or JEDC commission meetings. Citizens are encouraged to communicate with JEDC to provide feedback. He further stated that JEDC would provide regular representation to the CPAC meetings.

### Michael Bryant/Beverly Toney, FRESH Ministries, Inc. – East Jacksonville Affordable Housing

Reported that FRESH Ministries is marketing affordable housing in east Jacksonville. Presented plans for construction of single family homes on Grant Street. The Restore the Glory phone number is now 854-4444.

### Subcommittee Reports

*Environmental* – Michael Hartman reported he is following approval of funding in the House Committee for the Army Corp of Engineers study of the Hogans Creek. St Johns River Water Management District requested funding from the state government, and applied for a grant from NOAA with support of matching funds from JEA. The Department of Health will study vegetation of the St Johns. The grant would be \$100,000 if funded.

The Department of Housing and Neighborhood Services is newly proposed and would include four divisions: Neighborhood Services, Property Safety, Housing Commission and Community Development.

PLANNING AND DEVELOPMENT – Ken Avery reported that Margo Moehring is the new chief of Strategic Planning and also provided site plans for the Durkeeville Historical Society Community Art Gallery located at 19<sup>th</sup> Street and Myrtle Avenue.

Michael Hartman indicated that the Growth Management Task Force would afford CPACs more responsibility.

### New Business

Janetta Norman nominated Michael Hartman to receive the Mayor's Individual award and FRESH Ministries to receive the Mayor's Organization award. Seconded by Ethel Griffin and unanimously approved by the body. Janetta Norman appointed Ethel Griffin to the Hospitality Committee.
