

Speakers

Waterways Commission, Reclaimed Water

Representatives from Duval County Department of Health, St Johns River management District, JEA and the Department of Environmental Protection reported reclaimed water is treated wastewater and storm water identified and disseminated by purple pipes. Use of reclaimed water is less costly and decreases the demand on utilities. Watering restriction guidelines do not apply to those using reclaimed water. To date there have been no reports of health concerns associated with reclaimed water.


Jarik Conrad, Executive Director, Blueprint for Prosperity

Reported the Blueprint for Prosperity is a comprehensive strategic plan to raise Jacksonville's per capita income (which currently stands at 94.4%) by 0.5% annually by 2007. He encouraged members to review the document and to get involved by embracing at least one strategy. Members were invited to become Blueprint Partners by completing the form on page 38 of the document.

CODE ENFORCEMENT – Bob Prado reported a total of 1527 complaints received in the Urban Core, 65% of which have been resolved.

DEPARTMENT OF TRANSPORTATION – Milton Locklear reported lane closures on the Mathews Bridge to inspect the grating commencing March 12 and 13 from 9:30 p.m. to 5:30 a.m. Traffic will be rerouted to the Hart Bridge. He also reported closures on Forest Street to Riverside Avenue March 18 to 21 and Acosta to Fuller Warren Bridge four nights to install pillars.

Doug Vanderlaan informed members that budget cuts to solid waste have reduced the number of crews servicing Springfield from five to three. He expressed concern with the budget and the grants that neighborhoods receive.

Michael Bryant introduced guest Beverly Toney Eastside Housing Coordinator and requested FRESH Ministries be placed on the April agenda to report on the eastside housing issues. Doug Vanderlaan requested to have councilpersons address budgetary concerns. Janetta Norman requested a representative from the State Attorney's office to speak regarding prosecution of individuals committing homicides and school board superintendent Stephen Wise.


Announcements
