Call to Order

Chair Vanderlaan called the meeting to order at 5:03 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan Street and welcomed everyone. He thanked all the experts for coming.

He said there has not been a lot of discussion but has had updates from The Hester Group with Project New Ground. He introduced all the guests: Dr. Pegg a Toxicologist representing North Riverside CDC, Diane Kerr, President of North Riverside CDC in the Forest Street Site, Felicia Boyd, representing the 5th and Cleveland Street Site, L'Tonya Spencer, Public Affairs Specialist for the EPA, Caroline Philson, EPA Attorney, City of Jacksonville Attorney Kristina Nelson, Environmental Engineer Jim Manning, Site Investigation and Remediation Program, and Greg Bruce, The Hester Group consultant for the City of Jacksonville on Project New Ground.

Approval of the Minutes

Member Arnold made a Motion to accept the May 3, 2010 meeting summary as written; A second was made by Member Tutwiler. Member Miller wanted to be sure that that the transportation Subcommittee report and the FDOT report were listed separately. The Vote: All in favor; None opposed.

Staff Reports

Jacksonville Sheriff's Office (JSO) Zone 1 Assistant Chief Chris Butler reported that he had no formal report. There is a slight trend upward on auto thefts. The Jazz Festival was safe and successful. The next event will be the 4th of July. Guest Speakers

Chair Vanderlaan presented a map of the Urban Core with the Ash Sites circled on the map. He started going over the history of the ash sites but members asked to speak on the issues that he was concerned with.

Chair Vanderlaan's Presentation

Summary, CPAC questions/comments, public questions/comments Historical responsibility

It was decided that these areas did not represent a high risk and that sampling and remediation of the main sites immediately around the incinerators were of higher priority."

Chair Vanderlaan was concerned with the economic impact and the stigma for the neighborhoods. He invited a realtor to talk about what the language on the Property Record Card and what it means to mortgage brokers. Members and guests had concerns on the following:

- That this was not just one neighborhood but the district with all neighborhoods that shared the same concerns.
- The Economic Impact on Urban Core
- The Property Record Cards specifically the language that is on the Property Record
 Cards (PRC) listed on the City of Jacksonville's website www.coj.net: Notice: there are or
 may be hazardous substances on the property. For more information call 904-630-CITY
- Members have been complaining for years on the ash sites and now that more expensive homes in Springfield are being included are outspoken.
- There was a lot of confusion on how the sites were to be cleaned up.
- City of Jacksonville Jim Manning reported that a recent change is when lead is tested and exceeds the lead level it will be remediated. However it will not be more than 2 feet.
- Members were concerned with the health of the residents living in the Eastside in particular the highest lung disease rates.
- EPA Attorney Caroline Philson reminded everyone that the Consent Decree would only cleanup up to 2 feet of dirt. If anyone would dig in the ground the orange mesh would be there at the 2 feet level and should contact the city or the EPA. Members still had

- concerns for future residents that would move in years from now as well as renters.
- Members want the community to be fully informed on all the aspects of the ash and lead. Everyone needs to be on the same page. Project New Ground has been giving updates but not in detail.
- Members have been trying to get information on property values and no one has been listening.
- Members had concerns that one parcel was to be tested in Durkeeville and then the next one would not be tested.
- When lenders look at the Property Record Card that has been tagged with from the City they will not lend money for that property.
- Members had concerns on the definition of the word "site" and the boundaries of each site. There was also confusion on the definition on the OU 1 and OU 2 on the map.
- EPA Attorney Philson did go over the definition of the site that is in the Consent Decree.
- Members talked about amending the Decree to include the economic loss and the equity in the properties. This is a financial crisis.
- Members still have questions on the economic impact, not having the full disclosure and the explanation of the expanded boundaries. They also have residents that have not been tested nor will they be tested. The number of parcels continually changes.
- Members talked about:
 - 1. removing the notices from all properties outside the 36 acre site
 - 2. All homeowners in OU1 and OU2 have the right to have their properties tested and remediated.
 - 3. Give top priority to testing and cleanup around homes where children are at risk or where the families face financial hardship.
 - Some members just wanted to get to the heart of the issue by removing all notices on defined sites.
- Members wanted clarification on the JEDC and the Ash sites.
- Members want to be sure that if there is no contamination there would not be any language on the Property Record Card.
- They wanted to know who made the decision to expand the boundaries. They wanted to know how large was the site.
- There was great concern from parents wanting to know what to do about children playing in yards.
- Jim Manning also stated that the City of Jacksonville is committed to the Consent Decree and will not run out of money.
- A suggestion on trying to get stimulus money was made.
- City of Jacksonville Attorney Kristina Nelson spoke about the agreement and the EPA working on the language for the Property Record Cards that would not turn banks away.
 EPA Attorney Philson said they were hopeful in 2 months or so to have that language in place but she has to go up the chain of command.

Member Radlinski moved that the Urban Core CPAC recommend that the Mayor negotiate with U.S. EPA to revise the required property record card notation to delete cautionary language once a property has been remediated or determined not to be contaminated. A proper second was made by Member Arnold. A lively discussion ensued on the topics listed above. The Vote: All in Favor; none opposed.

L'Tonya Spencer from the EPA told members that Tronix on the Eastside is now a Superfund site and on the National Priorities list. There will be upcoming public meetings on the status of the site. Members would like an update on this at a future CPAC meeting.

- Homelessness and Panhandling Chair Greg Radlinski reported that at the next ShAdCo meeting the JEDC was looking at reconfiguring properties. It will be on June 22nd.

- Transportation Chair Celia Miller reported that the TPO last Wednesday discussed the TIP priority list of 20 projects that are pending and encourage members to attend the transportation regional meeting that FDOT Milton Locklear reported on which will be on June 16.
- Vacant Properties Chair Doug Vanderlaan had no report. A question on if there was a
 timeframe was asked and currently there is a limited time frame. Questions were asked
 on foreclosures and notices to investor or abandoned property owners that have been
 cited for multi violations that may relate to Ordinance 2010-327.
- Urban Core Vision Plan Chair Vanderlaan did attend the Vision Plan Steering
 Committee meeting and did report to them the motion that was made and passed by
 the Urban Core CPAC. Member Tutwiler reported that the Committee adopted the plan
 and made some changes to the plan like having the Conservation District for older
 neighborhoods. The Plan will have to go to the City Council for approval.

Urban Core CPAC Member Tippins TRUE Commission term will expire at the end of June.
Chair Vanderlaan asked members if anyone would like to represent the Urban Core on
the TRUE Commission. Member Tippins spoke on how interesting the meetings are. They

on other committees. The Committee makes recommendations to the Mayor and City
Council. They research how the money is being spent. Member Betty Chance
volunteered.
