#### **Guest Speaker**

City of Jacksonville Assistant Budget Officer Heath Beach presented a PowerPoint on the City of Jacksonville's Budget Introduction Process. The copy of the presentation is listed below. It was stated that asking to go above the maximum millage rate with the state after the rate has been set is very difficult. All cities in Florida face this and none have gone back to increase it from the August 4 due date. The City Council Finance Subcommittee on the budget concluded last

Thursday, August 26, 2010. The City Council did find some dollars to save in various departments. They do have to adopt a balanced budget prior to October 1st. The entire operating budget is around \$1.6 billion dollars. - 1. If someone sues the city or JSO and the case is settled, where does that money come out of? Depending on the type of lawsuit, settlements are paid out of the General Counsels Budget or our Self Insurance Funds.
- 2. Where do the city fees on the JEA bill go to and are they on the website? Franchise Fees and Utility Service Tax (Public service tax) go into the General Fund. The General Fund includes most basic municipal services and those that are not required to be accou8nted for in another subfund. Services include Police, Fire, Public Works, Parks, Libraries and many others.

Members also wanted to know how much money were in the city reserves? \$33 million dollars but in 2005 Tropical Storm Faye cost \$15 million dollars. They also asked if the biggest portion of the tax dollars comes from property taxes and with the amount of foreclosed homes they are not paying the taxes. What is the city doing to compensate that? The item is not broken out but the Property Appraiser does take that into account on the budget he presents. It was also discussed that with the increase of solid waste garbage fees and stormwater fees are not progressive taxes and everyone is paying the same amount. Member LaMountain made a Motion to write a letter on the following: The Urban Core CPAC acknowledges the efforts to make budget cuts for the city's fiscal year, but in light of the unprecedented revenue shortfalls resulting from property tax base reduction we advise the city adopt the Mayor's proposed millage increase to 10.12. The Motion was properly seconded. Discussion pursued on this topic. The Vote: 6 in Favor; 1 opposed. The Motion carries.

#### **Staff Reports:**

Mayor's Representative – Carolyn Shehee-Williams announced that the Library would be holding Town Hall Community meetings to have a dialogue on the future of the library system. Members asked why have the community meetings if the budget has to be cut and how much will this cost? The consultant will be looking at the future for the library system in 5 to 10 years and the consultant is being paid \$190,000 which is being paid for with private dollars and not general fund money. #### Mayor's Office

Project New Ground - Consultant Greg Bruce reported on the following:

- They held the meeting with lenders and there are no guidelines to prevent the lending process in the COU area. There is nothing to prohibit underwriting in the Project New Ground area. The only action is in the flood zone areas. It is encouraging with HUD and FHA. FHA will come and talk with lenders on the process so that everyone is updated on this.
- There will be a TAG meeting before the end of September to discuss the outcomes and how to work together on the Property Record Cards.

Members had the following concerns and questions: In 2003 the litigation in the Ash site settlement stated that any one that received any funds had to sign a letter not to sue and the deed restriction would be on their Property Record Card. The question on how many properties were there and where they are was asked. This will be asked again to Attorney Nelson. Greg Bruce will also follow up on this. They also wanted to know about the closed door meeting with the lenders. The meetings are not closed door but they do not invite the public. They are working meetings and will then bring this information back to the larger community. Members still had concerns on the Property Record Cards in the Project New Ground area and JEDCs oversight. **Recreation and Community Services –** Vanessa Price gave a Florida Recreation Development Assistance Program (FRDAP) presentation on a grant for the Julius Guinyard Park and Pool and reported on the following monthly updates:

- The Summer Night Lights Program had a reported 17, 330 visitors to 5 sites with no incidences and the overall crime reduction in the program hours were 28%.
- They have a new after school program M3 Zone Motivating, Maximum, Movement getting children moving about.

Grant Application Presentation for a FRDAP application: The Julius Guinyard Park is located off Jefferson Street. The FRDAP helps local governments to get land or outdoor recreation with matching grants. They plan to do pool renovations, resurface the basketball courts, new playground equipment for various age groups, as well as ball field renovations. Install a walking path around the park and make the ADA requirements. If selected the grant would start in the next fiscal year. Members commented that this would be a wonderful improvement for the Urban Core with money well spent. Member Radlinski made a Motion to write a letter in support for the Julius Guinyard Park and Pool FRDAP (Florida Recreation Development Assistance Program) Grant. A second was made by Member LaMountain. Discussion: Members wanted to know if there are any other projects being considered for grants in the Urban Core other than the Julius Guinyard Park and Pool. Ms. Price would have to check with Daryl Joseph and report back. A few months ago the Urban Core CPAC had written a letter of support for the S-line Grant. What is the status of that grant? The grant application was submitted and they have not heard back yet. Members also wanted to know if the amount of the project exceeds the amount being requested in the grant. Where would the money come from? Currently construction costs have been really good right now. The amount being requested is \$400,000. The identified budget is \$900,000 which includes the match. If the \$400,000 is approved it would offset the costs of the project. The Vote: All in Favor; none opposed. The Motion carries unanimously. Members did ask if this property was in the Project New Ground Ash Remediation site. It is and the property is scheduled to be cleaned up in November. Members would like to see if the Ash Remediation and the Julius Guinyard Park renovations could be timed together so the park would not have to be out of service twice. Member Chance made a Motion for the CPAC to recommend having any funds being expended to be delayed until the project can be done jointly to save money. A proper second wad made. Discussion on efficiency and keeping the park open so it will not have to be closed twice was made. Members want to be sure that they will not waste money and impact the lives of the people that live in this area twice. Since the Project New Ground representative had left the Motion was tabled to next month so they can check on the clean up schedule. They would like to invite the TAG Team to the next meeting. 
• Mr. Partlow spoke that he has been attending the Urban Core CPAC meetings for a number of years. He is from Durkeeville, Mid-Westside. The Issue of lead and ash went to Springfield lawyers and this shows the disparity of what happens in more affluent neighborhoods. It disturbs him that there Is no balance. Members asked him what can the CPAC do to get Durkeeville residents to come out in volume and speak up on this issue. Voices that were speaking to the powers that be didn't want to hear and they were speaking upon the deaf. They got tired of beating a deaf person and there is no satisfaction and hope dies. Just like the elderly gentleman that cam to the meeting a few months ago asking for help to get his property cleaned before he dies. This is a serious matter. Chair Vanderlaan said that at the June meeting that he should have researched this before he became chair. It impacted other neighborhoods and he regrets that the solutions that have been proposed with the Property Record Card and the new litigation class action suit are for anybody from any neighborhood with the exception of those involved with the past litigation. There have been inequities.




