# 1. Call to Order/Verify Quorum

• Chair Hill called the meeting to order at 6:30 p.m.

# 2. Approval of the Previous Meeting Summary

• Chair Hill inquired if everyone had the opportunity to read the meeting summary and if there were any corrections, deletions or additions; there were none. George Banks made a motion to approve the meeting summary and Gloria Stephens seconded the motion. The July 2013 meeting minutes were approved unanimously.

# 3. Staff Reports

- JSO (Jacksonville Sheriff's Office) Officer Dingler informed the group that he is a patrol officer in this section of Zone 3 and h is very familiar with the area. It was noted that in Zone 3 traffic fatalities are still a serious concern for JSO. Year to date citywide, there have been 87 traffic fatalities and 34 of them occurred in Zone 3. The CPAC was reminded to wear their seatbelts, be alert to their surroundings and enjoy their time behind the wheel. There were a couple of questions: *How are the red light cameras doing?* The red light cameras are generating so many tickets, that an additional officer was added to review the violations. *Can you pull someone over if you see them texting?* No, it is illegal to search a phone at this time. There must be a moving violation in order to pull someone over; then you can write the ticket in addition to the moving violation. *Can you provide an update on the incident that occurred at the Best Buy on Southside Blvd. on Friday night?* No, because it is an open investigation. *Are you aware that there have been a number of homes with the front door kicked in on Parental Home Road?* No, not aware of a spike, but crime is up on Baymeadows Road.
  - Mayor's Liaison John Shellhorn

Mr. Shellhorn announced that in conjunction with Duval County Public Schools there in a new program called Green Champion Program. Most of the schools in the programs are elementary school. One elementary school in the district, Twin lakes Elementary did receive honorable mention. Also, Keep Jacksonville Beautiful annually recognizes organizations, businesses and school for the work to help keep Jacksonville Beautiful and the Florida Coastal School of Law did receive an award this year. There is a ceremony on October 11<sup>th</sup> at City Hall to present the group with their award. There will be an International Coastal Cleanup on Saturday, September 21<sup>st</sup> in this district the clean-up will begin at 9:00 am at County Dock Boat Ramp, 11964 Mandarin Road (next to Walter

Jones Memorial Park. On September 10<sup>th</sup> there will be a Community Resource and Career Fair coming to the Main Library from 9:00 am to Noon. Also on September 10<sup>th</sup>, IFAS will be offering a Fall Gardening Workshop from 10:00 – 1:00 pm at the Mandarin Garden Club for \$5.00 per person. The 27<sup>th</sup> Annual Flowering Tree sale will be held on Saturday, February 22, 2014 starting at 7:00 am; the location is TBD.

- FDOT (Florida Department of Transportation) Jim Green Mr. Green informed the group that FDOT has not started any new project and all the current FDOT projects are on schedule.

## • Neighborhoods Department:

#### o Housing and Community Development Division – Rosemary Wesolowski

Ms. Wesolowski informed the group that the bus trip is on for September 7<sup>th</sup> and the group will meet and depart from the Kings Avenue Parking Garage at 9:00 am. Also, it was announced that long time co-worker Marilyn Fenton Harmer has resigned from the City of Jacksonville. Marilyn will be missed by her 2 CPAC's, but now her duties will be split up between Mary Beth Ridderman and Rosemary Wesolowski. Currently, Rosemary is assigned to staff District 1, 2 and 3; as well as the JHCDC board.

## o Municipal Code Compliance Division - Robert Crawford

Mr. Crawford stated that we are in the middle of the growing season and this is keeping Code Compliance very busy. Currently, there are 4 officers and one Supervisor in District 3. Still busy with the growing season, but we are doing our best to keep up with all the concerns. **Planning & Development** – Aaron Glick no report, but available for questions.

## o Parks & Recreation – Pam Roman

Informed the group that all the District managers are in place and Sherry Wilson has been assigned to work with the SE District; Ms. Wilson will be introduced next month.

## 4. Presentations – Councilmember John Crescimbeni and Dave Browning from WastePro,

informed the group about the new automated collection system that will be implemented in most of the Southeast District.

Currently, there are 3 private trash collector and one area (the inner core of the city) that have their trash collected by the City of Jacksonville. The portion of the SE CPAC that has their trash collected by the City of Jacksonville will not be impacted by this new automated system.

In 2012, Republic Waste System (Southland Waste) started the automated collection system in Jacksonville throughout the Arlington, Beaches and North areas of town. Councilmember Crescimbeni informed the group that his neighborhood is in the area that started the automated collection system in 2012 and now feels that it is an improved system. From his experience of going through this conversion in 2012 Crescimbeni addressed the concern over the size of the trash cans and to educate the SE CPAC about the expanded recycling programs that accompanies the new automated system.

Crescimbeni brought an array of products that were formally considered trash, but now can be recycled. With the new system all plastics, Styrofoam, all metal pans and cans, all card board and all metal used in household products can be recycled. A complete list of products and magnetic schedule of days of trash collection and recycling should be delivered with the trash cans. If you did not receive this magnetic schedule please call 630-CITY to request. It was also requested that every try they system with the 96 gallon cans for 1 month before they request the smaller cans. You can start using your cans when you receive them and the automated trucks will be on the streets starting September 30<sup>th</sup>.

There were a fair amount of questions:

Can you recycle batteries, mirrors and light bulbs? No

Can you recycle empty motor oil containers? yes

What do we do with the old trash cans? Use them for yard waste or have Waster take them.

What about TV or refrigerator boxes? Yes, break them down and put them in the recycling bin.

Do we still need to call in bulk waste? Yes

What about yard waste? Nothing changes

What if the 64 gallon cans are still too big? WastePro has a list of handicapped individuals and they will be handled specially.

How many days do you have to swap out the cans at no charge? 60 days

**Chairs report** - Chair Hill informed the group that the SE CPAC will hold a free bus tour on Saturday, September 7<sup>th</sup> starting at 9:00 am at the Kings Avenue Parking Garage, 1003 Kings Ave, 32207. Complete details will be emailed and please pre-register.

## Subcommittee/Liaison Reports -

**LUZ** (Land Use and Zoning)/Governmental Affairs- Jim Hill, Subcommittee Chair Mr. Hill stated the LUZ subcommittee discussed a lot of applications; and made recommendations to send 3 letters: 1. to oppose a rezoning from RR to PUD 2013 -474 at 12567 Aladdin Road ~ 8.29 acre horse farm to 19 homes. The group voted unanimously to send the letter. 2. 2013-C017 Marina San Pablo to rezone from residential to CCG; the motion was to oppose this application ~ the CPAC voted unanimously to oppose the application. 3. 2013-429 6347 Philips Highway to rezone from Industrial Light to CCG2; after discussion the group voted 13 vs. 1 in favor to oppose this application.

## Beautification/Parks/Environment – Dick Cardell, Subcommittee Chair

Mr. Cardell informed the group that the issue with billboards (2013-493) has become a problem again. With help from SE CPAC member and Scenic Jacksonville member Pat Corrado, a resolution in opposition to this application was distributed. The group had a lively discussion on the topic and the CPAC voted 12 -1 with 2 members abstained from voting because they wanted more information on the ordinance and to read the ordinance before they would support the resolution that was presented. The CPAC chair handed over the gavel to the Vice Chair because he abstained from voting.

## Economic Development - Gloria Stephens, Subcommittee Chair

Ms. Stephens informed the group that Mayo Clinic was granted \$5 million in grants on Genome mapping and requires that the research must be conducted in Jacksonville. This is groundbreaking and will change cancer treatment. Standard Pacific just bought 109 acres of land on Beach Blvd. between Hodges and Kernan and they are scheduled to build up scale houses.

#### Education - George Banks

Mr. Banks stated that he spoke again to School Board Member, Ashley Smith Juarez and she stated that things went pretty well for the 1<sup>st</sup> week of school. If there is a problem with bus transportation in your neighborhood, please call 359-6200.

#### Membership - Kathleen Perera, Subcommittee Chair

Chair Hill informed the group that Kathleen Perera needs to step down as subcommittee chair and inquired if anyone would be interested in being the subcommittee chair.
