#### 1. Call to Order/Verify Quorum

• Chair Corrado called the meeting to order at 6:30p.m.

## 2. Approval of the Previous Meeting Summary

 Chair Corrado made a motion to accept with the change to the date on the final page. Jim Hill made the motion and Michael Lashbrook seconded the motion. The August meeting minutes were approved.

### 3. Staff Reports

- JSO (Jacksonville Sheriff's Office)
  - o Sqt. Brad Muirhead stated that he drives Sector G (this is the sector where the meeting is held) and things have been quiet since school year started. Sgt. Muirhead also informed the group that residential and commercial burglaries have dropped 15-20 % YTD, but vehicular burglaries have stayed the same. Most of the vehicles are unlocked with valuables left unattended. I pads, I pods, garage door openers and GPS systems are often taken. Please remember that with your garage door opener and your GPS (with your home address programed in) the bad guys have a direct map and entry into your home. There was a question on in regard to the loss of the Community Service Officers and how this would impact JSO and the community? Sgt. Muirhead stated that the Florida Highway Patrol (FHP) will have to respond to accidents on state roads (University Blvd., San Jose Blvd., Beach Blvd., J. Turner Butler, ...) and this could take a while for FHP to respond. Danny Becton also gave kudos to JSO for their prompt response to a burglary alarm going off at his business. There was also some discussion about the red light traffic camera's that are being installed. Sqt. Muirhead stated that the patrol officers do not dictate policy that City Council dictates all city policies. Thus, it was City Council that voted to have the traffic cameras. The company that is installing the cameras has selected 25 spots due to the number of accidents that occur at those locations. The price of the tickets for running a red light will be \$175 if caught by the camera and \$265 if a JSO officer pulls you over. JSO has put a video on YouTube about on this subject if you would like to watch it. It was determined that JSO does not determine the fine amounts, the fine amount is determined by the legislative branch. Member Dick Cardell stated that a neighbor was having problems with a child custody dispute and she contacted JSO and they responded very quickly; he and his neighbors were impressed with the quick response time. Lastly there was a question in regard to who sets the timing of the lines. JSO confirmed that Public Works, Signals and Lights Division are responsible for setting the times for the lights. If you are having a problem with a light, please call 630-CITY and report your concern.

- Neighborhoods Department:

o **Housing and Community Development Division** – Rosemary Wesolowski Ms. Wesolowski informed the group that Mayor Brown will be the guest speaker at the October CPAC meeting.

#### o Municipal Code Compliance Division - Robert Crawford

Mr. Crawford stated that in Zone 3 they have completed 1150 inspections since the last meeting. They have lost 3 positions, but they are doing their best to keep up with the demand. Mr. Crawford also stated that they have had a lot of luck working with the Vacant Registry in dealing with foreclosures. At this time the Vacant Registry will contact the owner of the property (bank) to maintain the property until it can be sold again. A copy of the Vacant Registry brochure will be emailed to the CPAC members.

## Planning & Development – Aaron Glick.

 Mr. Glick stated that the Planning and Development Department has notice an uptick in application filled with the city. Application fees are going up too: Residential AD's will be \$830, Commercial AD's will be \$890, Exceptions will be \$900 and Exceptions Residential will be \$985.

#### o Parks & Recreation - Jackie Gregson

 Ms. Gregson brought JaxParks Fall-Winter 2012 activity guides to the meeting. Ms. Gregson also informed the group about the JaxParks 6th Worldwide Day of Play, September 29, 2012

Noon - 3 p.m., at Woodstock Park and Edith Brown Ford Community Center, 2839 W. Beaver St., JaxParks, Jacksonville Jaguars and Wolfson Children's Hospital invite you to get outside and play with Nickelodeon-style games like slime and musical pies, and traditional challenges like relay races, tug of war, hoola hoops, putt-putt golf and more.

Community First Saturdays, a JAX Chamber initiative kicks off this Saturday, October 6th on the Northbank Riverwalk Downtown. We start at 9am behind the Times Union Center of the Performing Arts (Community West) with a Tai Chi class on the St Johns River. Fitness classes, bike valet, and bike tours are just some of the activities planned. JaxParks' 9th annual Art in the Park will be held in conjunction with this event from 10am to 4pm, featuring hands on arts and crafts activities for kids and families.

Along with the weekly Riverside Arts Market, Community First Saturdays simply adds to the multiple quality-of-life events on the Riverwalk October 6th including Filipino Pride Day at the Jacksonville Landing, the Pink Ribbon Symposium at the Hyatt, and the Marine Corps Half Marathon which runs through the Riverwalk.

There was a question to Ms. Gregson in regard to the status of a fishing dock at the 9A-Baymeadows Park. Ms. Gregson said she would follow up.

#### 4. Presentations -

Brian Pippen, JEA, Conservation and Efficiency Specialist, addressed the #1 way we consume electricity; that is heating and cooling our homes. A typical house hold spends 43% of their monthly bills on heating or cooling their homes. By controlling our thermostats we are controlling our expense. Heating and cooling systems in the United States together emits 150 million tons of carbon dioxide into the atmosphere each year adding to global climate changes. They also generate about 12% of the Nation's sulfur dioxide and 4% of the nitrogen oxide.

It was recommended that we need to take charge of our thermostats and there are 8 steps that we can do to help us regain control of our thermostats.

- A. First, it is recommended that we seal leaks in air ducts. As heating and cooling systems age, leaks can develop in the ducts. These leaks can contribute tremendously to your energy bill.
- **B. Install Energy Star Ceiling Fan(s)** to use while the air conditioner is running. By using the two together, you can raise your thermostat about 4 degrees and experience any reduction in comfort. Also, running an energy star rated ceiling fan 24/7 will typically only cost about \$6 per month.
- C. Set thermostats at 68 degrees and 55 degrees in the winter and 78 degrees in the summer. It is recommended that you set your thermostat at 68 degrees when you're home and at 55 degrees when you're in your cozy bed. For hot summers, set the thermostat for the air conditioner at 78 degrees or higher. Avoid placing a lamp or a TV set near the thermostat. For each degree above 78 degrees that you raise your thermostat you can expect to save 3%/degree.
- **D. Clean and replace filters in your heating furnace and air conditioner**. Filters should be changed monthly and can be purchased in bulk. This action can save you up to 5% of energy used.
- **E. Programmable Setback Thermostat.** Install an Energy Star programmable setback thermostat (also called clock thermostats) to reduce temperatures when you are away or at night. Setback thermostats will save up to 20% on your energy bill, and they are available for \$30-\$150 at hardware stores.
- **F. Dress Accordingly.** Instead of turning the heat up or the AC down, consider dressing to increase your comfort level; less layers in the summer, more layers in the winters.
- **G. Passive Cooling.** The most important way to reduce your cooling /heating bills is to use natural passive cooling. You can plant shade trees and install awning and blinds. Trees should be planted on the south and west side of your house. Open windows at night to cool your home and close them during the day to keep the heat out. Whole house fans help to cool the house too.
- **H. Look into Solar Powered Electricity.** Look into ways to harness the sun's energy especially for heating.

Mr. Pippen also reminded the group that they can contact JEA for a free Energy Audit and a free inside water audit. Call 665-6000 to schedule a free Energy Audit.

**Shirley Dasher, Creative Community Solutions** informed the group that Clearly Jacksonville wants to open up their electronic billboards for local/community PSA's, such as association meeting notices, education and school related messages, community emergency information to name a few. William Brinton, City Beautiful Jacksonville, shared his concern with traditional billboards, electronic billboards and outdoor advertising. Starting 25 years ago Mr. Brinton started his fight to end visual pollution and has successfully had 1000's of billboards removed from the Jacksonville area. Mr. Brinton also expressed his concern and opposition to the electronic billboards and using them for PSA services.

Chairs report - Chair Corrado announced that a nomination subcommittee has been formed;

George Banks, Ralph Hodges and Gamal Lyons are the subcommittee members. If you would like to make a nomination, please contact one of the members or Rosemary. The election will be held during the November 26<sup>th</sup> meeting.

As previously mentioned, the SE CPAC T.R.U.E. Commission member Gamal Lyons announced his resignation as T.R.U.E. Commission representative due to the conflict with his work schedule. At this time Danny Becton has volunteered to represent the SE CPAC at the T.R.U.E. Commission. John Waddell made a motion to nominate Mr. Becton and Jim Hill seconded the motion. The CPAC voted unanimously voted to nominate Danny Becton.

**Elected Officials Reports** – Council member Boyer clarified a few issues for the group:

Jacksonville Community Council Inc. (JCCI) has released a community survey called Jax2025. This is your chance to share your thoughts and ideas about Jacksonville's future and to have a part in the community effort to develop a vision for Jacksonville. Survey forms are available at the back table or the survey can be completed online at <a href="https://www.jax2025.org">www.jax2025.org</a>.

In response to JSO's presentation on the Red Light Camera's, JSO wrote the bill and requested the red light cameras and presented it to City Council and City Council did pass the bill; the red light cameras were not City Council's idea. The elimination of Community Service Officers is unfortunate, but overall JSO's budget went up. Even with this increase in budget, JSO had to make cuts to offset the increase in budget and the workman comp claims.

On behalf of At- Large Councilmember Lumb, Donna Barrow encouraged the CPAC members to serve on one of the City Council Boards and/or Commissions. Ms. Barrow left paperwork on the back table in regard to the various boards and commissions.

# Subcommittee/Liaison Reports -

**LUZ** (Land Use and Zoning)/Governmental Affairs- Jim Hill, Subcommittee Chair Mr. Hill stated the LUZ subcommittee discussed many issues, but there was only one motion made. The motion was made by Chair Corrado to send an Opposition Letter in regard to Administrative Deviation AD-12-58 1917 Hendricks Avenue. The notice of the requested application was received by the CPAC 2 days ago and the San Marco Preservation Society (SMPS) has not received their notice yet. The CPAC is asking for a deferral until SMPS has the opportunity to review the application. The motion was seconded by George Banks. The membership voted unanimously and an opposition letter will be sent.

**Beautification/Parks/Environment** – Dick Cardell, Subcommittee Chair Reminded the group that we need to keep our trees trimmed during wet weather. A small tree recent fell in the back yard and it was due to the root system inability to support the tree with all the rain we have received.

**Economic Development -** Gloria Stephens, Subcommittee Chair Not present

**Education –** George Banks and John Waddell, Subcommittee Co-Chairs Stated that they expect representation from the school board at future meetings. Member Becton reminded the group that due to redistricting there has been a new school board member/ district added within the SE CPAC district. The new area / member will represent a lot of the area south of JTB to the St. Johns County line. Deercreek will host a School Board Member Candidate Forum on October 24, 2012 from 6-7 pm in the Deercreek Community (in the Deercreek Clubhouse). For complete details send an email to
