<u>Call to Order</u> - Chair Solomon called the meeting to order at 6:10 p.m., established that a quorum was present, welcomed everyone and opened the meeting with the Pledge of Allegiance at the Legends Center, 5130 Soutel Drive, Jacksonville, FL 32208.

#### Approval of the Meeting Summary

A motion to approve the January 10, 2013 summary as written was made by Member Anthony and a second by Member Rounsville. The Vote: All in favor; none opposed.

#### **Presentations**

Duval County Extension/UF IFAS/City of Jacksonville Director Mike Sweat passed out the 2011 Annual Report and gave a PowerPoint presentation on the following:

- o The Extension Service has the following divisions: Agriculture/Horticulture, Family and Consumer Sciences and 4 H Youth Development
- The Duval County Cooperative Extension Service was established by the Smith-Lever Act. It started a
  cooperative effort and a land grant college (University of Florida (UF)) that serves that particular
  state.

- Training classes and certifications are available i.e. pest control and lawn care.
- There is help to start a community and small container garden.
- The Master Gardner Program trains certified Master Gardner's with over 1200 volunteers.
- The canning center continues to be open with volunteers to educate on food preservation. They charge \$7.50 per hour to use the facility. Cans are available for purchase. School groups can take tours and place popcorn in a can that is sealed to take home.
- They train homeowners on Florida Friendly Yards.
- The Family Consumer Division trains daycare workers. They have over 850 people on their mailing list to keep them up-to-date on certification classes.
- The Financial Management team does training on financial planning and partners with banks.
- They have an expanded food and nutrition program as well as food safety classes.
- The Office has a summer camp, 4H Enrichment Program and a Junior Master Gardner program. Members had questions on the following:
  - How do they get on the mailing list? They have over 6000 publications and numerous newsletters. To sign up for their newsletter call the main line at: 255-7450.
  - They also asked if there were classes on home gardening and community gardens. Yes, but first a location with the owner's permission must be identified then call the office to get assistance.
  - Members also asked about the Superfund sites and how to get soil testing. Call the Department of
    Health. The Extension Offices does test soil for the PH level in yards and gardens. When sampling a
    yard take samples from various locations in the yard and then let that dirt dry on newspapers then
    mix it all together and bring a pint size container to the Office to get tested.
  - Is Sevin Dust a good insecticide for worms? Yes, but the liquid Sevin Dust (teaspoon to 2 gallons of water) works well since it is put on by spraying. Also DiPel is an organic fertilizer and is deadly to worms.
  - What are the 4 Hs? Head, Heart, Health and Hands

Chair Solomon thanked Director Sweat for coming and asked members to take advantage of the services that the Extension Office offers. He said that Mary Puckett from his office had presented information on Urban Gardening which led to him starting his garden.

LISC Northwest Jacksonville EPIC Neighborhoods Community Quality-of-Life Plan presented by Paul Tutwiler. He was excited to be talking to the NW CPAC about pending changes. The EPIC program is sponsored by LISC (Local Initiatives Support Corporation). The Northwest Jacksonville Community Development Corporation started 10-years ago. EPIC is about empowering people and inspiring change. What does the community of the Northside want and how can they solve issues? The community needs to solve their own problems. There are many plans that have been done but the next step is real solutions with action. The Mayor is working with JCCI on the 2025 Plan. Members were invited to participate with that too. What can be done?

- Work with other non-profits building our own houses and buildings the community needs jobs and opportunities.
- Start new businesses the Beaver Street Incubator is there to help with this.
- At North Point they will have a barber and ladies shop and coffee shop with free Wi-Fi so that they can apply for jobs on line.
- Mr. Tutwiler stated that the destiny of the community lies with us! The police and the neighbors know who is selling drugs but a solid solution is needed not being at risk.
- Children need to graduate from high schools so they can have a future.
- The community needs to work with JSO and Municipal Code Enforcement. The community needs to know where the problems are and if there is a drug house maybe it can be bought and a new homeowner can come in to help the community. How many houses are lost to back taxes or heirs just leaving the house and not coming back into the community? Neighbors and family members need to pass it forward. They need to take care and do things responsibly.

Members had questions, concerns and appreciated Mr. Tutwiler for being real:

• They asked about rebuilding the neighborhood what effect does this have on taxes. Currently Florida has the homestead exemption of \$50,000 and when new homes come into a neighborhood the value of the homes increase. Taxes have decreased but we have fees.

- How did you determine where to work and build homes? It started in the 29<sup>th</sup> and Chase neighborhood and other areas that have asked for assistance with community partners. They decide together. The community needs to be a part of the decision and help install pride back into the neighborhood.
- Are you rehabilitating homes? Yes, they did work with the Housing Partnership with Paint the Town. Currently there is no funding for this. He has been talking with banks to see if it is feasible. There needs to be a way to restore vacant homes that are in foreclosure, abandoned or condemned.

- This past year set a record for being down 6% in crime all over the city.
- Zone 5 led the city by being down 15.1/2%

Please remain vigilant. Members had questions on the following:

• How is the number of officers on the street since the reduction in force to the department? The numbers on the street have not changed but officers were pulled from various other departments to man the streets and those areas have been affected. The Florida Highway Patrol is now handling accidents on State Roads. JSO used to handle any crash in the city. The biggest issue has been response time. They are also concerned with the number of officers on DROP and when they will retire. If retirement benefits change a large number of officers may retire earlier than what was expected.

Members expressed sincere appreciation for Zone 5 Officers and the service they give for the residents in the northwest. Chair Solomon thanked and appreciated Lt. Mahaffey and his officers. **FDOT** – Thomas Hill reported on the following:

- Dunn Avenue resurface from New Kings Road to I-295
- I-295 Resurfacing from north of Commonwealth Avenue to the Trout River bridge (6 miles) and should finish in the spring 2013.
- New Kings Road (US 1) Resurface from Borden Street to Edgewood Ave. and should finish in 2013 with lane closings and resurfacing.

#### Ongoing Projects:

- I-295 and Commonwealth Avenue resurface from I-10 to Beaver Street there will be closings from 7:30 p.m. to 5:30 a.m.
- Martin Luther King Jr. Parkway building a new interchange at 21st Street/Talleyrand Avenue. The Phoenix Avenue on-ramp will be closed until the project is finished in late 2013 early 2014.
- The Matthews Bridge will be closed for the entire weekend starting 7 p.m. Friday until Sunday. Follow-up:
  - The stop sign on Pickettville Road is not a FDOT road but has Mr. Hill has talked with the City of Jacksonville to address this.

The deadline is next Friday, Feb. 15. The foreclosure aid only applies to Florida borrowers who lost their home to foreclosure from Jan. 1, 2008 through Dec. 31, 2011 and suffered servicing abuse. Claims need to be filed immediately for consideration, and only properly completed forms will be accepted. The funds are part of a settlement Florida is receiving from a landmark, \$25 billion joint federal-state agreement with the nation's five largest mortgage servicers over foreclosure abuses and unacceptable nationwide mortgage servicing practices.
