<u>Call to Order</u> - Chair Solomon called the meeting to order at 6:03 p.m., established that a quorum was present, welcomed everyone and opened the meeting with the Pledge of Allegiance at the Legends Center, 5130 Soutel Drive, Jacksonville, FL 32208.

Approval of the Meeting Summary

A motion to approve the March 14, 2013 summary as written was made by Member Burgess and a second by Member Tompkins. The Vote: All in favor; none opposed. The Motion carries.

Presentations

Duval County Public Schools (DCPS) Superintendent Dr. Nikolai Vitti – gave an overview of what has been happening in the last 5 months since he was hired. He stated that there is an urgency to get things right for children. He is child centered and will make decisions about children. He believes that DCPS is a good system with pockets of great teachers, principals and schools. He wants DCPS to be uniform and consistent for all children to be exposed to excellence. Teachers do need more support. The Strategic Plan will focus on four areas (not in any order):

- 1. **Employ the Best Teachers and Principals** develop great educators/leaders in general. This is the core of reform and the teacher and the child are at the epicenter to what happens in the classroom.
- 2. Increase Academic Achievement for All Students the District needs to remove resources from the district to go to the classroom i.e. laptops, new hands on curriculum that is inquiry based. No more workbooks. The children need to have hands on to apply what they are learning. Teachers and administrators need to have more teacher training. He is negotiating with the Unions. He wants teachers to create lesson plans together and build capacity. Currently teachers are isolated. There needs to be more planning time to work collectively.
- 3. **Engage Family and Community Support** He has been engaging the community 7-days a week. That is why he attends so many events. He wants the community to know who he is. He is the model and the principals need to reach out at least two days a week. They will build a Parent Academy. Parents care about their child's education and want them to do better. The Academy's will be spread throughout the county and focus on the following:
 - a. Help parents navigate the system on who to call, how to read a transcript etc.
 - b. Empowering them to help their child advance and what they need to grow. How to reach them and fill out FASFA etc.
- 4. **Deliver High Quality Support for Schools**: All elementary schools will have full time art, music and P.E. They will fund the before school, after school and Saturday tutoring. Students will not be pulled out of resources if they are below in reading. The resources may be the inspiration for reading or self-esteem. Schools need to develop the whole child. They also need to be good citizens. Have effective and equitable use of resources each school will have the same number of administrators by the number of students which will also generate the number of teachers each school has. With the reduction of dollars from the district the money can be used for reducing class size with more teachers.

Members had questions and concerns on the following:

- I-CARE would like to see Direct Instruction (DI) for reading. What are your thoughts? There has been a
 debate on Whole Language and re-teaching the basics. We need to get back to the approach of
 learning phonics early on. We should not be waiting to have intervention but to know when a child
 does not know a letter or sound as they are learning.
- The Durkeeville Historical Society would like to see DCPS visit their museum. They just had 150 UNF students and 100 Downtown students visit. They have 100 years of Black history and members of the Negro League Baseball Players that occasional attend the museum. Dr. Vitti wanted to get President Washington's information to see what could be done.
- Members wanted to know if the students that are not in a college mode could get back into the
 trades mode to create a workforce. Dr. Vitti stated that 15 years ago there was a National/State
 push to have college bound programs. Our graduation requirements also push to make this happen.
 He would like to see trades as elective classes because the student needs to pass the required
 classes to get their high school diploma.
- Members wanted to know if neighborhood associations could use their neighborhood schools to hold their meetings at. There is also a problem with the dedicated magnets not being a neighborhood school like Stanton, James Weldon Johnson, Cookman that are not open to the neighborhood. This was suspended years ago. It was stated to come to a School Board meeting and voice your concern. If a meeting could take place during the time right after school and before security leaves that is a possibility. Dr. Vitti stated that next year he plans to organize the schools according to Feeder Patterns in relation to the High Schools. They were organized by clusters: elementary, middle and high schools. He can't see a day to get rid of dedicated magnets. Those students would end up going to private or charter schools and DCPS would lose money. Duval County Public School enrollment has dropped.
- Members stated that there is a high turnover rate of teachers in the challenged schools and these teachers are not prepared for the culture of the neighborhood and don't do well and are not successful. Dr. Vitti agreed that it is a challenge to keep our best teachers at tough schools. He stated that we need to have a culture of feeling valued. The principal needs to recognize their work. The school numbers are checked twice a year once in October and then again in February. Those numbers determine the amount of money the school will receive from the budget.
- Chair Solomon asked about our young people and how to get them involved with the government in action. Dr. Vitti stated that maybe this could take place with a Civics class and have the students come to a meeting as a field trip. Teachers need to see how it works too.

• The question of safety came up. Dr. Vitti stated that some policy and systems have been changed like every classroom door is to remain locked as well as all outside doors. All visitors must get a badge. He has allocated funds for security guards next school year. He also discovered that if an emergency were to occur there was no way to contact the District or JSO with radios. He invested in the purchase of radios for emergencies. Long term he would like to see better mental health services within our schools. People need to identify depression and kids crying out for help. He is not a proponent of teachers having guns.

Chair Solomon and NW CPAC members thanked Dr. Vitti for coming to speak and update them on Duval Schools.

City of Jacksonville Public Works John Pappas gave a PowerPoint presentation on the Better Jacksonville Plan Update. Members had questions and concerns on the following:

- Members would like to get a copy of the PowerPoint and the list of projects that were not funded. Mr. Pappas will send it to Neighborhood Coordinator Marilyn Fenton-Harmer to send to members.
- They would like to know what projects were funded from the NW Economic Development Trust Fund.
- Lincoln Villas North would like to know about Phase II. That project is moving forward. The bid for the contractor has gone out. The project should begin in May.
- Members wanted to know how roads got prioritized and went on the plan. They originated out of the plan from the TPO and City Council input.
- They wanted information on the dollars that were allocated for stormwater drainage and why do we have the stormwater fee? The fee pays for the maintenance and cleaning of the ditches and stormwater systems. The Stormwater Utility Program had \$6 million to repair faulted systems.
- On Myrtle Avenue going to 8th Street there are manhole covers that are out of line with the roadway they are almost potholes. Mr. Pappas will check on this.

Elected Officials Report - none present

Staff Reports

JSO Zone 5 – Lt. Mahaffay reported on the following:

- Crime is down 12% It has been going down for the last four/five years.
- Violent crime is down 2%. Violent crimes have been robberies to individuals.
- Please be aware of your surroundings. If something is out of place call JSO at the 630-0500 number. It is better to call and be safe.
- Property crime is down 14%. Property crimes have been thefts and burglaries to residents. Members had questions on the following:
 - What is happening with the case where a group injures a person walking? It appears to be a group of juveniles or young adults that are focusing on someone that is walking alone on Soutel Drive. There is a crime force task force that is working on this. If you see anything suspicious or out of the ordinary please call 630-0500.
 - Do you know anything about a new drug program? No, the Lt. was not familiar with that.
 - The numbers are looking better for crime this year, can this continue? The office is hopeful to match the numbers. For the past four/five years the numbers have been down in double digits which is very rare.

FDOI – Thomas Hill stated that there were no new updates on the on-going projects and the projects under construction were:

• Jones Road - Replacing the bridge over Six Mile Creek which should finish in the Fall of 2013

Lane Closures:

- I-295 and Commonwealth Ave. to Trout River Bridge for a resurfacing project ramps will be closed nightly
- MLK Parkway and 21st Street Interchange the Phoenix Avenue Southbound ramp will be closed until the project is finished in early 2014.

- There were questions on the Matthews Bridge and when it is open and closed on the weekends. While they were painting found that it needed some structural work. They completed that and are re-priming those areas. It is moving right along.
- Members wanted to say "Thank you" to FDOT on the Six Mile Creek Project that had a problem cutting the cable line. It was back on within a day.

<u>Parks and Recreation</u> – District Manager Sherry Wilson reported on the following:

- The new parks guide is available. Please take some back to your community to get the word out. They come out quarterly. It has information on summer camps, Summer Night Lights program and other exciting things.
- At the Mitchell Center they will be doing some renovations for ADA and parking. The plaza should look nicer too.
- At Carvill Park they will add a new swing set.
- The Summer Night Lights program will be expanding to 10 pools and will be open on Thursday nights from 7 p.m. to 11 p.m., Fridays 7 p.m. to midnight and Saturdays from 6 p.m. to midnight. It will take place from June 20 through August 10th. The hub sites are: Clanzel T. Brown, Emmett Reed Park, Johnny Walker/Grand Park and Kennedy Park. The partner sites are: Charles Clark Park and the Mitchell Center.

Members had questions/concerns on the following:

- Members asked Ms. Wilson what parks she was in charge of: She had part of District 5 and District 2 parks.
- They asked about the Mitchell Center and when the renovations will begin. They are trying to get a better teen program. Celebration Church has partnered for Summer Nights Lights for the summer program. Parks response: The renovation goal is to have all the items completed by June 20, however, a contractor has not been awarded yet. As soon a contractor receives the reward, we can get a schedule from them.
- There was a question about the center on Line Street. That is a partner site. They lease the site from the Parks Department and are to be self-funded and insured.
- At the Beverly Hills site this is a volunteer STEM program which has a City of Jacksonville employee there to staff the facility.
- Members thanked the Parks Department for the swings at Carvill Park.
- They wanted to know if Bethesda Park was available for rentals especially during the holidays. This was cut due to budget cuts on staff. Can centers be rented on holidays? Parks response: Yes, centers can be rented on a holiday if a staff member offers to work that day. We do not require our staff to work on certain observed holidays, so the approval of a rental on one of these days will be determined if we can find someone willing to come in and work on that day. Typically, if someone makes the request, we will send an email out to all employees eligible to work rentals. If no one accepts the rental within 3-5 days of the request, we will not take the reservation. (The 3-5 days may vary based the time frame between the request and the desired date).

<u>Project New Ground</u> (PNG) – The Hester Group's Sam Holman spoke about Project New Ground. About 56 years ago garbage was incinerated and it turned to ash. Back then the ash was used for fill dirt. People didn't know that the ash was contaminated. The EPA identified four locations: Brown's Dump, Lonnie Miller Park, 5th and Cleveland, Forest Street and a part of Springfield was added. The City of Jacksonville/Project New Ground is cleaning up these sites by removing two feet of the contaminated dirt and replacing it with clean dirt. Once complete the tag on the property will be corrected.

- 5th and Cleveland has currently remediated 73 out of 100
- Brown's Dump remediation started 3-25-13 and 8 properties are scheduled for remediation.
- Lonnie Miller remediation will begin around the middle of May.

- What do the yellow color signs mean? The yellow sign is for citing a nuisance, overgrown lot as well
 as a vacant and open structure. The red and white that say Do Not Enter are for Condemnations.
- How high does a fence around a pool have to be? It had to be 6 feet and secured.
- When will Lincoln Villas have a systematic inspection? In two or three months.
- Do the City of Jacksonville properties get cited? Yes.
- There is confusion on who maintains the city right-of-way and who is responsible to keep it up? The owner of a residential home has to maintain the property in front of their home. The City of Jacksonville's Public Works maintain the city right-of -way.
- Do owners of commercial properties maintain them? Yes, they are responsible for their up keep.
- Who maintains the alley ways? Both owners on either side of the alley are responsible.
