# Chairs Report

Dewey informed the group that the CPAC Chair meeting with the Mayor that was scheduled for June 29<sup>th</sup> was rescheduled to July 22<sup>nd</sup>. Again, Dewey extended an opportunity share any topics or concern that the group felt should be expressed to the Mayor.

## Approval of the Minutes

Motion to approve the June 14, 2010 meeting summary was made. The motion was properly seconded and approved by the group.

## **Speakers**

Quinton White, Jr., Ph.D., Professor of Biology and Marine Science, Executive Director, Marine Science Research Institute, Jacksonville University informed the group about the new Marine Science – Research Center that will be opening in August 2010 at JU. The new 2 story building is built to be "green" as possible the design and building location was also selected to ensure minimal impact on the land and the river. On the first floor of the building, there will be a lot of open space, showers, storage and drying space for wet gear and house components of the sailing program. On the second floor there will be classroom, research facilities, reading rooms and offices. Currently JU is working on a solar powered laboratory. The group also had a detailed discussion in regard to the current algae bloom and fish kill in the St. Johns River. There was also an in depth discussion about the BP oil spill and the impact that it can / will have on the Gulf of Mexico, the Florida Keys and the East coast of Florida.

Lex Waters, Program Manager Pre-College, Marine & Environmental Studies, Duval County Public Schools discussed his relationship with JU and how his work with the Duval Public Schools to get high school students involved in the field of marine science. Currently, high school students that are enrolled in the Advanced Placement Environment Science (A.P.E.S.) are involved in water testing on water quality. The testing does cover a fairly lengthy portion of the St. Johns River and involved high school students from the St. Johns Sound to the Matanzas Inlet. Terry Parker is one of the high schools that are apart of the A.P.E.S. program and encourage the marine sciences for post-high school studies.

# Subcommittee Reports

**PARKS & RECREATION** – Chair Dewey Marshall – no report, but noted that the budget cuts on park maintenance is obvious; most parks look like they could be mowed and trimmed.

**BEAUTIFICATION** – Chair Larry Belge – supported the Wonderwood Landscaping and stated that the landscaping enhanced the area.

**LAND USE & ZONING** – Chair Mike Anania – the subcommittee made a motion on the following items.

The LUZ Subcommittee made the following motions: <u>Support for rezoning 2010-0372 for St. Barnabas Anglican Church PUD.</u> The property is located on St. Johns Bluff Road. The CPAC supports the rezoning because:

- A church can contribute to the moral and social strength of the community.
- A church at this location is consistent with surrounding uses of land.

- A church at this location can be developed in a manner that is consistent with the Land Development Regulations.
- A church at this location will not be a nuisance or interfere with the rights of others.

**TRANSPORTATION** – Co-Chairs Roger Sharp and Richard Witzel – not present

**ENVIRONMENT** – Chair Lad Hawkins – informed the group that there will be a Community Conversation on the Health of the St. Johns River hosted by City Council President Jack Webb, in City Council Chambers on Thursday, July 15<sup>th</sup> ~ 3:00 – 6:00 p.m.

**T.R.U.E Commission** – Marcella Lowe – informed the group that the commission does not hold a meeting in July. Marcella did extend an invitation to all CPAC members to the University Park Library Community Room dedication to Gail Melton, on Friday, August 13 at 11:30 a.m.

**Craig Airport Advisory Committee** – Dave Evans – not a lot has happened at this time, the attorney has had a heart attack.

**Growth Management Visioning Plan** – Mike Anania – completed the final draft and submitted it to the consultant. At this time the Visioning committee is expecting to have the draft reviewed and returned to them sometime in August or September.

**Representative Lake Ray**- informed the group that a special session has been called in Tallahassee next week to consider introducing an amendment in regard to offshore drilling. Currently, there are laws in place for offshore drilling; more information is needed before the most effective decisions can be made. No one wants to underestimate the impact and significance the oil spill will have on the economy and environment, but we need to have a contingency plan in case the oil does reach Jacksonville. Besides the obvious impacts on nature and economy, the oil spill can greatly impact our ports which could add to our economic challenges. We are at a time where we should look at deepwater ports statewide and try to increase trade, jobs and technology; reinvest in an industry that has tremendous growth opportunities. The

current economic crunch has illustrated the current state structure is no longer working and we need to look at railroads, ports and other infrastructure improvements to develop a new state structure.

Councilman Bishop was in attendance and recognized.

# Staff Reports:

**JSO** – Scott Dingee, JSO informed the group that Lt. Jankowski has transferred. Crime is down overall by 29% and property crime is down by 15%, but auto burglaries have increased (due to the kids being out of school). JSO is also working to enforce curfew to minors and if you have a problem in your neighborhood, please call the non-emergency number. Again, please remember to keep your doors and cars locked at all times, keep valuable out of sight.

**FDOT** – Jim Green, informed the group that Dames Point Bridge rehab is causing lane closures; and will continue to cause lane closures through the fall. On the Arlington Expressway at Regency (near Sears) mast arm signal replacement continues and should be completed this summer. Cesery Road from the Arlington Expressway to Arlington Road will be repave and restriped that will include a center turn lane this summer. 9A and 295 still waiting on completing the re- signage because of the Federal Government Highway Administration is looking at the current signage and there seems to be a little with the older signs. The first portion of 295 was completed over 20 years ago and the signage requirements since then have change. This is a situation that is hoped to be resolved soon after it is proven to the Federal Government that the roads are safe.

Jacksonville Public Library – Marshelle Berry informed the group that a long time Arlington resident passed away and donated money to the Jacksonville Public Library to be used at the Regency Branch Library. The donor was an avid gardener and the library would like to add a memorial garden to the front of the library in her memory. At this time we are looking for volunteers to help create a plan for a memorial garden. CPAC member Lad Hawkins volunteered to help be on the planning committee.

1. That a cross access drive connect the property with the adjoining church to the south.


