# Call to Order/Verify Quorum

Chair Rosanne Vernon called the meeting to order at 7:00 p.m. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department. She wished everyone Happy Valentine's Day and invited everyone to have refreshments provided by the Chair, Vice Chair, Coordinator and Shirley Lowry. Chair Vernon acknowledged guests David Lowry and Peggy Meyers for helping arrange the surprise Valentine refreshment table. She reminded everyone to take a flower when they leave the meeting.

# **Approval of the Meeting Summary:**

The January summary was approved.

JSO Report: Sgt. Hensley, Zone 4, reported

- Lt. Charles Wall retired.
- Mike Eason is the new Zone 4 Lieutenant and he is willing to work with the community.
- JSO had a crimes meeting today. There is a rapid decline in crime.
- ShAdCo J-1 had a spike in the numbers of burglaries. Please lock doors, and windows. If you go out of town, call 630-0500 to arrange for a JSO Sheriff's Watch.
- Numerous car crashes occurred during the past last two days with no rain. There were multiple car crashes on I-295 and a motorcycle rider's death on SR 17.
- One abduction occurred when a mother left a four year old child in the car
  when she went into a convenience store and two men took the car with the
  baby still in it. When they discovered the child in the back seat, the men stopped
  and blew the horn and stayed with the baby until JSO arrived to arrest them. They
  admitted to car theft, but apologized profusely for taking the baby.
- An inquiry was made about the robbery at gun point of CPAC Member, The Village Salon, in Ortega area and a concern expressed about illegal sales of prescription drugs in the Ortega parking lot of recently relocated Park & King Drug Store now at Oxford and Corinthian, near The Village Salon. Officer Hensley said he was not aware of that incident. ShAdCo Alice Turknett reported that JSO has arranged a community meeting with businesses near the Village Salon.
- A concern was raised about access to accident reports in order to recover damages to COJ property. Landscaping along Argyle Forest Boulevard is frequently damaged or destroyed by vehicular accidents. Area residents who maintain the right of way are often unaware of the actual accident date, and have been unable to obtain police reports. It would be a savings if JSO would include the COJ property in their list of property damage and notify the COJ of the damage in a timely manner, so reimbursement could be obtained from the drivers' insurance company. Officer Hensley referred Mr. Martin to Ashley Leddy at the Zone 4 office, 573-3165.
- Chair Vernon thanked Sqt. Hensley for his report.

<u>Introductions and Acknowledgments:</u> Chair Vernon welcomed everyone to the meeting. She acknowledged Alberta Hipps and other guests by name and thanked them for attending.

• Presentation: Chair Vernon announced that Mary Beth Ridderman had scheduled a speaker from the Dalton Agency, representing Clear Channel, to present information about Animated Signs and Message Boards (Ordinance 2010-900). The speaker did not show up or call to reschedule. Chair Vernon introduced Tracey Arpen. Tracey Arpen presented a Power Point presentation discussing Ordinance 2010-900 and Restrictions for Electric Signs. A question and answer session followed. The CPAC Chair asked if the CPAC wanted to vote to support or oppose Ordinance 2010-900. A motion was made and seconded. The Chair was asked to read the resolution (she did). A brief discussion was held. The CPAC voted to oppose Ordinance 2010-900 in its present form, support the Planning Commission's two amendments to Ordinance Number 2010-900 that (1) prohibit scrolling signs, and (2) establish the hold time for a changing message board as 3 minutes rather than 8 seconds; support an amendment to Ordinance Number 2010-900 that would prohibit digital billboard faces and urge Mayor Peyton to veto Ordinance 2010-900 should these amendments not be incorporated into the
