- 1. The meeting was called to order at 4:00 p.m. by Chair Mike Getchell.
- 2. A quorum was verified by Mary Beth Ridderman, Coordinator, Housing and Neighborhoods Department.
- 3. Presentation No presentation was scheduled.

 - The port was awarded \$10 million Transportation Investment Generating Economic Recovery (TIGER) grant to construct a rail spur which will remove some traffic from Heckscher Drive.
 - Mayor Alvin Brown is hosting an Open House at City Hall on Dec. 16, 3 7 p.m. Everyone is invited.
 - Chair Getchell presented certificates of appreciation to members. In behalf of Mayor Alvin Brown, Chair Getchell and Mary Beth Ridderman presented certificates of appreciation to the Vice Chair, Charter Members and Subcommittee Chairs.
 - In behalf of Mayor Alvin Brown, Mary Beth Ridderman presented a framed certificate of appreciation and a book, <u>Just Miles from Downtown</u> to Chair Getchell.

8. Staff Reports

- A. JSO Lt. Powers reported:
 - Residential burglaries are sporadic in Zone 6 area. Some of the burglarized homes were unlocked. In other cases, criminals break windows for entry. Please call 630-0500 if you see suspicious activity.

• Several incidents of auto burglary occurred near Biscayne and I-295. Several of the autos were unlocked. Please lock your car. Report suspicious activity to 630-0500.

•A concern was raised by Jack Stuart, who reported a chop shop is still working at night in his neighborhood. He provided the address to Lt. Powers. Lt. Powers asked residents to call if they observe an unmarked tow-truck.

- C. City Council Member's Reports No representative. No Report.

- E. Florida Department of Transportation (FDOT) Richard Prindeville reported:

- At the last meeting, a question was raised about trash on the Dames Point Bridge. He found it that the trash was caused by an incident on the bridge. The trash has been removed.
- Expect lane closures on the Dames Point Bridge from 7:30 p.m. to 5:30 a.m.
- The Dames Point Bridge project is taking longer than anticipated. The project started as routine maintenance, but they found a host tension rod and shear locks needed to be replaced. The problem was identified in Summer, 2011, but the heat prevented the sections from being separated. Computer tests were done to determine the design. A specialized jacking procedure was devised. The shear locks are being machined and scheduled for reinstall in Spring 2012.
- New overhead signs are being installed on I-295 (9-A). A question was asked if I-295 will be called I-295 East and I-295 West. Mr. Prindeville said he will investigate and return with the answer.
- Ongoing bridge projects include Dames Point Bridge, Sisters Creek Bridge and the I-95 Bridge over the Nassau River.
- New construction has begun on US 301. The project, from Baldwin to Callahan will increase the road from two to four lanes. The project is scheduled for completion in 2015.
- F. Municipal Code Compliance Bruce Chauncey's absence was excused. Please report suspected code violations to 630-CITY (630-2489).
- G. Planning and Development Shakeeb Shariff reported:
 - 2011-C14 will not go forward. The applicant did not pay the fees.
- H. Recreation and Community Brian Burket reported:
 - Local businesses helped fund the lighted boat parade. Fifty one boats participated.
 - The Planning Department had a special guest last week. The Secretary of the Department of Environmental Protection visited to discuss how to promote parks in North Jacksonville.
 - It is a great time to visit Jacskonville's parks such as Betz Tiger Point Preserve, Cedar Point Preserve, and the trails from Cedar Point to Pumpkin Hill.
 - Sheffield Park construction should begin anytime. Phase I is scheduled to open in Spring, 2013.
 - Batting cages are being installed at Tom Marshall Park.
 - Next week, Mayor Alvin Brown will announce a list of new kayak launches to increase access to Jacksonville's waterways.
 - The First Coast Pool project is waiting for signatures.
