<u>Home Sweet Home</u>

How Jacksonville Area Legal Aid, Inc. was able to help

a neighbor through the City of Jacksonville Public Services Grant Program



Judy Smith* came to Jacksonville Area Legal Aid, Inc. (JALA) with a serious problem. Judy, a pregnant single mother with other minor children, was renting her home under the Section 8 program. After many years in the same unit, her landlord sold the property and Judy and her family had to find another unit to rent. They located a house in the same neighborhood and met the landlord. The landlord came to Judy's home in late February, inspected Judy's housekeeping, and agreed to rent Judy her house beginning April 1, when Judy had to vacate her old unit.

The landlord gave Judy the keys on March 7 so that Judy could let in workmen to get the unit ready to pass the Jacksonville Housing Authority inspection. The same day Judy paid a \$1200 security deposit to the landlord.

The house passed the Jacksonville Housing Authority's inspection on March 21, and Judy started moving into the unit on March 28, after meeting with the owner that morning. On the evening of March 28, the landlord abruptly changed his mind, said he would not sign a lease with Judy, and ordered her out of the house immediately, threatening to illegally change the locks on her. The landlord did not return Judy's \$1200 security deposit. (Continued on Page 4)



Judy then sought help from JALA. JALA attorney Don Freeman contacted the landlord's attorney and he agreed to tell his client not to illegally lock Judy out of the house. Mr. Freeman contacted the Section 8 Department at the Jacksonville Housing Authority, and they agreed to give Judy a new voucher immediately and to look at barring the landlord from future participation in Section 8. Mr. Freeman then defended an eviction action filed by the landlord. Judy found a new Section 8 home, and moved in on April 26. The eviction case was dropped, but Judy's security deposit was never returned. Mr. Freeman sued the landlord for damages as well as a return of Judy's deposit, going to trial in August. While JALA awaits the Court's decision from the trial, Judy and her family

are in their new unit, and remain on the Section 8 program.

Judy's life and that of her children is better today because of PSG funding. JALA is proud to be a part of the family of non-profit agencies using PSG funding to assist our friends and neighbors live happier and healthier lives.
