

PARK & CAMPGROUND RULES AND REGULATIONS

The City of Jacksonville manages Huguenot Memorial Park to provide users with a safe and enjoyable outing. Please read carefully and follow all rules, signs and directions of park staff. In order to protect the park and its users, management reserves the right to incorporate additional rules as needed. Violators may be required to leave immediately without refund of any payments made. Registered campers are held responsible for all members of their group and any visitors at all times. Huguenot Memorial Park is a recreational family campground in a natural beach setting affording views of the Fort George Inlet and the St. Johns River. Many natural hazards and inherently dangerous activities are possible. The City of Jacksonville and Huguenot Memorial Park cannot be held responsible for accidents, injuries, and damages that may occur. Minors under age 18 must have adult supervision at all times.

GENERAL INFORMATION: Campers must provide a valid driver's license and be 18 years of age or older to reserve a campsite. Campsites are reserved for camping and will not be available for day use or fishing without camping in an authorized camping unit. Two vehicles are permitted per site in addition to the sleeping unit at no extra charge. Overflow parking areas are available behind the campground store. For additional passes above two per site there is a \$3 charge per pass. The speed limit in the campground is 5 MPH.

Extensions/renewals are due by 11 a.m. Continued late payments may result in eviction. Check-out time is noon. Prepaid reservation check-in is 1 to 9:30 p.m. **No check in after 9:30 p.m. without prior approval from the front office.** Office is open 8 a.m. to 7:30 p.m. on season and 8 a.m. to 5:30 p.m. off season. Quiet hours are from 10 p.m. to 7 a.m. **Generators must be turned off during quiet hours.**

Visitors: All visitors must pre-register at the office and leave the park by 10 p.m.

Refuse (trash): Please deposit refuse in the dumpsters located in the campground. Children and guests under age 18 shall be confined to their campsite and under adult supervision after 10 p.m.

The last re-entry by campers into the park is 11 p.m. The gates will be locked at 11 p.m. and the next re-entry will be 8 a.m.

RESERVATIONS: Advanced reservations may be made in person or by telephone. Payment may be made by cash, traveler's check, money order, cashier's check, MasterCard or Visa. NO OUT-OF-STATE PERSONAL CHECKS ACCEPTED. Phone reservations can be made Monday through Friday, 9 a.m. to 5 p.m.

LENGTH OF STAY: Maximum 15 days within a 45-day period.

REGISTRATION: Maximum total occupants per site are six, of which only four can be age 18 or older. All payments are final. No refunds for any reason. Each campsite must have at least one adult 21 or older if there is anyone under the age of 18 camping.

CANCELLATION OF REGISTRATION: In the event of cancellation, one night's payment including tax will be charged. There is a one-time opportunity to reschedule a reservation without a loss of payment, if the reservation office is contacted before 5 p.m. four days in advance of the day of the reservation. The reservation must be moved at that time to a new available date within a three month period from the original date.

OCCUPANCY LIMITATIONS: Maximum of four adult campers age 18 or over per campsite allowed. Maximum persons per campsite are six. Campsite occupancy is limited to one of the following groups or camping rigs:

- One motor home, one tent and two vehicles allowed per site.
- One trailer with pull vehicle, one tent, and one additional vehicle allowed per site.
- Two tents and two vehicles

All items must fit on campsite. Surplus vehicles must park in overflow parking areas only, never on vacant sites.

TENT: Must be of commercial manufacture and flame retardant material with integral floor. No more than two tents per site. Tents must be set up by 6 p.m.. Picnic tables and fire rings are not to be moved from site.

RV's: Must have outside connections for water and electricity and must contain a breaker box plus have fresh water tank. No sleeping in utility trailers. Portable toilets are not allowed. Only self-contained RV's are permitted.

OUTSIDE STRUCTURES: Equipment, appliances, tarps, clotheslines and hanging anything from trees are prohibited.

FIRES: Permitted in fire rings only. Please extinguish fires upon retiring or when leaving park. All fire wood must be fastener free. Pallets are not allowed as firewood because of the potential danger of nails/screws in boards.

NON-REGISTERED MOTORIZED VEHICLES: All motorized vehicles must be licensed for street use in Florida. No golf carts, motorbikes, scooters, go-carts, unlicensed dune buggies, or electric or battery powered vehicles allowed. Authorized mobility equipment for disabled persons must be properly permitted and documented.

SPEED LIMITS: The speed limit on the main (asphalt) road is 15 MPH. Speed limit in the campground and on all sand areas is 5 MPH. Performing doughnuts, power slides, rooster tails, reckless driving or excessive speeds is grounds for ejection without a refund.

SHELTER RENTALS: Shelters **must** be rented/permitted prior to use and are not for free use at anytime. To make a reservation, call 904-251-3335.

PETS: No more than two pets are permitted per site. All pets must be kept on a leash and properly licensed in accordance with City Ordinance. NO PETS ARE ALLOWED IN BUILDINGS. All pets must be kept under control, quiet, cleaned up after, kept inside at night and not tied to trees. No pets may be left unattended. **Pets are not allowed on any shoreline in or out of vehicles. No pets are allowed by day use or camping visitors.** If a violation occurs, it is grounds for ejection without a refund.

ALCOHOLIC BEVERAGES, GLASS CONTAINERS & ILLEGAL NARCOTICS: All are prohibited in the park in accordance with City of Jacksonville Ordinances and State of Florida Statutes. Violators may be ejected from the park without a refund.

RV & CAR WASHING AND SOLICITING: These activities are not permitted. Vending or selling of goods or services is not permitted.

DUNE PROTECTION: No vehicles, foot traffic or pets permitted in the Dunes. First offense for dune encroachment will be ejection without a refund.

WILDLIFE PROTECTION: It is unlawful to disturb and/or harass any wildlife in the park. If assistance is needed with wildlife, contact the office at 904-251-3335. Seasonal and permanent closures of areas of the park will occur. It is the responsibility of the visitor to be aware of the rules and policies of the park and to obey posted signage.

FISHING LICENSES: Licenses are required for resident and non-resident saltwater fishing, in accordance with Florida Fish and Wildlife Conservation Commission laws.

NO FIREWORKS, SLINGSHOTS, PAINT, PELLET OR BB GUNS: are permitted on park premises.
