Introduction

On February 17, 2009, President Obama signed into law the American Recovery and Reinvestment Act of 2009 (ARRA), which authorized \$575 billion in new short-term Federal spending designed to stimulate the American economy. Patton Boggs LLP has continued its effort to provide real-time distribution and analysis of funding opportunities available through ARRA. On February 17, we released ***No Small Change - The Stimulus Package and its Impact***.

Now to help you track the rollout of the spending, we are releasing ***No Small Change Part II - Distribution of Federal Competitive, Discretionary and Formula Funding***. No Small Change Part II will summarize Federal competitive, discretionary and formula funding opportunities that have been authorized by the American Recovery and Reinvestment Act of 2009.

The purpose of the Recovery Act is to create and save jobs, jumpstart the U.S. economy and build the foundation for long-term economic growth. Funding opportunities exist in the areas of infrastructure, research, and employment assistance, among others. The package intends to provide funds that will:

- * Create a framework for clean, efficient, American energy
- * Transform our economy with science and technology
- * Modernize roads, bridges, transit and waterways
- * Overhaul education for the 21st Century
- * Dispense tax cuts to make work pay and create jobs
- * Expand access to healthcare and lower costs
- * Provide assistance to workers hurt by the economy
- * Save public sector jobs and protect vital services

Larry Summers, the Director of the National Economic Council, has expressed that in order for this package to succeed the funding must be "timely, targeted and temporary". Thus agencies are rolling out solicitations for applications in a rapid manner and calling for submissions to be returned in a short period of time. With this in mind ***No Small Change Part II*** will be updated on the Patton Boggs websites as new and modified information become available.

Teacher Quality Partnership Grants Program Recovery Act

The purposes of the Teacher Quality Partnership (TQP) Grants Program are to: Improve student achievement; improve the quality of new and prospective teachers by improving the preparation of prospective teachers and enhancing professional development activities for new teachers; hold teacher preparation programs at institutions of higher education (IHEs) accountable for preparing highly qualified teachers; and recruit highly qualified individuals, including minorities and individuals from other occupations, into the teaching force. Enhanced Geothermal Systems Demonstration
