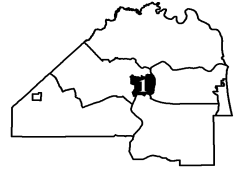

Call to Order

Chairman Williams called the meeting to order at 5:03 p.m. in the Ed Ball Building, Training Room 110 with a moment of silence and welcomed everyone.

Approval of the Minutes

Member Tippins made a motion to accept the minutes from the January 5, 2009 meeting. A second was made by Member Hartman. The Vote: All in favor; none opposed.

Guest Speaker

Office of General Counsel (OGC) Attorney Dylan Reingold presented "**Government in the Sunshine**" CPAC Training. The two areas covered in the training: The Public Records and Sunshine Law.

Public Records – Florida Statute Chapter 119 – Covers a broad base of areas such as the agenda, minutes, e-mails, tapes and videos. The records are made and received for public business. If it comes to the city it would be a public record. This would include information on CPAC subcommittees too. A document that is a draft is also a public document; it is just not the final copy. Notes that are taken at a committee meeting are public records. Quick notes just for yourself may or may not be considered a public record concerning the CPAC. OGC would decide on this. Anyone can request a public document and it does not have to be in writing. The person requesting to see or copy the document does not have to identify themselves. The copy has to be turned over in a "reasonable" amount of time.

Sunshine Law – Florida Statute Chapter 286 – Meetings need to be open to the public, noticed and minutes taken. What is a meeting? Two (2) or more members of the same body talking about what can fore see ably come before the group. You can talk to staff members but not another member or it is not in the “Sunshine.” This applies to subcommittee meeting records as well. The meetings need to be open to the public, noticed and minutes taken. The notice should be at least 48 hours or in an emergency 24 hours before the meeting, posted in City Hall and the building where the meeting is held. The location should be large enough to fit everyone. *Things to be cautious of:* casual gatherings and members running into other members; just don’t talk about what you could vote upon. Talk can be about football and the family etc. Do not circulate information to other members or get feedback. E-mails may satisfy a public records request but may violate the sunshine. *Phrases to watch out for:* Pull me aside after the meeting, I have an open door policy, come to my office etc. as well as whispering at or during meetings looks bad too. Cell phone calls to other members may also apply to the Sunshine Law. Don’t get into that either. There are fines to knowingly violating the Sunshine Law. The Office of General Counsel can answer questions. Members are all required to vote unless there is a conflict (A gain or loss to you or your family/organization would be a reason for a conflict). There are forms to fill out if you declare a conflict. Marilyn has them available to fill out. Members had questions on the following topics: Who is under the umbrella for the definition of a board, ad hoc committee etc.? On public documents – if a copy of a memo or an official letter that is sent to the CPAC would be part of the public record. Is it up to the city to provide a copy of the public record for a request? Project New Ground – Jim Manning, Environmental Engineer, Environmental Resource Management Department, Rachel Davis, Public Information Communications, Central Operations Department and Darrell Griffin, Affordable Housing Coordinator, Housing and Neighborhoods Department introduced themselves. Mr. Manning gave a brief history of the Ash Program. A hundred years ago the city incinerated garbage. It was not efficient but it did burn everything up. The ash was also used as fill material and distributed around the neighborhood as fill for land and used in flower beds. In the 1990s testing was done at Brown’s Dump and contaminants were found. The DEP became involved and it was turned over to the EPA. The two incinerated sites at Forest Street and Cleveland Street as well as Lonnie Miller and Brown’s Dump were tested. Testing samples have taken place since 2000. There are 2466 properties of which 1700 were sampled 1100 have shown some level of contamination and 766 still need to be tested. On July 17, 2008 the resolution was finalized by the Court. The Consent Decree solidified the method to clean up and procedures to follow. The technical crew has been hired: England, Thims & Miller. The solution the EPA states will take the top two feet of soil, remove it and replace it with clean soli. They may be starting construction at the end of October. It will take a 2 to 4 year timeframe. Darrell Griffin stated that he will be the Community Outreach with other city agencies. They have had face to face meetings with neighborhood associations, CPAC and other faith based groups. They will be starting a newsletter in March and if you would like to get a copy just let Marilyn Fenton-Harmer know your information. There will be neighborhood job fairs and community fairs for the neighborhoods beginning in March:

There will also be an office that will be staffed 5 days a week for residents to ask questions. They will need to get access agreements from each of the property owners to start the process of remediation. The agreements will be mailed out in February. The priorities will be children under the age of 6, residential property and then commercial or vacant land. Members had questions on following: When will the office open? They plan to open in March at the Hope VI Building at the Oaks of Durkeeville. Where is Brown's Dump off 33rd Street at the closed Mary M. Bethune Elementary School? What if a tree that is replaced dies a year later will it be replaced? It depends on the situation. What about under the house or driveway or will anything be on the deed? Each house will have its own plan and there will be a statement on the deed. What about the water table and if it should rise, this may cause recontamination? They haven't documented any movement with tests, it is not water soluble. Are children going to be tested again since they were done in 2000 and is it offered to all children in Jacksonville? The Department of Health offers free lead testing for children upon request. What about the bids? There are 11 pre-qualified companies that have been approved by the city and have not been bid out yet. What about seniors with property that may not have been tested? Tell them to come to the upcoming meetings or they will receive a letter with an access agreement to be tested. What about the air quality? No, the air does not come out of the soil – it is stable since it is beneath the surface. If residents have any questions they can call 630-CITY.

Florida Department of Transportation (FDOT) – Milton Locklear reported on the following from the January 5, 2009 meeting:

- Bike lanes on Main Street – there is a policy to put in bike lanes or sidewalks if the right-of-way is available but on Main Street the cost was prohibitive at this time. Members can contact the North Florida Transportation Planning Organization, Commuter Services Manager Elizabeth DeJesus at 306-7505 or edejesus@northfloridatpo.com to look at this again and buy the right-of-way.
- *The Hart Bridge Painting Project Manager is aware of the cars that were damaged in the past. Most work will be done at night and on the weekends. The contractors will be responsible and they learned a lot from the past.*
- *The pedestrian signal at 8th Street will be checked.*
- *The 45th Street JTA project is 30% finished and if we would like a project manager to talk about this project to please let him know.*
- *The DOT maintenance does clean the city right-of-way exit/entrance ramps every 4 to 6 weeks.*

Members had questions on the following: The left turn traffic signal at Davis Street and 8th Street only allows for 2 cars to make the left turn. This needs to be checked. There is a project for I-95 and 8th Street to have more capacity but it is 2 years away. The air pollution needs to be monitored at 2900 Benet Street. Planning and Development – Emery Nauden had no report and introduced Planner Kristen Reed. She went over the schedule for the Draft EAR (Evaluation and Appraisal Report) which has 252 recommendations which includes 8 elements. The assisted facilities received opposition has been withdrawn and is not in the EAR based amendments. They will revise the map after the 3 visioning plans are completed in June. Municipal Code Compliance – Zone 1 Supervisor Elaine Lancaster apologized for not being at the January meeting and reported on the following:

- They have been working in the following areas: East Union Street to East 8th Street to Haines Street to Hubbard Street, the West Mid-side neighborhood, and New Town (Is in Zone 5 and picks up on Myrtle Ave. and Kings Rd.) going north to 45th and Moncrief.
- They have been assisting JSO in 4 areas
- There numbers are high right now and will have the exact numbers next month since there were problems with the computer server.
- There are very active and going forward with the schedule to demolish 54 houses of which 32 are in the Urban Core.
- They attended the Sheriff's Walk in Longbranch and sited 67 properties in an 8 block area in the East 21st Street Neighborhood.

Follow-up from the January 5, 2009 Meeting from Jeff Beck

Marilyn Fenton-Harmer reported back on concerns on behalf of Jeff Beck, Chief of Right-of-Way Grounds and Maintenance, from issues at the January 5, 2009 UC CPAC meeting:

- What are the drums in Confederate Park? These are contaminated drill cuttings for subsurface soil sampling for disposal. Contact Jim Manning (381-8205) for more info. They should be removed shortly.
- Can we replace the crepe myrtles at 1469 Myrtle Ave that were hit? They have been replaced.
- Can we fix the "hole" by 1446 Myrtle? We will concrete the area by the end of Feb.
- The left turn signal at Davis/8th gives a very short time to turn left onto 8th from Davis – This timing is controlled by FDOT. We are at the maximum time they will allow. We are going to ask for a couple more seconds but the outlook is not promising.
- Lights are out at the entrance to JP Small Park – I entered a CARE issue (2009-53547) for Public Buildings Division to fix the lights.
- Hole at Spires/20th St – This is a JEA waterline repair that has not been patched. I sent an e-mail to JEA Dispatch asking that they complete the repair and patch as it is in a bad location in the intersection. As of yesterday it had not been patched yet.
- Banner arms – We are running a little behind on our repairs/removals. We are removing the lower banner arms where there are no banners and fixing the banners where they have come off the lower arms or the arms are missing. I expected to be done by the end of this week. It looks like we finish on 8th St and Main St some time next week. If there are some other locations that have been missed, please let him know.

He also mentioned the high rate of asthma in the Urban Core and the New England Journal of Medicine article. Jocelyn Turner, DOH mentioned that there is an asthma coalition that meets once a month.
