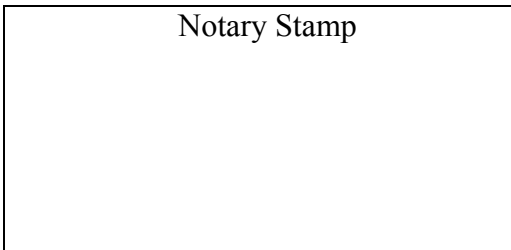

INSTRUCTIONS

- Please use affidavit form(s) provided by Animal Care and Control.
- Please be sure to include all information so as to allow us to issue citations under the law:
 - Date(s) **Must Have**
 - Complete description of the animal(s) (if known): breed, color, markings, size, sex, name.
 - Complete name(s) and address of the animal's owner.
 - Detailed statement of the alleged violations, including exact time; if producing a statement of a barking dog, indicate the start time and the end time.
- Be sure to sign the affidavit form **IN THE PRESENCE OF A NOTARY**. Notary service is usually available at Animal Care and Control.
- Mail or deliver the completed affidavit(s) to Animal Care and Control, 2580 W First St, Jacksonville, FL 32254. The Animal Care and Control center is located one block West of North McDuff Avenue on First Street. First Street is 1.3 miles North of I-10 on McDuff Avenue.

Please Note: If your affidavit(s) is not completely and specifically in accordance with the above instructions, it may not be sufficient to issue a citation. Please take special care to follow **ALL** instructions.

Enforcement of Affidavit

For the following violations, a citation may be issued on one affidavit from **two unrelated adult witnesses from different households** or on an officer witnessing the violation:

462.203

Cruelty to animals.

462.301

Failure to remove and dispose, immediately of fecal matter.

462.302

Allowing an animal to make objectionable noise continuously for a period of 30 minutes or more.

462.305

Permitting an animal to damage someone else's property or biting.

For the following violations, a citation may be issued on at least one sworn affidavit from **two unrelated adult witness from different households** or an officer witnessing the violation:

462.203

Deprivation of necessary sustenance.

Unnecessary beating or whipping.

Unnecessary riding, driving or working when sick and unfit to work.

Failure to provide proper food, drink, shelter or protection from the weather.

NOTE:

We need the complete animal owner's address including zip code on affidavit.
