### RE: Reporting: Boards and Commissions – Annual Reporting

The Joint Planning Committee (JPC) as an advisory body to the Duval County Public Schools (DCPS) and Cities is responsible for reviewing future growth patterns within the county; reviewing existing sites and identifying future sites and facilities for schools, parks, and libraries; considering future site-compatible community facilities; and reviewing the annual update of the Interlocal Agreement. Due to the JPC not meeting for two years, the committee's membership had to be renewed as many member appointments had expired. The Committee is now composed of nine members including three lay members appointed by the Superintendent, one lay member appointed from the DCPS School Board membership, two lay members appointed by the Mayor, one lay member from the City Council membership, one member appointed by the City Council President, and one lay member appointed jointly by the Mayor, City Council President, and Chair of DCPS. There are no vacancies; please see the membership roster attached.

The JPC is only required to meet twice a year however, due to a two year interruption and a mostly brand new membership, the committee has met eight times from November 2016 to present in order to move forward with its responsibilities. The JPC reviewed the Interlocal Agreement with an end goal of determining whether or not school concurrency, concurrency service areas and the student generation rates should be updated with the annual update of the Interlocal Agreement. For the present and upcoming year, the JPC is effectively practicing its duties and reviewing tasks in their purview. It is expected that the JPC as established will meet less frequently once the updates are complete.
