#### Subdivision Standards and Policy Advisory Committee Background

The Subdivision Standards and Policy Advisory Committee ("SSPAC") was established and created pursuant to section 654.142, Ord. Code. There are 10 members appointed to the SSPAC which includes a unique combination of city employees and volunteer citizens. A variety of stakeholders are represented, including the home-building industry, the engineering profession, the land developers, the land surveying profession and the Underground Utility contractor. The remaining members are the Chiefs of the Community Planning Division, Environmental Quality Division, JEA Director of Water and Wastewater, Right of Way and Stormwater Maintenance Division and the City of Jacksonville City Engineer who serves as the Chairman.

#### **Purpose**

The SSPAC's primary purpose is to set forth rules, standards and policies regarding issues relating to land development except traffic engineering and roadway design issues. The SSPAC accomplishes its purpose by reviewing, revising and approving changes to the City Standard Specification, City Standard Details and the Land Development Procedures Manual. The Land Development Procedures Manual is commonly referred to as the "Redbook."
