**SUBJECT:** 2018 Tree Commission Annual Report

Some of the Tree Commission's duties include acting as a coordinator for programs, projects, and activities related to planting projects and the health of the tree canopy between all public and private entities and to review expenditure proposals and plans for planting projects.

The Commission was established by City Council enactment of 2017-397-E on July 25, 2017. Meetings are held on the second and fourth Thursday of each month. The first meeting of the Tree Commission was held January 9, 2018. Since then the Commission has:

- Promulgated Administrative Procedures
- Established a webpage <a href="http://www.coj.net/departments/public-works/tree-commission">http://www.coj.net/departments/public-works/tree-commission</a> which defines the Tree Commission's duties in depth, lists each member with a biography and also contains all related documents, minutes, agendas for each meeting.
- Approved a Date Palm Resolution expressing an official position against the planting of Date Palms (<u>Phoenix dactylifera</u>) on public property within the City of Jacksonville or anywhere else using appropriations from the Tree Funds (15F and 15N).
- Established a Shade Tree Subcommittee to study the feasibility of revising the landscape code and ordinances to increase shade tree plantings.
- Reviewed Budget Balances of Funds 15F and 15N (at each meeting).
- Amended the Countywide Tree Planting contract to include a two year warranty as well as irrigation provision if requested by staff.
- Constructed an interface between Design Engineer Consultants, the City's GIS and Plan-it GEO where our GIS will be the tree maintenance database and Plan-it GEO will function as Tree planning database. The data will flow between all parties to monitor and maintain Jacksonville's tree canopy.

- Reviewed six planting projects; two are currently submitted for legislation, two have been completed and two
  are currently in progress.
- The Commission is currently finalizing the application processes for not-for-profit organizations as well as citizen groups who wish to submit requests for funding for tree planting projects.
- There is currently a vacancy on the Commission.
