15	Be It Enacted by the Legislature of the State of Florida:
16	Section 1. Chapter 2014-70, Laws of Florida is amended
17	to read:
18	327.37 Water skis, parasails, aquaplanes, kite boarding, kite
19	surfing, and moored ballooning regulated
20	(6) A person may not engage in kite boarding or kite surfing
21	within an area that extends 1 mile in a direct line along the
22	centerline of an airport runway and that has a width measuring
23	one-half mile unless permitted under federal law; provided
24	however, this subparagraph shall not apply to kite boarding or
25	kite surfing activities occurring within Huguenot Memorial Park
26	in the City of Jacksonville.
27	Section 2. The legal description for Huguenot Memorial
28	Park, located at 10980 Heckscher Drive, Jacksonville, Florida
29	32226 is as follows:
30	Those accreted lands lying within Section 20 and unsurveyed
31	Section 17, Township 1 South, Range 29 East, Duval County,

1	Florida, southeasterly of Fort George Inlet, and northerly
2	of and adjacent to the northerly line of those lands
3	described in Board of Trustees of the Internal Improvement
4	Trust Fund Deed No. 18,471 as recorded in Deed Book 817,
5	Page 308, Public Records of Duval County, Florida, said
6	northerly line being described as follows:
7	Commence at the Northwest corner of said Section 20, thence
8	South 0°47'31" East along the westerly line of said Section
9	20 a distance of 2396.6 feet; thence North 89°12'29" East a
10	distance of 2,439 feet to a point on the axis of the North
11	Jetty, said point being the Point of Beginning of those
12	lands described in Deed Book 817, Page 308; thence North
13	17°20'09" East along the westerly line of said lands a
14	distance of 500.00 feet to the Northwest corner of said
15	lands and the POINT OF BEGINNING of said northerly line;
16	thence South 72°39'51" East along said northerly line a
17	distance of 6,450 feet to an angle point in the northerly
18	boundary of said lands and the POINT OF TERMINATION of the
19	herein described line.
20	And
21	That portion of Government Lots Seven (7) and Eight (8)
22	lying Southeasterly of Hecksher Drive (State Road No. 105)
23	and Easterly of Haulover Creek, Section 19, Township 1
24	South, Range 29 East, Jacksonville, Duval County, Florida,
25	excepting therefrom that portion of said Government Lot
26	Eight (8) deeded to the State of Florida and described as
27	Parcel No. 21 in deed recorded in the public records of
28	said County in Deed Book 1058, pages 113 through 117.
29	And
30	All that portion of the lands described and recorded in Eng
31	Form 1736 by the Department of the Army Lease Agreement,

1		Project No. DACW17-1-80-2, dated 1 June 1980. Excepting
2		therefrom all that portion lying northerly of the north
3		line of that 100 foot tract described and recorded in Deed
4		Book 527, page 349 of the current public records of Duval
5		County, Florida.
6		Section 3. This act shall take effect upon becoming a
7	law.
