For the following violations, a citation may be issued on one affidavit with video or photographs of the animals, or with two affidavits from two unrelated adult witnesses from different households, or on an officer witnessing the violation:

Cruelty to animals

462,301

Failure to remove and dispose, immediately of fecal matter

462,302

Allowing an animal to make objectionable noise continuously for a period of 30 minutes or more

462.303

Allowing an animal to be at-large

For the following violation, a citation may be issued on at least one sworn affidavit from one adult witness or an officer witnessing the violation:

462.305

Permitting an animal to damage someone else's property or biting.
