Call to Order

Dr. Janetta Norman, CPAC Chairperson, called the meeting to order at 5:06 PM at FCCJ Urban resource Center Rm 411, 501 W. State Street

Approval of the Meeting Summary

Guest Speaker

Bill David, program manager, Jacksonville Human Rights Commission (JHRC), presented information about JHRC and Study Circles: He stated that this is an initiative of the JHRC, supported by a grant from the Jessie Ball DuPont Fund. Mayor Peyton is currently a Study Circles participant, and whole-heartedly supports the organization's initiative. He also stated that hundreds of Jacksonville residents have participated in the process and are beginning to make noticeable differences in their communities in Jacksonville.

Announcements

Dr. Janetta Norman, chair, raised concerns about the negative images of the Urban Core portrayed by the media. She said that most often the media only depicts stereotypical imagery, and when areas such as Springfield, Downtown or the Eastside are mentioned, they are not identified as Urban Core neighborhoods. She also reminded members about The Ninth Annual Mayor's Award. Our current nomination for the individual award is Pastor E. M. Johnson, and Grand Boulevard Neighborhood Association (Johnny and Deloris Swain) has been nominated for the neighborhood award. Floree Johnson-McPherson nominated Michael Bryant for the individual award. The deadline for submission of winners is July 31, 2004.

Michael Bryant, vice chair, stated that the Beaver Street Enterprise Center is available to persons seeking jobs or those desiring to start their own business. He also stated that the business incubator currently houses 16 tenants and has staff on hand to readily provide assistance. The center will celebrate its first anniversary on June 22, 2004 at 4:30 PM.

Staff Reports

Dr. Delphia Williams, Mayor's representative, director, community services, urged everyone to attend the Mayor's Town Hall Meeting, scheduled for June 21, 2004. She stated that City directors would accompany Mayor Peyton to address the concerns of Urban Core neighbors. The meeting will take place at LaVilla School of the Arts. She can be reached at 630-3632

Duval County School Board – Not present

Ken Avery, planning and development, notified everyone that a public hearing would be held for a parking lot project belonging to Fresh Ministries. He stated that current landscaping and buffering requirements could not be met. The hearing is scheduled for Friday, June 18, 2004.

Doris Leach, planning coordinator, reminded everyone about the upcoming Neighborhood Leadership Training Institute July 6-August 26 at Shands Twin Towers. It is requested that each neighborhood association sends three representatives through this year's program.

Frank Cunningham, code enforcement officer, reported that three unlicensed roofing and siding contractors were arrested for targeting elderly neighbors in the Urban Core. He said that doing business as an unlicensed contractor is only a misdemeanor, however, once elderly neighbors are targeted, the crime then becomes a felony. He urged anyone having knowledge of these predatory practices to contact JSO or Code Enforcement. He also reminded everyone that Code Enforcement is a complaint-based department. He stated that due to their enormous workload, officers are not able to randomly ride around and issue citations to properties. He encouraged neighbors to call 630-CITY to report possible code violations.

Ethel Griffin reported that 29th & Chase Community had a successful neighborhood cleanup event, with assistance from Duval County inmates, on June 5, 2004. She stated that although departments such as Clean It Up, Green It Up, and the Sheriff's Office were notified, the event did not receive sufficient coverage.
