1. Call to Order/Verify Quorum

Chair Rex Neidlinger called the meeting to order at 5:30 p.m. He welcomed all members and guests and acknowledged FSCJ North President Dr. Sandy Robinson. Mary Beth Ridderman verified a quorum.

2. Approval of the Previous Meeting Summary

A motion to approve the February summary was made by Dick Berry and Shauna Allen. The vote: All were in favor.

- **3. Elected Officials:** Duval County School Superintendent Nikolai Vitti and Duval County School Board Member Cheryl Grymes were present as the invited guest speakers (see below).
- **4. Presentation:** Duval County School Superintendent Nikolai Vitti and Duval County School Board Member Cheryl Grymes discussed recent boundary and program changes in area schools.
 - Recommended boundary changes to First Coast High School and Ribault High School.
 - Recommended changes to Oceanway and Highlands were rejected by the working group.
 - Raines and Ribault are at 60% occupancy. Both schools have strong alumni and neighborhood roots.
 - Jackson is no longer a neighborhood school. It will eventually convert to a 9th grade magnet school with Ribault and Raines as feeder schools. Jackson currently has a cyber program and offers dual enrollment at FSCJ. An opportunity exists to build an Information Technology "IT" program at Jackson. Next year the 9ths and 10th grades will be at Jackson. The 9th grade program will be phased in.
 - Schools are the largest employer in Jacksonville, with an operating budget larger than the City.
 - Funding is needed for capital improvements, including repairs, building maintenance and new schools (A back log exists of over \$100 million in major/minor maintenance.)
 - A resident expressed a concern: special magnet schools and programs may create an improper balance between groups that could lead to a class system. Superintendent Vitti explained that he believes in a diversification of schools.
 - A resident expressed a concern: magnet schools create a "Brain Drain" with the highest performing students often leaving neighborhood schools.

5. Staff Reports

- Mayor's Liaison E. Denise Lee said she was present to answer concerns and questions. She discussed:
 - o Mayor's Initiatives, which include LED lighting in neighborhoods with the highest crime rates.
 - o Mayor Curry is serious about neighborhoods.
 - He is working to change the CPAC Executive Order.
 - He will reorganize the Neighborhoods Department.
 - o More neighborhood associations are needed to combat crime.
 - o JFRD will begin outreach to install or service smoke detectors in neighborhoods. Ms. Lee commended JFRD Director Kurtis Wilson for his vision of assisting neighborhoods by installing or servicing smoke detectors.
 - o City departments such as Municipal Code Compliance, Housing and Community Development Division, Public Works and others will all be working in the same targeted areas to combat crime.
 - Residents were encouraged to report code violations and blight to 630-CITY by using the free city MYJAX app.
 - A member commended Municipal Code Compliance officers for their enforcement in the North district. The CPAC applauded.

 - o He will be attending North CPAC meetings.
 - o In Zone 6, the numbers increased for auto burglaries, home burglaries, and burglaries to homes under construction.

 - o The importance of installing and checking smoke detectors. More information will be forthcoming about the JFRD smoke detector installation program. Ms. Ridderman offered for Neighborhood Coordinators to assist JFRD by electronically distributing information about the smoke detector program or other JFRD programs.

 - o A question was raised about needed benches at Bert Maxwell Park. Mr. Rhodes said he will ask and get back to Mr. Bivens with the answer: Benches will be considered as a separate project after current bulkhead construction has been completed.

- Regulatory Compliance Municipal Code Compliance Division Tim Myers reported:
 - o Zone 6 officers completed 1,454 inspections in the past month. City wide, officers conducted 9,215 inspections.
 - A systematic inspection was completed within one week in Brentwood with 351 new cases and 1098 violations. Zone 6 received assistance from other officers. Brentwood needs an organization. (Brentwood is in the Northwest Planning District. The Neighborhood Coordinator was notified of the need to reform and organization.)

 - A concern was expressed: signal lights frequently malfunction at I-295 South and Heckscher Drive, creating safety issues when drivers become impatient and run the light. FDOT followed up by reporting the signal lights are the City's maintenance issue. A CARE issue was entered. Council Member Ferraro's office assisted to try to resolve the issue with Public Works.

2016-0096	Approved	The bill appropriates \$1,442,313.23 from the Drainage System Rehab capital improvements account to several drainage projects (Brierwood Road, Champlain Road, Corbett Street, Duval Station Road, Grant Avenue and Hobart Avenue) and re-appropriates \$518,686.77 in residual funds from the completed "Hamilton/Jersey Outfall to Roosevelt" project to the Sunnyside Outfall Replacement project.

Commission – shall sunset and be repealed as of September 30, 2016.
