• Petition for Rulemaking – JEPB Rule 4

Mr. Richardson shared that on February 22, 2017 the JEPB received a Petition for Rulemaking from Shannon Gregory on behalf of WRH Realty Services, Inc. The petition seeks a change to JEPB Rule 4.211 adding proposed language "A waiver may be granted on a case by case basis by the board allowing mechanical trash hauling hours to be extended to include the hours of 5am – 7am for property owners in locations where the hauling of trash is only feasible from a public area commonly used by pedestrians, cyclist and motorist such as a public street or sidewalk". Pursuant to JEPB Rule 1.202 the JEPB must take action on the petition within 30 days.

After brief discussion, a motion was made to accept the petition and open Rulemaking for JEPB Rule 4 at the April EPB meeting (Sonnenberg) properly seconded (Baker) and approved by the body.

• Resolution declaring April as Water Conservation Month

Mr. Richardson shared a request from the St. Johns River Water Management District (SJRWMD) regarding a resolution for April to be named as Water Conservation month.

After a brief discussion a motion was made to approve the resolution (Tappouni) properly seconded (DuPree) and approved by the body.

• JEPB Priorities - Discussion

Mr. Howland shared some of the discussion that took place during the retreat. Those present took some opportunity to update the priorities of the EPB. These will direct things like funding requests and other work of the board. He stated that if there were any other thoughts to share them with Mr. Richardson. There will be further discussion around the topic at future meetings. He also stated that there had been increased discussion

around the topic of artificial reefs. He asked that the EPO committee take the topic and research if there are any opportunities for the board to potentially sponsor a reef.
