Call to Order/Verify Quorum- Chair Salem called the April 2018 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

Approval of the Previous Meeting Summary – The March 2018 meeting summary was unanimously approved by the CPAC membership.

Presentation(s): Joseph “Maceo” George, University Park Civic Association President, spoke on litter in the Arlington Community. As part of his presentation, Mr. George shared his personal recommendations on various actions, laws and policies that should be implemented and/or enforced by the City of Jacksonville to reduce/eliminate litter in Arlington and the City of Jacksonville. Mr. George showed many pictures of litter throughout the Arlington area in a PowerPoint presentation. Mr. George encouraged the CPAC members to download the Blight App or the My Jax app as a tool(s) to report littering or blight that they see when out in the community.

Elected Officials Report:

Joyce Morgan, City Council District 1 provided the following updates:

- The next Council District 1 Town Hall Meeting will be held on April 23, 2018, at the Five Star Veterans Center, 40 Acme Street, 32211, 6-7pm. This town hall meeting will focus on small businesses.
- Arlington is focused on community clean-ups. Council Member Morgan is supporting the first Saturday of the Month Neighborhood Clean-ups in the Arlington area. If you would like to organize a clean-up and receive supplies, please contact the Clean it Up – Green it Up Coordinator, Dan Durbec at 255-8250.
- The Woodland Acres Boys and Girls Club / Kona Skate Park clean-up was held on March 23, 2018 and was a tremendous success. The clean-up focused on Century Street in Woodland Acres. After the clean-up Kona Skate Park hosted a fun-filled afternoon for the kids that participated in the clean. The owners of Kona Skate Park offered to host another clean up in the fall.

Carol Brock, City Council District 3 Aide provided the following updates:

- St. Vincent's Hospital will offer the At-Home Medical Mission again this year at the Prime Osborn Convention Center on Saturday, April 14, 2018. The purpose of the At-Home Medical Mission is to provide a wide range of medical services for those in without insurance that are in need of medical care.
- On Saturday, April 21, 2018 the Neighborhoods Department will host the Neighborhood and Community Summit at the Prime Osborn Convention Center from 8 am to 2 pm.

Staff Reports:

- **JSO (Jacksonville Sheriff's Office)** – Lieutenant Clement announced violent crime is down 9.55% in Zone 2. Property Crime is down 19% and robbery to business is up 2% YTD. At this time auto theft is the only major increase in crime throughout the district. Lt. Clement informed the CPAC that he participated in a Lieutenant's Walk today in the Crane Road area; no major incidents to report. The CPAC was reminded again to participate in the 9:00 pm JSO Routine; the 9:00 pm Routine is to make sure your car is locked with all valuables and weapons removed from the vehicles.

- **JFRD (Jacksonville Fire & Rescue Department)** – Frank Gillis stated that JFRD still has smoke detectors available to give away to those that do not have a working smoke detector. It was recommended to have a smoke detector in each bedroom, in or near the kitchen, in the living areas and in the garage. It was noted that there has been a sharp increase of residential fires due to faulty batteries in phones, tablets, laptops and golf carts.

- **Neighborhoods Department (Municipal Code Compliance)** – Elaine Lancaster stated that she is aware of the multiple violations at Eagle Point Apartments. There are currently over 100 violations in the Eagle Point Complex. Ms. Lancaster announced that there are currently 766 active cases in the GAB District; this is the lowest amount of violations in the GAB District since 2010. It was confirmed that code compliance is actively looking for illegally parked semi-trucks.

LUZ (Land Use and Zoning)/Governmental Affairs – Mike Anania announced the LUZ Subcommittee reviewed one application and no motions were made.

The goal of this subcommittee is to reach out to all areas of the GAB District to identify organizations, communities, associations to help get their voice heard and to get them active. Additionally, if an association needs to be formed, the subcommittee can assist with that. At this time, the subcommittee has a survey that they plan to send out to the community. It was also mentioned that through the Neighborhoods Subcommittee they are promoting that the First Saturday of the month to be a community clean-up day through-out the district. The projects need to occur on city owned property, cost at least \$100,000 and are expected to last at least five years. All recommendations should be submitted to Rosemary. The CPAC Chairs meet with Sam Moussa, Chief Administrative Officer on Friday, May 11, 2018. The plan is to meet with Mr. Moussa on a quarterly basis.
