**Call to Order/Verify Quorum-** Chair Salem called the February 2019 GAB CPAC meeting to order at 6:30 pm. Rosemary Wesolowski verified that a quorum was present.

**Approval of the Previous Meeting Summary –** The January 2018 meeting summary was approved by the CPAC.

**Presentation(s): Tim Rogers, Director, Jacksonville Public Library** introduced himself and provided a brief professional bio. Mr. Rogers shared the following facts and statistics:

- Jacksonville Public Library (JPL) has provided more than 100 years of free and open to all lending.
- JPL has a main library, twenty branches citywide and one new branch in the planning phase.
- There are 840,000 library card holders, the libraries have approximately 3.1 million visitors anually and 4.7 million items are checked out annually.
- JPL offers GED/High School Diploma Prep, citizenship classes and has the largest adult literacy program in Florida.
- Demands for e-books increases each month by 50 %.

Mr. Rogers provided a brief description for a wide variety of programs and services that are available at various libraries throughout the city. JPL also has a number of services to meet the

special needs of those in our city. The special needs materials that JPL offers include: Florida Braille and Talking Book Library, Closed Caption and Described Movie Series, and the Video Relay system for those using American Sign Language. Mr. Rogers announced effective March 2, 2019 all JPL libraries JPL will expand their hours. All libraries will now be open Monday through Saturday; hours will vary for each location. All regional libraries will stay open until 9:00 pm Monday through Thursday. JPL hopes to expand the amount of libraries that are open on Sundays in fiscal year 2019/20. #### **Elected Officials Report:**

**Joyce Morgan, City Council District 1 –** thanked Mr. Tim Rogers for attending her January City Council District 1 Town Hall Meeting. Council Member Morgan will hold her next Town Hall meeting on Monday, February 25, 2019 at 6:00 pm at Seacoast Christian Academy (8057 Arlington Expressway, 32211). The next CRA Board meeting will be held on February 13, 2019 at 2:00 pm at City Hall, Second Floor Conference Room; the Arlington Zoning Overlay will be part of the discussion at this meeting.

**Aaron Bowman, City Council President, District 3 –** announced the Task Force on Safety and Crime Reduction Subcommittee Chairs will meet Friday, February 15th, 2019 at 9:00 A.M to discuss Task Force Subcommittees. The meeting will be held in the Lynwood Roberts Room located at 117 W. Duval St., 1st Floor, City Hall - St. James Building.

Last week, JEA put out artists' renderings of the three proposed JEA headquarters. All three artist renderings include a state-of-the-art office building, but none gave a price, saying it was a competitive secret. One developer would put the tower in the development planned for Lot J in the Sports Complex (in the parking lot of TIAA Stadium). Another would put it in the heart of Downtown next to the Duval County Courthouse. A third developer would locate the JEA offices next to the Kings Avenue parking garage in San Marco.

The Veterans Memorial Arena may soon have a new name. Pending city council approval, the arena will be known as the VyStar Veterans Memorial Arena.

U.S. Department of Transportation Secretary Elaine L. Chao made the formal announcement of a \$25 million grant to support the Bay Street Innovation Corridor and Urban Core Riverfront Revitalization projects in Jacksonville. The grant is to revitalize transportation and commerce in the heart of the city. The projects will bracket the downtown area, providing major improvements to Bay Street, from the Jacksonville Regional Transportation Center at LaVilla in the Downtown Core area to the Sports Complex. Through highway redevelopment, implementing an autonomous transit network, and introducing smart technologies, the projects will focus regenerative efforts on the riverside area around local business, sporting, and entertainment centers. Jacksonville was one of 91 grants selected from 851 eligible applications from all 50 states.

One of the CPAC members informed Council President Bowman that she emailed the principal of Alimacani Elementary School and the school board in regard to the traffic problems associated with student drop-off and pick-up. She did receive a reply and was informed that the school cannot expand their parking lot to try alieve traffic congestion and improve safety for the children attending the school. The principals' recommendation is to request the city to expand San Pablo Road to a four lane road. Council President Bowman stated there is a project in the works to expand San Pablo Road. In the near future, Council President Bowman will hold a town hall meeting to discuss the San Pablo Road project.

#### **Staff Reports:**

JSO (Jacksonville Sheriff's Office) – Lieutenant Valentine stated in the past 30 days in Zone 2 violent crime is down 20.67 % and property crime is down 17%; there was a slight uptick in residential burglaries. Lt. Valentine encouraged everyone to become involved with the Sheriff's Watch Program. JSO has a new website. The web address is <a href="www.JaxSheriff.org">www.JaxSheriff.org</a>. Lt. Valentine informed the CPAC that JSO is offering a Citizens Academy that will begin on March 21, 2019 for twelve weeks; applications for the Citizens Academy are due to JSO by February 15, 2019.

Jacksonville Public Library – Jackie Spiritis, provided the following updates:

- The 2019 Jacksonville Black History Calendars are available; they can be found in the lobby.
- Jacksonville's literary event of the year will return on Saturday, Feb. 23, 2019! The Jax Book Fest is back for its third year in a row. The event will be held at the Main Library in Downtown Jacksonville and will feature presentations and signings by authors of both national and local acclaim, book sales, children's activities and more. The event runs from 10 a.m. to 3 p.m. The featured author will be R.L. Stine.
- Early voting begins on March 4, 2019 and will be offered at most libraries; the Pablo Creek Regional Library is an early voting site.
- Jacksonville Public Library and the American Association of Retired Persons (AARP) Foundation partner each year to bring free tax preparation to the community. AARP Tax-Aide sites are serviced by IRS-certified volunteers that provide FREE tax counseling and preparation services to millions of low- and middle-income taxpayers, with special attention to those ages 60 and older. There is no income or age limit for assistance at AARP TaxAide sites; however, AARP sites cannot assist rental property owners or small business owners.

**JTA -** Cheryl Riddick stated she did not have a specific report for the CPAC, but stated JTA continues to operate the Mayport ferry, construct roadway and sidewalk projects throughout the city.

**Neighborhoods Department (Municipal Code Compliance Division) –** Thomas Register provided a report/newsletter that was emailed to all the CPAC members prior to the meeting. Mr. Register stated Municipal Code Compliance completed a systematic inspection in the Woodland Acres community and the Southside Estates Community. In the Woodland Acres Community, 439 inspections were completed which netted 635 violations. At the Southside Estates systematic inspection, 490 inspections were completed. Parks, Recreation and Community Services – Keith Meyerl provided the following updates:

- Announced the design phase to re-construct the board walk at Blue Cypress Park has been completed. The next phase will be the bid process and that will occur later this month. Construction should begin in May or June of this year.
- The splash pad at Abyss Park will be open on April 1, 2019.
- Huguenot Park will receive new curb and gutters along parks roads. New power posts will be installed to each of the campsites at Huguenot Park.
- Mayport Waterfront Park (4638 Ocean Street) will be renewed.

- Hanna Park dune restoration has been completed.
- The World of Nations will be held at Metro Park in February this year.

**Public Works –** Steve Long informed the CPAC that the Traffic Engineering Division in the Public Works Department has reviewed traffic accidents/crash data throughout the city. To improve safety, a number of mid-block cross walks are being installed. Call 630-CITY to report any roads that could benefit from the addition of a mid-block crosswalk. Mr. Long informed the CPAC a sidewalk will be installed on Monument Road from Lee Road onto Mill Cove. FDOT has plans to extend the side walk from Mill Cove to the Wal-Mart (at Kendall Town) on Monument Road and Tredinick Parkway.

### Subcommittee/Liaison Reports (3 minute time limit):

**LUZ (Land Use and Zoning)/Governmental Affairs –** Mike Anania announced the LUZ Subcommittee reviewed numerous applications and made two motions. The motions are:

**Deny of Administration Deviation AD-19-05** at 2393 University Boulevard. The following observations were made:

- The applicant requests relief from the fence structure height for 6' to 8'. The applicant also states that they will build a concrete fence structure to protect the property from "cars and pedestrians from entering the property".
- Granting the request will create a single lot anomaly in the neighborhood.
- The current fence is non-complaint and granting the request will condone a violation.

The CPAC voted unanimously to deny the application.

**Deny Rezoning 2019-067** at 0 Atlantic Blvd. RE# 167141-0900. The following observations were made:

- The GAB CPAC has heard testimony from the affected residents and the developer's representative on this request in 2018 and recommended denial of the request.
- The proposal to incorporate multi-family units or duplexes does not provide a logical transition of uses and intesnsity.
- The introduction of duplexes to a single-family neighborhood is not consistent with the owner-occupied single-family character of the surrounding area.
- The recent negotiated changes in the application are somewhat helpful in mitigating the conservation area concerns.
- The increase in units and height will have an adverse impact on the surrounding neighborhoods.
- The increase in dwellings will further exacerbate existing traffic/evacuation concerns on the surrounding neighborhood roadways.
- The proposal would have an adverse impact to property values of surrounding properties.

• The proposed development is not consistent with the surrounding properties in relation to density, intensity, lot size and type of units.

The CPAC voted unanimously to deny the application.

**Beautification/Parks** – Larry Belge stated due to our wet weather conditions we have experienced a lot of growth of molds, moss and fungi. Mr. Belge encouraged everyone to use bleach and/or pressure washers to clean their properties to protect their families and pets.
