## **Elected Officials Report:**

The Honorable Will Lahnen, City Council District 3, shared the following updates:

- Clarified the boundaries of new City Council District 3. San Pablo Road is now part of City Council District 13.
- Upgrades at Patton Park are expected to be completed by the end of January 2024. The upgrades include the installation of one of the biggest and most extensive playgrounds in Jacksonville.
- Council member Lahnen is actively working to get a community center to City Council District 3.
- The University of North Florida (UNF) entrance off Kernan Boulevard is part of a \$3 million-dollar shared use path project. A shared use path is a 10- to 12-foot-wide paved path that offers a variety of uses. The new path will begin at Kernan Boulevard and end at the

- entrance into the St. Johns Town Center. The project will be completed in three phases. Phase one will begin this year; the project should be completed over the next three years.
- FDOT is working on a pedestrian signaling improvement project at the intersection of Beach Boulevard and Hodges Boulevard. This project is expected to be completed by the end of the year.
- A large-scale FDOT project is underway at the intersection of J. Turner Butler Boulevard (S.R. 202) and Kernan Boulevard. This \$17 million-dollar single cloverleaf interchange project should be completed in late 2024.
- Tomorrow night, the City Council will vote on the \$25 million-dollar Mayor Deegan has requested for various projects throughout the city.

  recently purchased and is scheduled for demolition to build a car wash. Dozens of
  supporters have turned out to Council Land Use and Zoning Committee meeting on
  December 5, 2023.
