The City of Jacksonville Small & Emerging Business Program


he goals of the City of Jacksonville Small & Emerging Business Program are to ensure compliance on city projects, promote economic development by offering technical & educational assistance, and encourage cooperative communication amongst various local agencies & establishing a strong JSEB support presence in the business community.

The JSEB Program is available to small businesses who have an established business headquartered in Jacksonville for three or more years and/or have resided in Duval County for at least one year.


The qualifying owner's personal net worth may not exceed \$605,000. The business must have a three-year gross receipts average of less than \$6,000,000 for the preceding 3 year period of application.

The qualifying owner must maintain 51% ownership of the business for a minimum of one year.

The above chart shows the amount of new JSEB applications & re-certification applications that were processed and approved by the JSEB office in FY '15. Average Days to Process # represents the # of days after the receipt of a complete application. The total New JSEB Applications processed in FY '15 was 81. The total Re-Certification Applications processed in FY '15 was 211.

What is Section 3?

ection 3 of the Housing & Urban Development Act of 1968 ensures that employment and other economic opportunities generated by certain HUD financial assistance shall, to the greatest extent feasible, be directed to low and very-low income individuals, especially recipients of government assistance for housing, and to business concerns that provide economic opportunities to low and very-low income individuals.


A Section 3 Business is one that is either owned by Section 3 residents, employs Section 3 residents as permanent, full-time employees or subcontracts with businesses that provide opportunities to low and very-low income persons.

As a certified Section 3 Contractor, a small business would be provided with valuable information on contracting opportunities over \$100,000 available through the Community Development Block Grant (CDBG), the Home Investment Partnership Program (HOME) and the Neighborhoods Stabilization Program (NSP).

The JSEB Office performs all the Section 3 business recruiting, certifying and re-certifying for the Section 3 program. HUD monitors the performance of recipients and contractors within the Section 3 program, awards contracts to Section 3 businesses and provides technical assistance to recipients and contractors in order obtain compliance with Section 3 requirements.

During FY '15 the JSEB Office processed 37 New Section 3 Applications.


