

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application $\underline{\text{L-5876-23C}}$ was filed on $\underline{\text{February 21, 2024}}$, as $\underline{\text{Ordinance 2024-144}}$.

The subject site is approximately <u>5.29 acres</u> and is located with an address of <u>12636 Ivylena Road and 12640</u> Ivylena Road, between Girvin Road and Southern Rose Drive.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Medium Density Residential (MDR)</u> and <u>Conservation (CSV)</u>. Plan category descriptions can be found on the Planning and Development Department website.
