



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5876-23C was filed on February 21, 2024, as Ordinance 2024-144.

The subject site is approximately 5.29 acres and is located with an address of 12636 Ivylena Road and 12640 Ivylena Road, between Girvin Road and Southern Rose Drive.

The current land use category is Low Density Residential (LDR). The proposed land use category is Medium Density Residential (MDR) and Conservation (CSV). Plan category descriptions can be found on the Planning and Development Department website.
