

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5899-23C</u> was filed on <u>February 21, 2024</u>, as <u>Ordinance</u> <u>2024-146</u>.

The subject site is approximately <u>1.80 acres</u> and is located with an address of <u>7850 Cranbrooke Road</u>, <u>between Garden Street and Cranbrooke Road</u>.

The current land use category is <u>Agriculture (AGR)</u>. The proposed land use category is <u>Low Density</u> <u>Residential (LDR)</u>. Plan category descriptions can be found on the Planning and Development Department website.
