

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5904-24C</u> was filed on <u>March 20, 2024</u>, as <u>Ordinance</u> <u>2024-223</u>.

The subject site is approximately <u>15.72 acres</u> and is located with an address of <u>0 Beaver Street West</u>, <u>between Otis Road and U.S. Highway 301 North</u>.

The current land use category is <u>Community/General Commercial (CGC)</u>. The proposed land use categories are <u>Light Industrial (LI)</u> and <u>Recreation and Open Space (ROS)</u>. Plan category descriptions can be found on the Planning and Development Department website.
