



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5909-24C was filed on March 20, 2024, as Ordinance 2024-225.

The subject site is approximately 0.67 of an acre and is located with an address of 0 Clydo Road, between Rolac Road and Clydo Road.
