



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5926-24C was filed on April 17, 2024, as Ordinance 2024-310.

The subject site is approximately 1.85 acres and is located with an address of 5310 Philips Highway, between University Boulevard and Emerson Street.

The current land use category is Community/General Commercial (CGC). The proposed land use category is Light Industrial (LI). Plan category descriptions can be found on the Planning and Development Department website.
