Call to Order

Vice Chairperson Tippins called the meeting to order at 5:04 p.m. in Training Room 110, Ed Ball Building, 214 N. Hogan St. and welcomed everyone.

Approval of the Minutes

Member Swain made a made a Motion to accept the minutes from the November 3, 2008 meeting. A second was made by Member Walker. The Vote: All in favor; none opposed.

Guest Speakers

Digital TV Presentation - Carolyn Broughton, Public Information Administrator/Cable Franchise Mgr. introduced George Birnbaum, Operations Manager for WCWJ TV/DT -The CW 17 Cable 9 - the Frog Station, who discussed the switch to digital TV. . If someone needs assistance in accessing the coupons please call 630-CITY. Mr. Birnbaum explained that the digital transition has been occurring for the last 6 years but on Feb. 17 the analog viewing will be turned off forever. They do not want to lose viewers. The government is giving away two coupons per household address for \$40 each for a converter box. Converter boxes can range from \$50 to \$70 and can be purchased at many retail shops. However; the program has run out of money and there is now a waiting list for the \$40 coupon. The coupon had an expiration date on them and many were not used by the date. He showed members the box which comes with a remote control. It will have a quality picture and more channels. Members had numerous questions on the different channels, if it will work with battery operated TVs when the power is out. No it won't and neither will the small battery TVs. They asked if there were

- "Light Pole Banners" Jeff Beck, Chief of Right-of-Way Grounds and Maintenance talked about the light pole banner arms. They first had to decide who the responsible party was. In the past it was Traffic Engineering, JEA and now it's his Division Right-of-Way Grounds and Maintenance. They work with the Special Events Division that hangs the banners. They decided to take the lower arm off the pole. This will give them inventory to repair or fix other broken arms. Members had numerous questions for Mr. Beck on the following: Member Vanderlaan thanked Mr. Beck for coming to the meeting. He wanted to know when the banner arms in Springfield would be addressed. He explained that as a tax payer he wanted to know how much money was spent on maintenance and now removing the banner arms. Mr. Beck said that in the next 30 days they plan to get to take down the lower banner arms and he did not know the cost. Member Vanderlaan wanted to know if the banner arms were defective in design and shouldn't be falling apart. Shouldn't the manufacturer take responsibility for this by covering the cost of the repairs with a warranty? He also wanted to know if they would be addressed in 6 months to see if the new hanging procedure for the banners worked and looked good. Mr. Beck explained that it was not so much defective but the opportunity for vandals pulling on the banners lower arms and they are hit by trucks. Other members had questions on if other light poles could have banners. Mr. Beck suggested they call Special Events to see where the banners could be placed. JEA will not let you put banners on concrete poles.
 - o In Confederate park there are 15 to 20 drums near Orange Street (dead ends Ocean and Noonan St.) that showed up a few years ago to do ground sampling that need to be removed. Mr. Beak will check on this.
 - o Member Swain reported that there was a water leak/cave in his neighborhood that has been left open for over a month. Mr. Beck would send JEA an e-mail.
 - o Member Miller reported that a car had hit some new trees that were planted on the city right-of-way at 1446 Myrtle Ave. and 15th Street. They have reported in CARE almost 6 months ago but are still waiting for something to be done. Mr. Beck will tell the Urban Forester to have 3 Crepe Myrtles replaced at 1469 N. Myrtle Ave.
 - o The front entrance lights at J. P. Smalls Park are out. It has been reported to JEA but they do not do park lights. It is very dark around the park the light bulbs need to be replaced. Mr. Beck will call Public Works to help them with this.

Florida Department of Transportation (FDOT) – Milton Locklear addressed the CPAC asking for their input on his report and attendance at the meeting. The UC has the least amount of FDOT projects and he wants to do a better job of reporting. Members thanked Milton for coming each month and being so helpful and conscientious. Members hope that he will be able to continue coming each month and if not every month every other month. Milton presented his report:

FDOT - The following programs over the next 4 years with the cut backs will be:

- I-10/I-95 is expected to be finished in 2011
- The Hart Bridge painting project will begin soon
- The 8th Street ramp will be done by 2010 to 2011

Members asked about the Main Street project and the lack of bike lanes. Some members were confused with the location and asked for a map. Milton will bring this next month. He will also look into the project and report back next month. Members asked about the Hart Bridge painting. In the past there was a tremendous problem and cars were painted by spraying mistakes. Members wanted to know if the crossing light at 8th Street and I-95 could be adjusted. The pedestrian signals need to be adjusted. Milton will check on this. They also wanted to know about the JTA HUB at Gateway and the work from Lem Turner to Gateway Mall. The \$100,000 does not include programming dollars. Member Hartman reminded Ms. Robbins that he requested that the Recreation Department check into funding for refurbishing Hogan's/Deer Creek for future parks.
