

# Call to Order

Chairman Vanderlaan called the meeting to order at 5:32 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan Street and welcomed everyone.

#### **Approval of the Minutes**

Member Noonan made a made a Motion to accept the minutes from the October 3, 2011 meeting. A second was made by Member DeVall. The Vote: All in favor; none opposed.

# **Guest Speaker**

**Sheriff John Rutherford –** stated he was glad to be at the meeting to start a conversation on homelessness all over Duval County. He said vision without action is daydreaming and action without vision is chaotic. The city has been doing the same thing for 20 years and it's time to redefine the problem of homelessness. There are three groups:

1. There are people that are house less. They are the ones that advocates talk about with homelessness. They want a job, a home and they value these things. That is what Clara White and the Sulzbacher Center are about.

- 2. The chronic homeless they are the ones that don't want the things the majority of people value. They don't want to stay in the shelters but will eat there. They are the ones that live in the woods at night and go to the bathroom on the streets and in the fountains. They ask people for money. They are the ones that want to drink and do drugs. The Sheriff's office picks them up for violating the law and continues to put them in jail. The chronic homeless call this" 3 hots and a cot." Some have been arrested over 100 times for misdemeanors. Once they are released from jail they are only 4 blocks from where they got picked up and the same thing happens all over again. Downtown is a target rich environment. There are some that have been in jail 169 times since May.
- 3. The mentally ill they need professional help. They are different than the chronic homeless.

Sheriff Rutherford stated it was time to try something different. He suggested creating a facility to provide food and shelter far from downtown, may be in the woods about 12 miles away from downtown. He would like to have good resources to help convince the chronic homeless to change. He would like to create a Misdemeanor Release Facility. This way the chronic homeless would be offered help or they would have to walk back to downtown or go to another city. They need to stop destroying the quality of life in this community. We can't continue to do the same thing. The chronic homeless cannot continue to cycle through the jail like a revolving door either. He has spoken to the heads at the Sulzbacher Center and Clara White. He wants to begin the dialogue of building a Misdemeanor Release Facility. Members had numerous questions and concern on the following: the cost of the facility, where it would be built, how long would someone be allowed to stay and would this be an undo penalty for the poor. It was mentioned that Chair Vanderlaan was strong armed by a panhandler. People that come downtown for the first time do not need to have a bad experience and never come back. Businesses need to thrive in the community as well. Some recommended sharing the problem throughout the city while others thought this would be unrealistic. Members mentioned the closing of Monroe Street and if a park would be built what would keep the chronic homeless away? It was also mentioned that the chronic homeless are well connected and Jacksonville is a destination to come to. Members thanked the Sheriff for doing something to address this issue. Members also asked if the centers are charging \$8 a night to stay there. No, they are free and this is a scam. They also mentioned mega churches helping by bringing the homeless to their churches and helping them there. Sheriff Rutherford stated that crime is down in the Urban Core. It is the safest it has been since 1983 with the raw numbers and the per capita numbers. We have added 375,000 people since then. Murder is the lowest in three decades. Things have changed since then:

- 1. ShAdCo (Sheriff's Advisory Council) has grown from 600 to 3000 members.
- 2. The community is working with JSO tips are coming in through the ceiling. Jacksonville is no longer a "don't snitch community".

Chair Vanderlaan thanked Sheriff Rutherford for coming.

Member Radlinski moved that the Urban Core CPAC supports the Sheriff's initiative to create a Misdemeanor Release Facility outside the downtown area subject to further review. The Motion was properly seconded by Member Swain. Discussion: Members talked about the issues of churches currently feeding the homeless downtown who cause other problems like garbage all over the streets and no bathroom facilities. They were also concerned on how they would differentiate the chronic homeless and mentally ill people. This population is vulnerable and how would they get the resources and health care that they need. There was also talk about moving them from downtown but people have rights. The Vote: 8 aye and 4 no. The Motion carries. Chair Vanderlaan stated that the Motion will give the CPAC an opportunity to keep an eye on this as it develops.

**Executive Council Assistant** for Council Member Lumb, At-large Group 5 Donna Barrow left information on the latest openings for Boards and Commissions as well as applications. # Planning and Development - Emery Nauden reported on the following:

- At the end of October a request had to be re-noticed for 706 A. Philip Randolph Blvd. for a reduction from 1500 feet to 26 feet for a complete liquor license. There are a number of churches near this location. The Neighborhood Action Plan for the Eastside Corridor Study recommended for more restaurants and retail. Planner Lisa Ransom determined from the NAP that this would promote business and the department approves of this zoning. For more information contact Bruce Lewis at 255-7500. A member asked what the name of the restaurant is and where it was located. Member Anderson from the Eastside did not know where this was. He will talk with Ms. Love when he gets the information. He did not support any additional operations.

**Recreation and Community Services -** Pam Roman reported on the following:

- Shorty Robbins is no longer with the city. She left on her own decision and is with the Parks Department in Hillsborough County and is doing well.
- Chair Vanderlaan welcomed Ms. Roman to the Urban Core CPAC. She stated that she has been with the City of Jacksonville for the past 8 years.
- They are tasked with cutting positions and centers. Currently there is nothing slated in the Urban Core but the list will be available after the first of the year.
- There are two construction projects:
  - o Confederate Park the disc golf course will be open this Friday. It is a lot of fun.
  - Klutho Park has to be rebid. The current vendor did not do the paper work correctly.

That is an Adult Service Center and not a park center. They also asked about the Joe James Center, it has been closed for several years but is open for the summer lunch program.
