Call to Order

Vice Chairperson Tippins called the meeting to order at 5:02 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan Street with a moment of silence and welcomed everyone.

Approval of the Minutes

Member Swain made a made a Motion to accept the minutes from the May 4, 2009 meeting. A second was made by Member Johnson--McPherson. The Vote: All in favor; none opposed.

Jacksonville Sheriff's Office (JSO) – Sgt. Yul a member of the Bike Unit in Zone 1 introduced himself and Officer Domingo. The Bike Unit has 5 Officers on his squad and they arrest about 100 people per month. He reported that Zone 1 will not be getting any of the new officers. They will be going to Zone 4 and 5. School is almost out and kids will be at home for the summer and typically this is when crime goes up. There is a Curfew Law: weekdays 11 p.m. to 6 a.m. and on weekend's midnight to 6 a.m. If you see kids hangings out during the curfew times call JSO at 630-0500. Auto thefts city- wide have gone up. Use common sense and do not leave anything in your car to tempt a smash and grab. Bikes safety is the law. Children under the age of 16-years old must wear a helmet. One should ride on the right side of the road and not the sidewalk. Bikers should use the same hand signals that drivers use. Members had a question on an abandoned car in an ally way. Guest Speakers

<u>JEA</u> - Brian Pippin, CEM, CGP gave a presentation on a portion of the 45-minute program "Savings without Sacrifice" Low and no cost energy and water conservation behaviors and products that will help to significantly lower your utility bill. If this will spark your interest and you would like to become a trainer please contact Brian. He asked members if they received an operations manual when they purchased their home. None did. With summer time being so hot and the need to lower utility bills by 50% with no cost, low cost and or a capital solution was presented.

- First; control your thermostat: set it at 78 degrees in the summer (68 degrees in the winter). If you set it lower it will cost you more money each month.
- Low cost: If you install a fan in every room and only turn it on when you are in the room it will make you feel 3 to 5 degrees cooler. Fans cool people not rooms. If you leave it on when not in the room the motor will produce heat. If you leave it on 24 hours a day it will cost \$5 a month.
- Everyone needs interior shading and the need for more exterior shading with trees and bushes but that will take years. Awnings and shutters will help as well as solar screens and much better is film for your windows to be placed on your east and west windows.
- Air conditioner heat pumps take the heat out of house in the summer. If you check your attic and you can see your rafters you need more attic insulation for an R 38, walls R19 and windows with no shade will be an R2 value.
- You can chalk and weather strip your home "If you see light it isn't tight"
- In the kitchen under your sink there may be a hole that no-one sees. This is a way that air escapes and rodents enter. Use some spray foam sealant to close the gap.
- Have CFL light bulbs for every lamp in your house. They save money. At the end of the meeting each person will receive a CFL light bulb.

Members asked questions on the following:

- What about devices that say they will save you money. These devices are usually for commercial customers being billed in KVA. They will save this billing money but JEA does not bill the residential customer in KVA wattage and therefore this device will not save you any money.
- How much does a CFL burn? Compared to a 60 watts bulb the CFL will burn ¼ but the latest technology of LED will burn 5 watts but the cost for these bulbs are still very high but worth it for direct lighting.
- Is it worth it to switch your thermostat to a programmable one? Yes. If no-one is home during the day – every degree below 78 will cost you 5% more in your bill. Be careful not to have the A/C off to long to control the humidity level in the house. Mold and mildew may grow.

Emergency Preparedness Elizabeth Henderson, Planner, gave a PowerPoint presentation on "Disaster Preparedness" Today, June 1st is the first day of the 2009 Hurricane season and lasts to Nov. 30. Are you ready? Jacksonville hasn't been hit in a few years but that doesn't mean it may not happen. Everyone needs to be prepared. If a hurricane did hit there may not be any assistance from government for 3 to 7 days. You need to prepare yourself. The 2009 National Weather Bureau is predicting 9 to 14 named storms. Are you ready to survive a Category 3, 4 or 5 storm?

- Category 1 winds 74-95 mph
- Category 2 winds 96-110 mph
- Category 3 Winds 111-130 mph
- Category 4 winds 131-155 mph
- Category 5 winds over 155 mph

Color-coded storm surge markers can be found throughout Jacksonville and the Beaches. You may only have a 12-hour notice to prepare. If a storm is a approaching prepare by doing the following: Set you freezer on the highest setting, freeze water bottles for ice water and or an ice pack if someone is injured wrap the bottle with a towel, remove all objects from your yard, make an evacuation plan, remember to call 511 (Florida Highway Patrol) to see what roads are

blocked and where to travel, if you need transportation to go to an evacuation center go to your nearest bus stop. If you are told to evacuate call ahead to a hotel to make a reservation, place all your financial, medical and home information on a flash drive and if told to leave your home LEAVE. JSO and the Fire Department will not put themselves in harms way if you were asked to leave and didn't. Register yearly if you need medical care or need to go to a pet friendly shelter. Currently there are 897 registered for medical. Secure your valuables in a water proof container. Stay away from windows and don't go out. Do not open your windows and doors. Know where your safe room is. After the storm do not use equipment or go on roof tops if you have never done it before. Don't let children play in standing water there may be live electrical wires or snakes. If you are in a car during a tornado get out of the car and go to the lowest point.

Recommended Supply Kit:

- 1 gallon of water per person per day for 3 to 5 days
 - Water purification kits are sold in sporting goods stores
- Canned food and non perishable items for at least 3 days
 - o Stay away from flames but sterno cans can be reused
- Battery operated or hand crank radio and a NOAA Weather radio with tone alert and extra batteries for both
- First aid kit
- Whistle to signal for help
- Get cash the ATM won't work without power or the machine may be empty
- Take clothing and bedding and place in a plastic bag
- On June 12 your old battery operated TVs will NOT work. If you get a new digital TV make sure you read the instructions on how long it will work and how change batteries or recharge it.
- Flash lights and extra batteries
- Manual can openers
- Hand sanitizer, moist towelettes, garbage bags and plastic ties for personal sanitation
- Prescription medication call the pharmacy to fill once a storm is approaching
- Books and games to entertain

Booths at the fairs will be health and safety related. The Department of Health will hold hand washing demonstrations and Wal-Mart will have vision screenings. JEA and Florida Kid Care will also be in attendance. There will be drawings and kids activities all from 10 a.m. to 1 p.m. The Outreach Team continues to go door-to-door since they are still in need of more signed access agreements. They hope to begin the cleanup sometime in the fall and open the Outreach Center sometime in the summer at the Oaks at Durkeeville. Florida Department of Transportation (FDOT) – Milton Locklear had no repot but Introduced Maintenance Engineer, Jerry Ausher. Mr. Ausher stated that FDOT does not have employees on maintenance crews but uses private contractors. Jacksonville is the only area in the state that is completely contracted out 100%. This is the current trend. They have a good performance record. Please call FDOT if there are problems so that they can be addressed with the contractors. He talked about homeless camps typically under bridges and the need to clean them up and lighting which is for the roadway and maintained by the City. Members had concerns with the following:

- The grass is not being cut, workers asked about the problem are rude and this trend with private contractors is not in the best interest of the neighborhood for keeping the areas clean.
- There is a problem at Spires and Wilson that they have been working on for years. They have talked with Tom at FDOT. They want to get a block aide to stop left turns off Wilson. They have been told there in nothing in the budget for concrete barriers. Is there a way to find out the crash history and do something quicker?
- The Bay Street and Myrtle Avenue underpass needs regular maintenance. The walls look unsanitary with weeds and visual blight. This needs to be addressed.
- The lighting is out at the Park Street overpass near the Prime Osborn Convention Center.
- Members are very concerned with big trees not being trimmed and how dark the streets are especially in the Planet Watch neighborhood.

Planning and Development - Emery Nauden had no report but since there will not be a meeting in July wanted to defer his time to Attorney Brenna Durden to speak on the Swisher, Inc. rezoning to a PUD (Planned Unit Development) located at 17th and 18th Streets and Walnut and Liberty. Swisher international is the largest producer of cigars in the U.S. with over 1 million cigars produced a day. They have been at the current location for over 100 years. They operate in 2 shifts that go to 11 p.m. They want to expand to produce more cigars. They have purchased the homes in the above mentioned boundaries which have been torn down. In the past they have been a good neighbor. They have met with the neighbors and there concern was a loud speaker they use at night. Swisher was unaware till the meeting that this was a problem and they are working on this. Members stated that Swisher has been a wonderful partner in the community with great employment opportunities but they need to have something transitional from residential to the company in a way to be visually pleasing for the community. Instead of a chain link fence maybe they could they use something nicer. There is a lot of traffic during shift changes. Members also wanted to know if anyone was displaced and if they were forced to sell. No, no-one was under duress but people were calling them to buy their property. Realtor Ralph Colbert would know the details. Members also wanted to know how many were homes had renters. Members wanted to know about a current fence that had barb wire around it and that was not allowed. Ms. Durden was not aware of this and would check on this the following day. They also were under the impression that the land was going to be for parking not a building for manufacturing. No it could be both. Ms. Durden summarized the issues to be sound, traffic, the sold properties and the fence.
