

# **Meeting Summary - September Meeting** Monday, August 29, 2011

#### Call to Order

Chair Vanderlaan called the meeting to order at 5:30 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan Street and thanked and welcomed everyone.

#### Approval of the Minutes

Member Parrish made a Motion to amend the minutes with the following corrections for the August 1, 2011 meeting. A second was made by Member Radlinski.

- Springfield Woman's Club should be referred to as SIAWC or Springfield Improvement Association and Woman's Club, which is the legal name of the organization.
- Regarding the proposed Main Street traffic study: the phrase "study that would not mess up the one way" doesn't make sense - the study is to determine the cost and viability of changing the street from one way to two-way traffic between State and Union Streets.
- Regarding the need for this change, it is important to stress that because it is impossible to travel north on Main into Springfield, commercial vehicles including large, over weight tractor trailers are traveling down residential streets and endangering property and pedestrians.
- Regarding the weight limit signs on Hubbard, the point is that trucks are ignoring the

The Vote: All in favor; none opposed. The Motion carries with the amended corrections.

Chair Vanderlaan introduced **Council Member Robin Lumb**, Group 5 At-Large and his Executive Council Assistant Donna Barrow. Council Member Lumb talked about the Redistricting. He stated that he was on his way to the next hearing at FSCJ South Campus but wanted to be sure to let the Urban Core know that there will be a hearing of the full City Council on September 13, time to be determined on the redistricting only. Thus far he has heard a lot of negative feedback. He has not had a role on developing the redistricting map but wanted to make sure everyone had a chance to voice his concern. The map needs to be a rational plan. Some of it makes sense and some does not. The deadline to finish this process is November 18, 2011. Please feel free to call his office for the details on the meeting on September 13 at 630-1387. He also spoke and handed out information on current openings with appointments by the City Council on the following Boards and Commission:

 Building Code Adjustment Board, Duval County Research and Development Authority, Enterprise Zone Development Agency Board, Health & Life Insurance Procurement Committee, Jacksonville-Duval County Council on Elder Affairs, Jacksonville Health Facilities Authority, Jacksonville Housing and Community Development Commission, Jacksonville Housing Finance Authority, Jacksonville Police & Fire Pension Board of Trustees, JIA Area Redevelopment Agency Board, and Taxation, Revenue & Utilization of Expenditures "TRUE" Commission. They are accepting applications.

#### Redistricting

Members talked about the redistricting map 8/10/11 Total Population Plan D. They would not like to see District 7 extend well beyond the river to the Southside. They would like to see the Southbank residential high-rises included in the Urban Core. Members reviewed the criteria set out in the Redistricting Ordinance 2011-554 which states that the Council is obligated to insure that all the districts are as nearly equal in population and are arranged in as logical and compact a geographical pattern as possible to achieve and to ensure that all federal and state constitutions, laws and requirements are complied with; and whereas; the Council districts are based upon population with respect to their size, the geographical arrangement and territorial boundaries of the districts must take into consideration other factors, particularly compactness and contiguity, so that the people of the City, and their varied economic, social and ethnic interests and objectives, are adequately represented within the Council. Members were concerned if they did not voice their concerns now it may be too late since this will be coming out of the Rules Subcommittee. Following discussion Member Parrish made a Motion to advise the Mayor and City Council that the Urban Core CPAC has determined that District 7 is neither compact nor contiguous and the diversity of interests of the population is too great for adequate representation by a single council person. Member Radlinski made the second. Discussion continued on the make up of the districts. Thereafter, Member Radlinski made a Motion to Amend the Motion to add that the CPAC recommends to retain the Southbank to Prudential Drive in District 7 and merge the area south of Prudential Drive on the Southside along Phillips Highway into District 5. Member Ownby seconded the Motion to amend. Discussion: There was a lengthy discussion since this is a very complicated process. When moving one area to another district will have a domino effect and becomes complex. It was noted, however, that redistricting is not a precise mathematical process; that the redistricting ordinance allows a 10% population deviation. Thus additions or subtractions within the original proposed district population was anticipated. The Vote: All in favor of the amendment; none opposed. The Amendment carries unanimously. Members Voted on the Motion as Amended: The Vote: All in favor of the motion as amended; none opposed. The Amended Motion carried unanimously.

#### **Guest Speakers**

"Community Awareness" – Department of Health – Dr. Max Wilson, Prevention Programs Coordinator talked about reproductive health. He passed out a flyer with comparison rates of STD rates in Duval County to the National Average from 2009:

	Duval County	Florida	United States
Chlamydia	608.9 per 100,000	387.5 per 100,000	409.2 per 100,000
Gonorrhea	200.9 per 100,000	111.0 per 100,000	99.1 per 100,000

Syphilis	23.6 per 100,000	20.4 per 100,000	14.7 per 100,000

Geographically, the Urban Core of Jacksonville has the highest incidence of STDs in comparison with other areas of the city. Zip codes with the highest STD rates (ranked from highest to the lowest) include: 1. 32209 2. 32206 3. 32208 4. 32254 5. 32211

- STD disparities based on age: Teenagers and young adults aged 15 24 years old bare the majority of the burden for STDs. 64% of the total number of STDs occur in this population. Within this age group 1 out of every 19 individuals has had an STD. Women are disproportionately affected by STDs and over 81% of STD infections occur among African American women. Other minorities also suffer from high rates of infection. Repeat STD infections ranged from 2 cases to 47 cases over a 3-year period which was troubling.
- Dr. Wilson invited everyone to attend the Community Advisory Board on the First Thursday of the month with the next meeting on September 1, 2011 at 5:30 p.m. at the Urban League. The HIT Team Health Intervention Team includes young adults and students.

Members had questions and concerns on the following: Are men more likely not to come in for care? Yes and the process of "Back to the Well" will not treat partners unless they come to the office. There was great discussion and interest on the Community Awareness on the high numbers of STDs in the Urban Core. They were also very concerned with the Duval County School Board having an abstinence based only sex education when Duval County's STD numbers are so high. A DCPS Health Educator will come to discuss this further at a future meeting. Members had suggestions to have a social media sight like U-Tube present the information to be a self help and what to do to educate them. They also suggested working with the DCPS to educate the students with abstinence based inclusive program. Dr. Wilson can be reached at 253-2985

**JEA** –Neighborhood Energy Efficiency Program – did not show up but Chair Vanderlaan talked about the program which is available for specific neighborhoods in the Urban Core.

#### **Unfinished Business**

Community Gardens - Member Searle from Sustainable Springfield was not present but alternate Member Ownby stated that Member Searle was trying to get goats and chickens (hens) not roosters into the zoning code and was looking for Council support. The Chairman suggested that the Committee again defer the matter until Member Searle was present. Member Radlinski objected. He said that he had requested deferring the matter when Member Searle raised the subject, because he was unfamiliar with Community Gardens. However, since then he had stated he had researched community gardens and toured four of them in town and now supports the concept. Further, as the Committee's representative to the TRUE Commission representative he became aware of Ordinance 2011-251 that amends the Future Land Use Element of the 2030 Comp Plan on Community Gardens. If adopted, that bill would define a community garden as "an area of land managed and maintained by a group of individuals to grow and harvest food crops and/or non-food, ornamental crops, such as flowers, for personal or group use, consumption or donation, but not for retail sale or wholesale purposes. Community gardens may be divided into separate plots for cultivation by one or more individuals or may be farmed collectively by members of the group and may include common areas maintained and used by group members. Community gardens are considered unsuitable for the following future land use categories: Light Industrial, Heavy Industrial, and Water Dependant-Water Related." Additionally, the Council is considering Ordinance 2011-542, a bill that appropriates \$15,000 in Environmental Protection Agency grant funding under the Environmental Justice Small Grants Program for Community Research. The funds are to be used by the Eastside Environmental Council, in partnership with the City, for outreach and to provide educational workshops and community training sessions concerning the concept of community gardening in preparation for the widespread implementation of community gardens in the City's Health Zone 1. The project will also demonstrate how the presence and accessibility of community health centers can improve a community's overall health.

Member Radlinski made a Motion for the Urban Core CPAC to support Ordinance 2011-516 as written. He would have included a further limitation that community gardens being subject to the people who live adjacent to and within 100-feet around the gardens, and prohibit keeping animals in community gardens. However, the bill does not authorize animals at community gardens, and, without animals, approval of neighboring property owners did not appear necessary before establishing a garden. Member Swain seconded the motion.

Discussion: Members were concerned about the procedures for having a community garden. They thought that the neighbors around the garden needed to have a say on if they would support a garden. They wanted to know if guidelines existed for the gardens. There were concerns with chickens, goats and manure. Member Radlinski reviewed 2011-516 and pointed out that it does not authorize animal husbandry at community gardens. If animals were to be allowed, another bill would have to be introduced to amend the definition of "community garden." The Vote: All in Favor; none opposes. The Motion carries unanimously.

JFRD (Jacksonville Fire and Rescue Department) Chief Kurtis Wilson introduced himself and stated that he manages the 57 fire stations, 4 buildings and the fleet of fire and rescue cars and trucks. He spoke about Station #2 in Springfield. It is currently undergoing some renovations. The station is over 100 years old. The bay floor had not been replaced in over 50 years and it was not supporting the weight of today's equipment. Trucks can weight 30,000 to 40,000 pounds more than in the 1970s. The floor is cracking and the roof has met its life expectancy. They have put in new concrete floors to look like the previous terrazzo floors that will support the weight of the trucks. They were hoping to be done with the floor by Aug. 15th but are behind. Once this is done they will begin work on the roof. They are currently under budget by \$20,000 on the floor and they have a \$60,000 quote on the roof. It will look the same but will last longer. The plywood doors will be replaced with new bay doors once the repairs are complete. The money for the doors came from a grant. Members asked if the station is still open. Yes, it is. Station #2 is one of the busiest stations in particular with the older homes in Springfield that catch fire so quickly. Members thanked the Chief and complimented him on the very friendly staff at Station #2. Chief Wilson stated that the Chief of Station #2 has been there for the past 18 years. <u>Duval County Public Schools</u> (DCPS) - Michelle Stone and Nikki Micheau talked about accountability and the Intervene schools. An Intervene school is a school that meets the following criteria:

- Current "F" schools that have earned at least four "F" grades in the last six school years
- High schools that have earned less that 395 FCAT performance points and have earned at least four "F" grades in the last six school years (*Raines, Ribault High Schools*)
- "D" Correct II elementary or middle schools or "F" elementary or middle schools or Correct II high schools with FCAT performance points less than 435 that meet at least 3 of the following criteria: (Andrew Jackson High School and North Shore K 8 Elementary)

Schools that are in the Intervene category must select one of four options. These are:

- 1. Convert the school to a district managed turnaround school
- 2. Close and reopen the school as a charter school or multiple charter schools.
- 3. Contract with an outside entity to run the school.
- 4. Close the school and reassign the students to another school, and monitor the students' progress. The four Phase 1 Intervene Schools are: Raines, Ribault, Andrew Jackson High Schools and North Shore K-8 Elementary. Phase 2 Intervene are: A. Philip Randolph, Forest and Ed White High Schools. In the news you may have heard that a group of Jacksonville business leaders were getting together to form the Duval Partners for Excellent Education, Inc in hopes of becoming an EMO (Education Management Organization) to run the Intervene Schools. In July the Board decided to hire an EMO directly called Education Direction. In the mean time the State gave DCPS an extension but part of the process was to host community meetings to discuss the available school options at the Intervene schools. The meetings were held in August. The schools will look at the whole child for services and partner agencies. The State will hold meetings. There will be one in October to consider other reform models and other oppor-tunities. The schools show growth and made progress but it is hard to exit the Intervene status. Don't Eat the Fish in Hogan's Creek and Long Brach tributaries in Health Zone 1. The Duval County Health Department (DCHD) and the City of Jacksonville (COJ) are jointly issuing a Fish Consumption Advisory for largemouth bass, blue tilapia, and striped mullet from Hogan Creek and Long Branch tributaries in Health Zone 1. The advisory recommends that people should not eat largemouth bass and striped mullet from Hogan Creek due to their contamination with polyaromatic hydrocarbons (PAHs). In addition, largemouth bass and blue tilapia from Long Branch should not be consumed due to pesticide (dieldrin) contamination. The concentration of contaminants found in the mentioned fish species from these creeks could pose a health concern for the people who eat them.
