# Call to Order

Chairman Williams called the meeting to order at 5:06 p.m. in Training Room 110 of the Ed Ball Building, 214 N. Hogan Street with a moment of silence and welcomed everyone.

# Approval of the Minutes

Member Dr. Norman made a made a Motion to accept the minutes from the June 1, 2009 meeting. A second was made by Member Vanderlaan. The Vote: All in favor; none opposed.

Jacksonville Sheriff's Office (JSO) – Sgt. Yul reported that they were currently working on a deployment for pan handling. Zone 1 has received numerous complaints on panhandling and in just a few hours 10 arrests have been made. It is a nuisance crime. There have been a lot of crimes involving robberies. Be aware of your surroundings with your car and house. There have also been robberies to businesses and home invasions. Do not leave anything in the car. GPS devices sitting on the dash are in invitation and welcome sign to smash and grab. Place them in the trunk of your car. Members asked about National Night Out on Tuesday, Aug. 4, 2009. SPAR will hold their event at 3<sup>rd</sup> and Main Street at 6 p.m. Please come and join them. The other events for National Night Out in the Urban Core are at the Parks at the Cathedral with an Ice cream social and Northshore turning their lights on. Chairman Williams stated his car was stolen at the NW Library but was able to get it back with only the spare tire stolen. Chairman Williams introduced Councilman Don Redman, District 4, who can be reached at 630-1394 or Redman@coj.net, Councilman Dr. Johnny Gaffney, District 7, who can be reached at 630-1384 or Gaffney@coj.net and Councilman Warren Jones, District 9, who can be reached at 630-1395 or Wajones@coj.net. They all went over their District boundaries and were all pleased to be at the UC CPAC meeting. Councilman Redman spoke on downtown panhandlers. He gives the pan handlers a green card which states where to go to get help and something to eat. Do not give them money. It is against the law to panhandle. JSO will give them a warning the first time and the second time a ticket. Councilman Dr. Gaffney spoke on being accountable to you the constituents, his boss. If there is no neighborhood association one needs to be formed. He wants to see his constituents empowered. If there is a problem he will call on the right department or agency to get it fixed. He is very aggressive to clean up District 7. Councilman Jones spoke about the upcoming Ordinance 2009-401 on bus shelters that Mike Miller from JTA will be discussing. He hopes that it will be approved by the City Council in a couple of months. They all acknowledged receiving Member Vanderlaan's e-mail on the cavein and old infrastructure in Springfield. Members thanked the Councilmen for attending the meeting. They all then heard and answered questions by the UC CPAC Membership:

- 1. Member Vanderlaan thanked them for their words on the pot holes but the Urban Core infrastructure is old and decaying and short term patches are spending more tax payer dollars instead of actually restoring or building infrastructure. Is there any stimulus money to invest in infrastructure?
- 2. Member Vanderlaan also wanted to know about gambling parlors or internet cafes. Is it a state issue? Legally couldn't the State clarify the law? They are showing up all over the city with a legal loop hole that won't allow JSO to shut them down. This seems to be a poor way to run government. If shops are not paying anything why would the state want this? Do they have the proper license to operate? Does it follow the rules? They just move in equipment, open up the doors and get the profit without giving anything to the city? What about zoning rules and regulations? We need to bring this to our state legislators if nothing can be done locally. The newspaper article says there are 36 of them.
- 3. In the Planet Watch neighborhood near Brentwood, they have dug up roads inconsistently throughout the neighborhood all the way to 20<sup>th</sup> Street. They have not seen one yellow line, curb or continuous sidewalk in 30 years. How can they get this done? The BJP (Better Jax. Plan) should have taken care of this.
- 4. With the toughest budget in recent memory why hasn't the courthouse been put on hold considering it's a \$300 million dollar project? BJP and other funds have to be set aside for this project only. They also want to get the courthouse off the riverfront and put that property back on the tax roles if they are able to sell the building.
- 5. With the courthouse contracts how many jobs will go to local people?
- 6. Is there a way to get an amusement park or some tourist attraction to have something for children to do and have more jobs?
- 7. Mark Holmes, 1640 Tyler Street asked Councilman Jones how he can can get his yard fixed. They dug in front of his house and there is still no grass and nothing has happened for weeks. Councilman Jones said the contractor is required to fix it. He asked Mr. Holmes to call him.
- 8. Members mentioned that School Board Member Stan Jordan wants to sell the DCPS building on Prudential Dr. It is a 7-member Board and they will have to vote on it. Now is not the time to try and sell the Duval County School Board Building while values are depressed.
- 9. Contractors that the City of Jacksonville is hiring to cut and clean nuisance lots are not following through with the jobs that they are getting paid for. This needs to be looked into and the contractors need to be held accountable.
- 10. Members do not want to see the Eastside Library close since it is utilized by the youth and community especially in the summer months when school is closed.
- 11. Members remarked that no-one wants to pay high taxes but residents don't want to give up services. The budget is a very complicated issue. There are concerns for services In the Urban Core and to raise the millage takes courage.

- 12. Is there any stimulus money to invest in infrastructure?
- 13. The CPACs need the neighborhood coordinators to run keep them in place and to have things run smoothly. It is essential to keep them to keep the CPACs viable.

JTA – Mike Miller, Director of External Affairs, showed a video on Legislation 2009-401 that Councilman Jones introduced in his remarks on bus shelters. The video can be seen on the JTA website www.jtafla.com Council members Jones, Redman and Gaffney are all cosponsors of this bill. The lack of bus shelters is among the top six suggestions by riders and non riders from a JTA survey and thus bus shelters are needed. Jacksonville averages 115 days of rain and 53 days with temperatures at or above 90 degrees. This bill will allow JTA to add 750 new solar powered shelters during the next 15 years with no money from taxpayers. It will save nearly \$10 million in capital and maintenance during the 15 years. Voice your comments to all the City Council members by calling 630-1377. Members had guestions on the following: The time line on the vote by City Council - Planning is looking at zoning for the advertised shelters and it expects to be on Aug. 13 then to LUZ on the first Tuesday in September and possibly to the full Council the second week in September. The time line is short. Where will the shelters be placed and are there priority areas? JTA rapid system had 4 main corridors: North: from the Rosa Parks station to Gateway, Southwest: Roosevelt to Orange Park Southeast: I-95 or US 1 and East: Beach and Atlantic Blvd. and that's where they will be located. There will be no advertised shelters in residential areas. Some of the shelters will replace some of the older ones but this will allow JTA to free up existing budget dollars and put more shelters up. There is a back log of 75 shelters but in order to qualify for a shelter there has to be 24 passengers per day at that stop. The Eastside Looper was cut to Gateway and this is needed for the neighborhood. There will be a meeting on Sep. 5 on the new round of efficiencies to balance the budget by making changes to the routes. Come and voice your concerns. **Mayor's Office –** Project New Ground – The Hester Group Consultant Greg Bruce introduced Anthony McGlone and reported on the following:

- The clean up is expected to start in November.
- At the end of August or the beginning of September the Community Office will open.
- They still need 3200 access agreements.
- They just finished Neighborhood Fairs in the community.
- They are conducting samplings near the Brown's Dump and Springfield area.
