Call to Order

Chairs Report

Dewey thanked everyone for attending the December Holiday Gathering, presented the Subcommittee Chair with their Certificate of Appreciation for those that were unable to attend the December meeting. Approval of the Minutes

Motion to approve the November 9, 2009 meeting summary was made. The motion was properly seconded and approved by the group.

Speakers

Jeff Winkler, Director, Real\$ense Prosperity Campaign, introduced himself and the programs that are offered through Real\$ense and their partners. Some of the services that they provide are free financial classes, some of the topics include: how to fix your credit, open or reopen a bank account, use credit wisely, and set up a budget and save money. Real\$ense also offers Matched Savings Account. This program matches every \$1 you save by \$2 so the money saved can be used to buy your first home, start or grow your own business or pay for college or technical school for your self. Real\$ense also offers free income tax preparation. Matt Shirk, Public Defender, Fourth Judicial Circuit, informed the group that the 4th Judicial District includes Duval, Nassau and Clay counties. The public defenders office was created in 1963 to handle non-capital offence felonies. Since taken office, Shirk has worked to develop an efficient administration, effective representation and engage the community. Another way they will try to save taxpayer funds is by recovering some funds from acquitted clients, by postponing their bill for services rendered until they become employed. Also, there appears to be a large number of people who claim to be indigent are not, and public defender investigators could check for income not divulged in court. PARKS & RECREATION – Chair Dewey Marshall – no report

BEAUTIFICATION – Chair Larry Belge – informed everyone that along the Wonderwood Expressway many trees are being planted and a sprinkler system is being installed too.

LAND USE & ZONING - Chair Mike Anania -

Opposition to Ordinance 2009-401 regarding the illumination advertisement on bus shelters. CPAC opposes the placement of internally illuminated advertisement in bus shelters in Planning District 2 since all Planning Districts in Jacksonville are not to be treated equally and therefore oppose any action that is discriminatory.

Opposition to the Administrative Deviation AD-09-113 to deviate the side yard from 5 feet to 2.8 feet and the rear yard from 10 feet to 0 feet to allow the replacement of an existing shed at 10770 Java Drive between Kuralei Drive and Indies Drive. The applicant has the room to relocate the shed to meet the City's zoning code.

Opposition to Permit Application Number SAJ-2007-03007 SP-MRE) RaceTrac Corporation application to construct a RaceTrac fueling station and convenience store

Corporation application to construct a RaceTrac fueling station and convenience store on 2.8 acres of wetlands on Merrill Road , Jacksonville.

- During RaceTrac's land use application process to the City for this proposed use CPAC recommended that this application be denied based on various reasons. However, the main reason was environmental. CPAC felt the wetlands of the site were valuable and should be preserved.
- The St. Johns River Water Management District will approve any wetlands alteration in their permit process as long as the applicant agrees to either mitigate the wetlands on site or pay into a mitigation bank. CPAC always opposes the idea of losing their community's wetlands to some other location.
- There is other non-wetland land available to locate the gas station and convenience store.

Opposition to the Land Use Amendment LU-2009D-003 (2010-18) to change the land use category of 3.6 acres from LDR to MDR to allow for elderly housing at 14321 Van Zile Avenue on the corner of Van Zile Avenue and San Pablo Road. The proposed density is too dense in an area of Low Density Residential land use. Approval would set a precedent for spot zoning.

Opposition to the Minor Modification MM-10-03 to modify the sign allowance as stipulated in the PUD from 18 inches to 42 inches at 2771-12 Monument Road between Monument Road and Monument Landing Boulevard. Approval will set a precedent for other tenants to want larger signs thereby, nullifying the PUD restriction.

The School Board will be attending a retreat to discuss "Race for the Top" The first phase of FCAT begins in February.



- There is other non-wetland land available to locate the gas station and convenience store.
