MAYOR'S REPRESENTATIVE – Kelley Boree brought thanks form the administration for the work of the CPAC. She reported on the reorganization of city government to create efficiencies. She also reported that the Legislative Special Session on Property Tax Reform was scheduled to begin the following day. They are expecting some answers by June 22nd. A \$50 - \$75 million budget deficit is anticipated. She urged everyone to contact their state legislators. She then fielded questions from the group.

JSO – Asst. Chief Carson Tranquille reported that traffic fatalities were up across the county. The primary cause is people not wearing seat belts. He encouraged everyone present to please wear them and encourage others to do so as well. In Zone 2, they are still having issues with Burglaries to Autos. He asked everyone to not leave valuables in sight in their vehicles. He also invited everyone to attend the upcoming joint SHADCO meeting with Sheriff Rutherford as the guest speaker. He then fielded questions from the group.

DCSB – Selinda Keyes reported that school is out and the district is awaiting the state to report school grades. They are expected the week of the 22nd. She mentioned that Justina Elementary is a school of concern. She also reported that the School Board recently approved purchasing land and moving forward with a new high school in the 9A and Baymeadows area.

PUBLIC WORKS – no report.

PLANNING & DEVELOPMENT – Ed Lukacovic reported on upcoming workshops for the 2010 Comp Plan Evaluation and Appraised Report (EAR). (Info can be found on <u>www.coj.net</u> on the Planning Dept. webpage)

FDOT – James Richardson reported for Jim Green that traffic on the Mathews Bridge would begin traveling on the South side of the bridge while the grating is replaced on the Northern side. The basic travel patterns and times will remain in place. The project is also on schedule

Small focus groups may be convened in the coming weeks to secure more community feedback.

Re: Support for the St. John River Ferry in Mayport Village.

The District 2 Citizens Planning Advisory Committee (CPAC) is in support of for the St. Johns River ferry and asks that the City continue its operation for the following reasons:

- The stopping of the ferry would interrupt the traffic flow of State Route A1A.
- · Stopping ferry operations would place Mayport Village on a dead end street.
- During heavy storms and high tide A1A leading into the Village is underwater and cut off. The ferry is the only way out of the village during an emergency.
- · Businesses that rely on ferry traffic would suffer financial harm.
- The redevelopment effort of Mayport Village depends on the forry traffic. Without
 it, redevelopment may not happen and tax valorem to the City will be
 decreased.
- Ownership of the ferry slips will fall back to the family that originally donated the land for the ferry. The City will not be able to sell the valuable waterfront property and profit from the proceeds.
- Efforts are being made to increase ecotourism in the eastern portion of Jacksonville. The ferry operation is an intricate part of the efforts.
- Taking the ferry saves fuel and saves wear and tear and reduces traffic on alternate travel routes.
- Once the ferry operation stops. The City will never be able to restart the service without incurring prohibitive costs.
