1. Call to Order/Verify Quorum

Chair Hill called the meeting to order at 6:30 p.m.

2. Approval of the Previous Meeting Summary

Chair Hill inquired if everyone had the opportunity to read the meeting summary and if there
were any corrections, deletions or additions; there were none. George Banks made a motion
to approve the meeting summary and Ernst Cornehl seconded the motion. The January 2015
meeting minutes were approved unanimously.

3. Staff Reports

- JSO (Jacksonville Sheriff's Office) no report
 - Mayor's Liaison Betzy Santiago provided the CPAC with the following updates: CDC Update: Both the No More Homeless Pets and Church's Fried Chicken grants have been approved. They will now go before city council for final approval.
 - Charter Schools: It has been determined that DCPS nor the Mayor's Office do not have any jurisdiction over charter schools. The Florida Department of Education (FDOE) is the organization responsible for charter. If the CPAC would like to receive additional information or look for an entry point to voice their disapproval, a good place to start maybe the Office of Independent Education and Parental Choice (IEPC). IEPC may be able to answer any questions regarding Florida School Choice Programs.

- FDOT (Florida Department of Transportation) Jim Green informed the CPAC that FDOT is hosting a public meeting Thursday to reveal the latest proposed improvements to the Interstate 10 and 95 interchange area. This meeting incorporates public comments and requests gathered during meetings held since last year when the initial concepts were introduced.
- Planning and Development Department:
 - **Housing and Community Development Division** Rosemary Wesolowski Thanked all the members for continually working for and supporting their neighborhoods and the Southeast CPAC.
 - **Planning** Aaron Glick -no report, but available for questions.
- Environmental Quality Division (Code Compliance) Robert Crawford informed the CPAC that since October 1, 2014, his division has collected over 6000 illegal signs; 1200 of those signs were from the Southeast District. Mr. Crawford informed the CPAC that all of the political candidates attended a class to inform them on the appropriate places/locations to post a sign. After the election, candidates are given 7 days to collected the sign and dispose of them.
- Parks & Recreation Keith Meyerl informed the CPAC that the Southside Tennis Courts renovations have been completed. JaxParks is recruiting for Summer Camp Counselors. Applicants must be at least 18 years old or older or be a certified life guard. Visit JAXPARks.com for complete details.
- Public Works Bill Joyce not present
- 4. Presentations Ron Tittle, Public Information Office, Florida Department of Transportation (FDOT), reviewed a number of large FDOT projects in the Southeast District. There were a number of photos of the various projects throughout the district. Mr. Tittle touched on the challenging need to project what the roadway needs will be in the future. It was stated

that FDOT and NFTPO are planning for 6 million more Floridians by 2030, with nearly 100 million annual visitors; this makes Florida's transportation infrastructure quite a challenge. Specifically, how will Florida's transportation systems manage this growth and what impact will changes in transportation have on families, businesses and communities. Mr. Tittle stated that nearly every corridor of our district is under construction.

As a CPAC we had a significant discussion about the clear cutting of trees along I-295 in the area of phase 1 (Buckman Bridge to I-95) of the Express lanes. Quite a few CPAC members expressed their displeasure on the tree removal and expressed their concern about the construction of the sound walls that will be constructed soon.

Mr. Tittle Shared the following updates on FDOT projects:

University and Beach Blvd. Intersection Improvements

- Construction is to improve safety at the intersection
- Medians will be added and there will be some limits added to the types of left turns that can be made
- Cost approx. \$4.6 million
- Begin December 2016

I-295 Express Lanes – Phase 1 ~ I-95 to Buckman Bridge (San Jose area)

- Add two lanes for express; using SunPass
- Began Fall 2014; going full work in January
- End Fall 2016
- Cost approx. \$89 million
- Public meeting Oct. 23, 4:30-6:30p.m.; Mandarin Baptist Church, San Jose Blvd.

7. Subcommittee/Liaison Reports -

LUZ (Land Use and Zoning) - Jim Hill, Subcommittee Chair

A number of applications were reviewed and there was one application for a bikini bar at 3535 St. Johns Bluff Road, 32246 that raised some concern. The Planning and Development Department plans to deny the application, but the subcommittee plans to follow this application. No action was taken at this meeting.

Beautification/Parks/Environment – Dick Cardell, Subcommittee Chair Not present

Economic Development - Gloria Stephens, Subcommittee Chair JAXPORT approved an expanded, long-term lease with Crowley Liner Services. Under the agreement, Crowley will relocate its Puerto Rican service from its private terminal along Jacksonville's harbor to JAXPORT's Talleyrand marine terminal and expand its current leasehold in preparation for deployment of the company's two new LNG-powered Commitment-Class ships, the company said in a statement.

The new facilities lease agreement becomes effective on Jan. 1, 2017, for a term of 20 years plus two 10-year mutual renewal options, and calls for Crowley's current 12-acre Talleyrand leasehold to be expanded to 50 acres.

The Jacksonville Port Authority has pledged almost \$18 million in incentives for Volkswagen Group of America to import its vehicles through Jacksonville, according to the agreement

between the port and the company. To help with the project, the state has agreed to provide \$16 million for capital infrastructure improvements — including at least \$4 million in the 2015/16 fiscal year — "to directly support this new business and to build additional capacity to support Jaxport's growing business." Volkswagen expects to import about 568,000 VWs, Audis, Bentley, Bugattis, Lamborghinis and possibly Porsches during the five-year contract.

The Jacksonville Aviation Authority announced that Jacksonville International Airport (JAX) ranked Third in the Best Airport by Region: North America category of the Airports Council International's (ACI's) 2014 Airport Service Quality (ASQ) Awards. 2014's 3rd place ranking is the best placement since the JAA began participating in the survey program in 2008.

As the industry's most comprehensive passenger service benchmarking tool, the ACI ASQ Survey has reliably captured passengers' immediate appraisal from check-in through departure at the gate at more than 300 airports worldwide. These awards represent passengers' views on 34 key service indicators and are an objective and accurate indicator of the top worldwide performing airports with regard to passenger service.

Education - George Banks / John Waddell

Co-Chair Banks read a report from School Board member Ashley Smith Juarez. A new GRASP program is underway for children with learning disabilities. In addition, she says a new preearly college program will be implemented in several of the magnet schools. In addition, Eugene Butler and Stillwell Middle Schools will become dedicated magnet schools. Ashley says the School Board evaluation of the superintendent continues. Ashley will be out of town next month, but plans on attending the April SE CPAC meeting.

Transportation – Growth Management – Eric Lanier / George Bollinger No report

Safety – Betty Wolfe, Subcommittee Chair

The next ShAdCo Meeting will be a joint ShAdCo meeting and the meeting will be held on March 19, 2015 University Christian Church. ShAdCo is looking to recruit new members. Ms. Wolfe stated that at the last ShAdCo meeting, JSO distributed a flyer that illustrated officer fatalities in the United States. In 2015, Florida ranked 4th on the country for officer fatalities. The rankings were: California – 14 fatalities, Texas – 11 fatalities, New York – 9 fatalities, Florida – 6 fatalities and Georgia – 5 fatalities.

Ad-Hoc:

TRUE (Taxation, Revenue, and Utilization of Expenditures) Commission – Danny Becton Announced to the CPAC, that he will be resigning as the SE CPAC TRUE Commission representative due to his new role as City Council member. A motion was made by George Banks that nominated Ralph Hodges as the new SE CPAC TRUE Commission Chair; the motion was seconded by Ernst Cornehl. The CPAC voted unanimously to nominate Ralph Hodges as the new TRUE Commission representative.

Becton also informed the group that the TRUE Commission has been following a number of issues for the past year. The Commission has been particularly interested in the Northwest

Economic Development Trust Fund. This is a \$25 million fund that got into bad shape and was shut down. At the last meeting it became apparent that 2 grants have popped up related to this trust fund. One of the grants is 2015-14 for No More Homeless Pets for the amount of \$583,587; \$400 thousand was a loan and \$183 thousand was a grant. The TRUE Commission recommended denial. The other was for a Church's Chicken and the TRUE Commission did approve this grant. The TRUE Commission would like to have the person that is now responsible for this fund to come and speak to them and provide an update on the fund.
